# **Important Notice**

## Signature and Chop on Vehicle Registration Document (VRD)

The VRD **has to** contain signature of the registered vehicle owner, and the signature on the application form should match with that on the VRD when a relevant licensing application is submitted by the registered vehicle owner concerned. If the vehicle is owned by a company/organization, the VRD **has to contain** the signature of an authorized representative together with a company/organization chop and the chop on the application form **must be identical** with that on the VRD, otherwise this department will **not** process the licensing application.

## **Requirement of Address Proof**

The original or a copy of the proof of address issued within the last three months **has to** be produced when submitting a licensing application. In accordance with the relevant legislation, the Transport Department may suspend processing the application in the absence of address proof. [Please refer to the list of acceptable proof of address]

## **Change of Address**

According to the law, driving licence holders or registered vehicle owners have to notify the Transport Department within 72 hours of their change of address. Any person without reasonable excuse contravenes such requirement commits an offence and is liable to a fine of \$2,000. You may notify the Transport Department of change in address with your proof of new address in writing, through <a href="GovHK">GovHK</a> or by submitting <a href="the specified form">the specified form</a> ("Change of Personal Particulars or Vehicle Particulars").

## **Submission of Identity Document**

For application submitted by post/ via drop-in box, please **do not** submit the **original** identity document.

Applicant may choose to provide his completed application form and relevant documents to Licensing Office (LO) via email (hklo\_reg@td.gov.hk) for preliminary vetting. Under normal circumstances, TD will provide a reply through email within 10 working days informing the applicant of the result of preliminary vetting; and advise the applicant to formally submit the original application form together with supporting documents and prescribed fee to an LO through the submission means mentioned in the application form. TD will only conduct preliminary vetting on applications submitted by email, and such applications will only be formally processed and approved after receiving the original application and supporting documents from applicant.

If you are a registered elector and your residential address has changed, please notify the Registration and Electoral Office (REO) as early as possible. For enquiries, please call the REO hotline 2891 1001.

## 2. FITTING AN ACCESSORY WITHIN 6 MONTHS AFTER THE FIRST REGISTRATION

If an accessory is fitted to a motor vehicle within 6 months after the first registration of the motor vehicle and the accessory has not been declared when applying for first registration, the registered owner and the registered distributor (in the case where the accessory is fitted by a registered distributor or an associated person) or the registered owner (in the case where the accessory is fitted by a person other than a registered distributor or an associated person), shall, within 5 working days after the fitting of the accessory, make and deliver to Transport Department a declaration setting out details, including the value of the accessory together with the invoices and/or agreements, and Published Retail Price List (if applicable) in support of the declared value.

3. OBTAINING A TAXABLE WARRANTY WITHIN 6 MONTHS AFTER THE FIRST REGISTRATION

If the registered owner of a motor vehicle obtains a taxable warranty for the vehicle within 6 months after the first registration of the vehicle and the warranty has not been declared when applying for first registration, the registered owner and the registered distributor (in the case where the warranty is provided by a registered distributor or an associated person) or the registered owner (in the case where the taxable warranty is provided by a person other than a registered distributor or an associated person), shall, within 5 working days after the date on which the contract for the taxable warranty is entered into, make and deliver to Transport Department a declaration setting out details, including the value of the taxable warranty together with the invoices and/or agreements, and Published Retail Price List (if applicable) in support of the declared value.

- 4. If you need to apply to deduct the value of the replaced accessory, please submit TD469A together with this declaration.
- 5. If a change occurs in the name, address or identity document of a driving licence holder/registered owner previously provided by the driving licence holder/registered owner to the Commissioner for Transport, the driving licence holder/registered vehicle owner shall, within 72 hours of the change, notify the Commissioner for Transport in writing with the proof of change. Any person who without reasonable excuse contravenes such requirement commits an offence and is liable to a fine of \$2,000. For cases of change of name or change of identity document, the driving licence holder/registered vehicle owner shall also deliver to the Commissioner for Transport the existing original driving licence (if applicable), original vehicle registration document (if applicable), vehicle licence (if applicable) and Certificate of Allocation of Personalized Registration Mark (if applicable) for amendment.

- 6. The Commissioner for Transport may, in processing licensing application, require the applicant **to produce proof of his/her present address** [residential/company address (if using company as registered vehicle owner) and correspondence address, e.g. water/electricity/gas/mobile phone bill or bank correspondence], and may suspend the processing of the application until the production of such proof. Therefore, applicants please bring along your proof of present address which is issued not more than 3 months from now for presentation as and when requested by officers of licensing office.
- 7. For any change of address notified in this declaration form, all vehicle/driving licence records of the applicant under the same identity document/Certificate of Incorporation held by this Department will also be changed.
- 8. Copy of your submitted supporting document(s) will be destroyed after processing your application.
