

# Incentive Scheme for Replacing Euro II Diesel Commercial Vehicles by New Commercial Vehicles

## Notes for Application

#### **The Incentive Scheme**

To improve Hong Kong's air quality, the Government is offering a one-off grant to owners of Euro II diesel commercial vehicles to encourage them to replace their vehicles with new ones complying with the prevailing statutory emission standard for newly registered vehicles <sup>(See Note 1)</sup> from 1<sup>st</sup> July 2010 to 30<sup>th</sup> June 2013.

Under this incentive scheme, "commercial vehicles" include light, medium and heavy goods vehicles; private and public light buses; as well as private and public non-franchised buses.

[Note <sup>1</sup>: Currently, Euro IV emission standard is the statutory standard for newly registered commercial vehicles. If it is tightened to a more stringent standard during the implementation period of the scheme, the new replacement commercial vehicles shall comply with the new standard.]

- When you submit the application form, please also produce the following documents:
  - 1) Photocopy of the applicant's H.K. Identity Card or passport for non-identity card holders in the case of a private owner; the Certificate of Incorporation in the case of a Limited Company, Business Registration Certificate will not be accepted; and
  - 2) Duly completed GF179A "Authority for payment to a bank" should be submitted if you select to have the payment of the grant credited to your bank account.
  - Channels of Submission: <u>From 1 July 2010</u>, applicant can submit the completed application form TD605, together with the documents mentioned above, by any one of the following means:
    - 1) By post to Hong Kong Licensing Office, Transport Department (Address: 3/F, United Centre, 95 Queensway, Hong Kong); or

- 2) By drop-in boxes at the four licensing offices; or
- In person or by agent to submit the application form at Hong Kong Licensing Office, Transport Department during office hours (Monday to Friday: 9am to 5pm) (Address: 3/F United Centre, 95 Queensway, Hong Kong).
- Applicant shall provide his/her personal data and vehicle particulars about the scrapped vehicle and the new vehicle, including the registration mark and the chassis number for the scrapped and the new vehicle, the scrapped date of the old vehicle and the first registration date of the new vehicle.

## **Collection of Grant**

Applicant shall select one of the following options for collecting the grant:

- 1) Crossed cheque sent by mail to applicant's correspondence address; or
- 2) Credit to applicant's self-named bank account. (Duly completed GF179A "Authority for payment to a bank" shall be attached to the application if choosing this option.)
