

TRANSPORT DEPARTMENT NOTICE

Extension of Temporary Closure of Yuen Wo Road in Sha Tin

Notice is hereby given that the following temporary traffic and transport arrangements will continue to be implemented from 6.00 pm on 15 April 2016 to 6.00 pm on 20 May 2016 to facilitate the sewerage repair works:

(a) **Road and Lane Closure**

During the above period, the following road and lane sections will continuously be closed to all vehicular traffic:

- (i) the section of Yuen Wo Road northbound between Fo Tan Road and Sha Tin Road;
- (ii) a traffic lane of Fo Tan Road eastbound near its junction with Yuen Wo Road;
- (iii) a traffic lane of Fo Tan Road westbound near its junction with Yuen Wo Road; and
- (iv) a traffic lane of Yuen Wo Road northbound near its junction with Fo Tan Road.

(b) **Banning of Turning Movement**

- (i) During the above period, all vehicles will continuously be prohibited from turning left from Fo Tan Road eastbound to Yuen Wo Road northbound; and
- (ii) During the above period, all vehicles will continuously be prohibited from turning right from Fo Tan Road westbound to Yuen Wo Road northbound.

(c) **Traffic Diversion**

- (i) Vehicles on Yuen Wo Road northbound or Fo Tan Road westbound heading for Tai Po Road (Sha Tin section) northbound will continuously be diverted via Fo Tan Road westbound, Tai Po Road (Sha Tin section) southbound, the slip road leading from Tai Po Road (Sha Tin section) southbound to Sha Tin Rural Committee Road, Sha Tin Rural Committee Road westbound, the slip road leading from Sha Tin Rural Committee Road to Tai Po Road (Sha Tin section) northbound, and Tai Po Road (Sha Tin section) northbound; and
- (ii) Vehicles on Fo Tan Road eastbound heading for Tai Po Road (Sha Tin section) northbound will continuously be diverted via Tai Chung Kiu Road southbound, Sha Tin Rural Committee Road westbound, the slip road leading from Sha Tin Rural Committee Road to Tai Po Road (Sha Tin section) northbound, and Tai Po Road (Sha Tin section) northbound.

(d) **Temporary Public Transport Arrangement**

- (i) During the above period, KMB route nos. 72, 72A, N73, 74A and N271 on its journey to Tai Po / Lok Ma Chau will continuously be diverted via Fo Tan Road westbound, Tai Po Road (Sha Tin section) southbound, the slip road leading from Tai Po Road (Sha Tin section) southbound to Sha Tin Rural Committee Road, Sha Tin Rural Committee Road westbound, the slip road leading from Sha Tin Rural Committee Road to Tai Po Road (Sha Tin section) northbound, and Tai Po Road (Sha Tin section) northbound before resuming its original routing;
- (ii) During the above period, KMB route no. 73A on its journey to Wah Ming will continuously be diverted via Fo Tan Road eastbound, Tai Po Road (Sha Tin section) southbound, the slip road leading from Tai Po Road (Sha Tin section) southbound to Sha Tin Rural Committee Road, Sha Tin Rural Committee Road westbound, the slip road leading from Sha Tin Rural Committee Road to Tai Po Road (Sha Tin section)

northbound, and Tai Po Road (Sha Tin section) northbound before resuming its original routing; and

- (iii) During the above period, GMB route no. 501S on its journey to Sheung Shui will continuously be diverted via Fo Tan Road westbound, Lok King Street northbound, Lok Shun path northbound, Tsun King Road northbound, roundabout, Tai Po Road (Ma Liu Shui section) northbound, roundabout, Tai Po Road (Ma Liu Shui section) southbound, slip road and Tai Po Road (Sha Tin section) northbound before resuming its original routing.

Appropriate traffic signs have been erected on site to guide motorists. Public transport operators have displayed notices to advise passengers of the above temporary transport arrangements.
