Traffic Advice

<u>Temporary Traffic and Transport Arrangements at</u> the junction of Tai Chung Kiu Road and Sha Tin Wai Road

Motorists are advised that in order to facilitate the road marking work, the following temporary traffic and transport arrangements will be implemented from 2.00 am to 4.00 am on 14 June 2018:

(a) Lane Closure

- (i.) Some traffic lanes of Tai Chung Kiu Road eastbound near its junction of Sha Tin Wai Road will be closed;
- (ii.) Some traffic lanes of Sha Tin Rural Committee Road southbound near its junction of Tai Chung Kiu Road will be closed;
- (iii.) Some traffic lanes of Tai Chung Kiu Road westbound near its junction of Sha Tin Wai Road will be closed; and
- (iv.) Some traffic lanes of Sha Tin Wai Road northbound near its junction of Tai Chung Kiu Road will be closed.

(b) Banning of Turning Movements for all Vehicles

- (i.) All vehicles will be prohibited from going straight ahead or turning right from Tai Chung Kiu Road eastbound to Sha Tin Wai Road southbound;
- (ii.) All vehicles will be prohibited from going straight ahead or turning right from Sha Tin Rural Committee Road southbound to Tai Chung Kiu Road westbound;
- (iii.) All vehicles will be prohibited from going straight ahead or turning right from Tai Chung Kiu Road westbound to Sha Tin Rural Committee Road northbound; and
- (iv.) All vehicles will be prohibited from going straight ahead or turning right from Sha Tin Wai Road northbound to Tai Chung Kiu Road eastbound.

(c) <u>Traffic Diversions</u>

- (i.) Vehicles on Tai Chung Kiu Road eastbound heading for Tai Chung Kiu Road eastbound will be diverted via Sha Tin Rural Committee Road northbound, Pai Tau Street, Sha Tin Rural Committee Road southbound and Tai Chung Kiu Road;
- (ii.) Vehicles on Tai Chung Kiu Road eastbound heading for Sha Tin Wai Road southbound will be diverted via Sha Tin Rural Committee Road northbound, Pai Tau Street, Sha Tin Rural Committee Road southbound, Tai Chung Kiu Road eastbound, Yuen Chau Kok Road southbound, Kong Pui Street, Sha Kok Street and Sha Tin Wai Road;

- (iii.) Vehicles on Sha Tin Rural Committee Road southbound heading for Sha Tin Wai Road southbound will be diverted via Tai Chung Kiu Road eastbound, Yuen Chau Kok Road southbound, Kong Pui Street, Sha Kok Street and Sha Tin Wai Road;
- (iv.) Vehicles on Sha Tin Rural Committee Road southbound heading for Tai Chung Kiu Road westbound will be diverted via Tai Chung Kiu Road eastbound, Yuen Chau Kok Road southbound, Kong Pui Street, Sha Kok Street, Sha Tin Wai Road northbound and Tai Chung Kiu Road;
- (v.) Vehicles on Tai Chung Kiu Road westbound heading for Tai Chung Kiu Road westbound will be diverted via Sha Tin Wai Road southbound, Yi Shing Square, Kong Pui Street, Sha Kok Street, Sha Tin Wai Road northbound and Tai Chung Kiu Road;
- (vi.) Vehicles on Tai Chung Kiu Road westbound heading for Sha Tin Rural Committee Road northbound will be diverted via Sha Tin Wai Road southbound, Yi Shing Square, Kong Pui Street, Sha Kok Street, Sha Tin Wai Road northbound, Tai Chung Kiu Road westbound, Sha Tin Tau Road southbound, Sha Tin Tau Road northbound, Che kung Miu Road eastbound, Tai Chung Kiu Road eastbound and Sha Tin Rural Committee Road;
- (vii.) Vehicles on Sha Tin Wai Road northbound to Sha Tin Rural Committee Road northbound will be diverted via Tai Chung Kiu Road westbound, Sha Tin Tau Road southbound, Sha Tin Tau Road northbound, Che kung Miu Road eastbound, Tai Chung Kiu Road eastbound and Sha Tin Rural Committee Road; and
- (viii.) Vehicles on Sha Tin Wai Road northbound to Tai Chung Kiu Road eastbound will be diverted via Tai Chung Kiu Road westbound, Sha Tin Tau Road southbound, Sha Tin Tau Road northbound, Che kung Miu Road eastbound, Tai Chung Kiu Road eastbound, Sha Tin Rural Committee Road northbound, Pai Tau Street, Sha Tin Rural Committee Road southbound and Tai Chung Kiu Road.

(d) <u>Temporary Transport Arrangements</u>

- (i.) During the above period, KMB Route no. N281 (Kam Ying Court bound), LWB Route no. NA41 (Shui Chuen O bound) and Cross Harbour Route N182 (Kwong Yuen bound) will be diverted via Sha Kok Street eastbound, Kong Pui Street, Yuen Chau Kok Road and Tai Chung Kiu Road eastbound before resuming its normal routeing;
- (ii.) During the above period, Cross Harbour Route N170 (Sha Tin bound), NT GMB Route no. 61S (Fo Tan/Wo Che Bound) will be diverted via Tai Chung Kiu Road westbound, Lion Rock Tunnel Road northbound and Sha Tin Centre Street before resuming its normal routeing;
- (iii.) During the above period, Cross Harbour Route N170 (Wah Fu bound), NT GMB Route No. 501S (Kwun Tong bound) and GMB Route no. 61S (Mong Kok Bound) will be diverted via Tai Chung Kiu Road eastbound, Yuen Chau Kok Road southbound, Kong Pui Street and Sha Kok Street before resuming its normal routeing;

- (iv.) During the above period, NT GMB Route no. 65S (Sha Tin Bound) will be diverted via Lion Rock Tunnel Road northbound, Sha Tin Centre Street, Wang Pok Street, Yuen Wo Road eastbound, Sha Tin Rural Committee Road southbound and Tai Chung Kiu Road eastbound before resuming its normal routeing;
- (v.) During the above period, NT GMB Route no. 65S (Mong Kok Bound) will be diverted via Tai Chung Kiu Road westbound, Sha Tin Wai Road southbound and Sha Kok Street before resuming its normal routeing.

Appropriate traffic signs will be erected on site to guide motorists. Public transport operators will display notices to advise passengers of the above temporary transport arrangement.
