Traffic Advice

Extension of Temporary Traffic and Transport Arrangements in Southern District

Members of the public are advised that to facilitate the works for public housing developments, the following temporary traffic and transport arrangements will continue to be implemented from 1.00 am on 28 April 2024 to 1.00 am on 19 May 2024:

I. <u>Traffic Directions</u>

- (a) Wah Hong Street will continue to be converted from two-way traffic to one-way eastbound traffic;
- (b) Wah Chui Street will continue to be converted from two-way traffic to one-way westbound traffic;
- (c) The section of Wah King Street between Wah Chui Street and Wah Lam Path will continue to be converted from two-way traffic to one-way southbound traffic; and
- (d) The section of Wah Lam Path between Wah King Street and Wah Fu Road will continue to be converted from two-way traffic to one-way southbound traffic.

II. Banning of Turning Movements

- (a) All vehicles will continue to be prohibited from making right turn movement from Victoria Road southbound onto Wah Hong Street westbound;
- (b) All vehicles will continue to be prohibited from making left turn movement from Victoria Road northbound onto Wah Hong Street westbound;
- (c) All vehicles will continue to be prohibited from making left turn movement from Wah King Street southbound onto Wah Chui Street eastbound;
- (d) All vehicles will continue to be prohibited from making right turn movement from Wah King Street northbound onto Wah Chui Street eastbound;
- (e) All vehicles will continue to be prohibited from making left turn movement from Wah Lam Path eastbound onto Wah King Street northbound;
- (f) All vehicles will continue to be prohibited from making left turn movement from Wah Fu Road eastbound onto Wah Lam Path northbound; and
- (g) All vehicles will continue to be prohibited from making right turn movement from Wah Fu Road westbound onto Wah Lam Path northbound.

III. Traffic Diversions

- (a) Affected vehicles on Wah Chui Street eastbound heading for Victoria Road will continue to be diverted via Wah Hong Street eastbound;
- (b) Affected vehicles on Wah Hong Street westbound heading for Wah King Street will continue to be diverted via Wah Chui Street westbound;
- (c) Affected vehicles on Wah Fu Road eastbound heading for Wah Lam Path will continue to be diverted via Shek Pai Wan Road, Victoria Road, Wah Chui Street and Wah King Street;
- (d) Affected vehicles on Wah Fu Road westbound heading for Wah Lam Path will continue to be diverted via Wah Fu Road and Wah King Street; and
- (e) Affected vehicles on Wah King Street northbound heading to Wah Fu Road will continue to be diverted via Wah Hong Street eastbound, Victoria Road northbound and Wah Chui Street westbound.

IV. Temporary Arrangement of GMB Stand

The GMB stand on Wah Lok Path will continue to be relocated to Wah King Street southbound outside World Fair Court.
