### **New Service Arrangement of Bus Routes Serving the Ocean Park**

Members of the public are advised that with effect from 17 May 2015 (Sunday), the details of the new service arrangement of the following bus routes (Citybus Route no.41A, Cross Harbour Route nos. 107, 170, 171 and 973) will be implemented with details in the following table:

CTB Route No.41A (Wah Fu (Central) – North Point Ferry)	<u>To North Point Ferry</u> All departures will omit the Ocean park on Saturdays, Sundays and Public Holidays
	<u>To Wah Fu (Central)</u> All departures will omit the Ocean park on Saturdays, Sundays and Public Holidays
Cross Harbour Route No.107 (Wah Kwai – Kowloon Bay)	<u>To Kowloon Bay</u> Sundays and Public Holidays (from terminus) : 4.00 p.m. to 6.30 p.m.
	<u>To Wah Kwai</u> Sundays and Public Holidays (from terminus) : 9.00 a.m. to 11.30 a.m.
Cross Harbour Route No.170 (Wah Fu (Central) –Sha Tin Station) Cross Harbour	<u>To Sha Tin Station</u> Sundays and Public Holidays (from terminus) : 4.00 p.m. to 6.30 p.m.
	<u>To Wah Fu (Central)</u> Sundays and Public Holidays (from terminus) : 9.00 a.m. to 11.30 a.m.
Cross Harbour Route No.171 (South Horizons – Lai Chi Kok)	<u>To Lai Chi Kok</u> Sundays and Public Holidays (from terminus) : 4.00 p.m. to 6.30p.m.
	<u>To South Horizons</u> Sundays and Public Holidays (from terminus) : 9.00 a.m. to 11.30 a.m.
Cross Harbour Route No.973 (Stanley – Tsim Sha Tsui East (Mody Road))	<u>To Tsim Sha Tsui East</u> Saturdays (from terminus) : 3.25 p.m. to 7.20 p.m. Sundays and Public Holidays (from terminus) : 3.30 p.m. to 7.15 p.m.
	<u>To Stanley</u> Saturdays (from terminus) : 8.30 a.m. to 12.55 p.m. Sundays and Public Holidays (from terminus) : 8.00 a.m. to 12.45 p.m.

Other service details of the above bus routes remain unchanged. Notices will be displayed at the bus stops and inside compartments by Bus Company to advise passengers of the above new service arrangement.
