Temporary Traffic and Transport Arrangements in Sha Tin Heights Road

Notice is hereby given that the following temporary traffic and transport arrangements will be implemented from 10.00 am to 4.00 pm daily from 7 June 2018 to 31 August 2018* to facilitate the road resurfacing works:

Road Closure and Temporary Public Transport Arrangements

The road works will be conducted in seven phases. Specified section of Sha Tin Heights Road will be temporarily closed to all vehicular traffic during the road works. Meanwhile, the bus terminus of New Territories Residents' Service Route No. NR818 (Golden Time Villas, Sha Tin – Tai Wai Station) at Golden Time Villas will be temporarily suspended from 20 June 2018 to the conclusion of the temporary road works, and will be temporarily relocated as follows:

1	From 7 June 2018* to the conclusion of the temporary road work	The section of Sha Tin Heights Road between Ascot Villa and Golden Time Villas will be temporarily closed.
2	From 20 June 2018* to the conclusion of the temporary road work	The section of Sha Tin Heights Road between Golden Time Villas and Chase Villa will be temporarily closed. The routeing of NR818 will be shortened to Sha Tin Heights Road near Chase Villa.
3	From 26 June 2018* to the conclusion of the temporary road work	The section of Sha Tin Heights Road between Chase Villa and Happy View House will be temporarily closed. The routeing of NR818 will be shortened to Sha Tin Heights Road near Happy View House.
4	From 5 July 2018* to the conclusion of the temporary road work	The section of Sha Tin Heights Road between Happy View House and Royal Forest will be temporarily closed. The routeing of NR818 will be shortened to Sha Tin Heights Road near Royal Forest.
5	From 13 July 2018* to the conclusion of the temporary road work	The section of Sha Tin Heights Road between Royal Forest and Mount Pleasure will be temporarily closed. The routeing of NR818 will be shortened to Sha Tin Heights Road near Mount Pleasure.
6	From 16 July 2018* to the conclusion of the temporary road work	The section of Sha Tin Heights Road between Mount Pleasure and Greenheight Villa will be temporarily closed. The routeing of NR818 will be shortened to Sha Tin Heights Road near Greenheight Villa.

7	From 20 July 2018* to the conclusion of the temporary road work	<p>The section of Sha Tin Heights Road between Greenheight Villa and 100 meters south of Godi will be temporarily closed.</p> <p>The routing of NR818 will be shortened to Sha Tin Heights Road 100 meters south of Godi.</p>
