

客運營業證證明書申請書——公共小巴服務

填表須知

(A) 簽發條件

- (一) 客運營業證證明書乃簽發予以客運營業證經營的車輛。
- (二) 客運營業證證明書有效期一年，或直至客運營業證的最後有效日期為止，以較早者為準。客運營業證證明書不得轉用於其他車輛。
- (三) 每輛以客運營業證經營的車輛，必須：
 - (a) 擋風玻璃的左面展示一張由運輸署署長指定格式的證明書；以及
 - (b) 根據道路交通(公共服務車輛)規例第2附表中圖2所指定的形式，於車輛後面展示載有客運營業證編號的字牌。
- (四) 任何人士在下列情況下不得駕駛或使用已領有客運營業證的車輛，或容許或任令他人駕駛或使用該車輛：
 - (a) 該車輛並無展示上文第(三)段所指的證明書或字牌；
 - (b) 該車輛展示該證明書或字牌的方法與上文第(三)段所指定者不符。
 - (c) 該車輛展示的任何聲稱為以上文第(三)段所指的證明書或字牌：
 - (i) 已損毀、塗改或破損；
 - (ii) 與該車輛現有的客運營業證無關；或
 - (iii) 與該車輛無關。
 - (d) 該車輛展示的證明書(上文第(三)段所指者)已告失效。
- (五) 每張客運營業證證明書收費為160元。
- (六) 如有關車輛用作行走專線服務，事先須獲得運輸署運輸管理部的批准。

(B) 填寫表格

- (一) 如以有限公司名義申請，聲明書部份應由已獲公司授權的人士簽署。
- (二) 申請人如非有關車輛的登記車主，則申請人及登記車主均須在另一表格內聯合聲明彼此同意將該車輛從登記車主的客運營業證中刪除，並同時將該車輛列入申請人的客運營業證內。

(C) 遞交申請書

申請書填妥後，應親自或由代理人交回運輸署公共車輛分組(香港金鐘道95號統一中心3樓)，或以掛號郵遞寄回。

(D) 更改資料

申請人如要更改填報的資料，應即通知運輸署署長。

(E) 證明文件

遞交申請書時，應一併附上下列文件：

- (a) 香港身分證/公司註冊證(加簽的真確副本)；
(經郵遞申請所遞交的身分證影印副本，本署會於處理申請後銷毀)
- (b) 有效商業登記證(加簽的真確副本)；
- (c) 客運營業證(正本)；
- (d) 適當文件，以證明該車輛由指定的車房/汽車公司維修和保養(如適用)；
- (e) 運輸署運輸管理部簽發的批准書副本(如該車輛用作行走專線服務)；以及
- (f) 上文未有提及的其他有關證明文件或資料。

**APPLICATION FOR PASSENGER SERVICE LICENCE CERTIFICATE
PUBLIC LIGHT BUS SERVICE
NOTES FOR ATTENTION**

A. CONDITIONS OF ISSUE

- (1) A passenger service licence certificate will be issued in respect of a vehicle operating under a valid passenger service licence.
- (2) A passenger service licence certificate is valid for one year or until the passenger service licence expires, whichever is the earlier; and shall not be transferable to another vehicle.
- (3) Every vehicle operated under a passenger service licence shall display:—
 - (a) on the left hand half of vehicle's windscreen in a manner as to be visible from the front of the vehicle a certificate in a form specified by the Commissioner for Transport; and
 - (b) at the rear of the vehicle, a plate showing the passenger service licence number in accordance with Figure No. 2 of the Second Schedule to the Road Traffic (Public Service Vehicles) Regulations.
- (4) No person shall drive or use a vehicle operated under a passenger service licence or suffer or permit such a vehicle to be driven or used, if such vehicle—
 - (a) does not display the certificate and the plate referred to in para. (3) above;
 - (b) displays such certificate or plate other than in the manner prescribed by para. (3) above;
 - (c) displays any such certificate or plate purporting to be a certificate or plate referred to in para. (3) that—
 - (i) is damaged, altered or defaced;
 - (ii) does not relate to a passenger service licence currently in force in respect of the vehicle; or
 - (iii) does not relate to the vehicle.
 - (d) displays a certificate referred to in para. (3) that is invalid.
- (5) The fee for each passenger service licence certificate is \$160.
- (6) If the vehicle is intended to run scheduled service, prior approval has to be obtained from the Operations Division of the Transport Department.

B. COMPLETION OF FORMS

- (1) In the case of a limited company, the declaration should be signed by the person authorized by the company.
- (2) If the applicant is not the registered owner of the vehicle, then both of them have to jointly declare on a separate form to the effect that they agree that they agree to delete/exclude the vehicle from the passenger service licence of the registered owner and include it in the passenger service licence of the applicant simultaneously.

C. SUBMISSION OF APPLICATIONS

All completed applications should be submitted either in person, by agent or by registered post to Public Vehicles Unit of Transport Department at 3/F, United Centre, 95 Queensway, Hong Kong.

D. AMENDMENT

The Commissioner for Transport should be notified of any change in particulars immediately.

E. SUPPORTING DOCUMENTS

The following documents should be forwarded at the time of submission of the application form:—

- (a) Hong Kong Identity Card/Certificate of Incorporation (certified true copy);
(the copy of the identity card attached with the application submitted by registered post will be destroyed after processing the application)
- (b) Valid Business Registration Certificate (certified true copy);
- (c) Passenger Service Licence (original);
- (d) Documentary evidence to show that maintenance and service facilities are provided by appointed garage/motor car company where appropriate;
- (e) Approval letter issued by the Operations Division of the Transport Department if the vehicle is to run scheduled service (copy only); and
- (f) Other relevant documents/information in support of the application not mentioned above.

(只適用於與車輛有關的申請)
 - 依照道路交通（駕駛執照）規例第 39 條的規定，保存一份詳列駕駛執照上各細項的紀錄；
(只適用於與駕駛執照有關的申請)

 - tunnel companies, Tsing Ma Control Area operator and Tsing Sha Control Area operator for execution of their statutory duties in traffic and transport matters.
