The date of completion of the course specified in the course certificate shall fall within one year preceding the date of application for the full driving licence to drive the vehicle class.

- A person shall not be eligible for a full driving licence to drive a taxi, a private light bus or public light bus, a private bus or public bus, a medium goods vehicle, a heavy goods vehicle, a special purpose vehicle or an articulated vehicle if he has been convicted of an offence under Section 36 (Causing death by dangerous driving), Section 36A (Causing grievous bodily harm by dangerous driving), Section 39 (Driving a motor vehicle under the influence of drink), Section 39A (Driving, attempting to drive or being in charge of a motor vehicle with alcohol concentration above prescribed limit), Section 39B (Screening breath tests), Section 39C (Provision of specimens for alcohol analysis), Section 39J (Driving motor vehicle without proper control under influence of specified illicit drug), Section 39K (Driving motor vehicle with any concentration of specified illicit drug), Section 39L (Driving motor vehicle without proper control under influence of drug other than specified illicit drug), Section 39O(1) (Failure to undergo preliminary drug test), Section 39S (Failure to provide specimen of blood or urine) of the Road Traffic Ordinance (Cap. 374) during the 5 years immediately preceding his application.
 - People with disabilities or people who need to wear hearing aids when driving may contact Driving Services Section of Transport Department (Tel.: 2713 7262) for the arrangement of an appointment for driving ability assessment or hearing ability assessment if they wish to apply for a driving test. Subject to the result of the assessment, you will be given an approval letter for applying for driving test and appropriate licence from the Commissioner for Transport.
 - A driving test form is valid only for a period of 18 months from the date of issue. Its number, shown on the appointment letter of driving test, should be quoted in all enquiries.
 - To apply for a full driving licence to drive commercial vehicle class(es), you must fulfill the application requirements and you must be the holder of a Hong Kong Permanent Identity Card, or the holder of a Hong Kong Identity Card (other than a Hong Kong Permanent Identity Card) and are not subject to any condition of stay (other than a limit of stay as defined in section 2(1) of the Immigration Ordinance (Cap. 115)).
 - Applicant must be a holder of a valid full driving licence to drive a private car or light goods vehicle for at least 1 year immediately preceding his/her application; or applicant must be a holder of a valid full driving licence issued after the completion of probationary driving period to drive a private car or light goods vehicle on the date of his/her application for a learner's driving licence to drive a commercial vehicle.
 - If a change occurs in the name, address or identity document of a driving licence holder/registered vehicle owner previously provided by the driving licence holder/registered vehicle owner to the Commissioner for Transport, the driving licence holder/registered vehicle owner shall, within 72 hours of the change, notify the Commissioner for Transport in writing with the proof of change. Any person who without reasonable excuse contravenes such requirement commits an offence and is liable to a fine of \$2,000. For cases of change of name or change of identity document, the driving licence holder/registered vehicle owner shall also deliver to the Commissioner for Transport the existing original driving licence (if applicable), original driving instructor's licence (if applicable), original vehicle registration document (if applicable), vehicle licence (if applicable) and Certificate of Allocation of Personalized Registration Mark (if applicable) for amendment.

FIRST SCHEDULE OF ROAD TRAFFIC (DRIVING LICENCES) REGULATIONS—EXCEPTED DISEASES AND PHYSICAL DISABILITIES

- 癲癇症。
 - 高血壓或其他因由,以致有可能突然暈眩或昏倒以致失去能力。
 - 精神紊亂,以致執照申請人或持有人(視屬何情況而定)有可能根據《精神健康條例》(第136章)被羈留或以住院病人身分在該條例所指的精神病院接受治療。
 - 任何導致肌肉不受控制的狀況。
 - 未受控制的糖尿病。
 - 不能在白天充足光線下讀出與他相距23米的登記號碼(有需要者在配戴眼鏡或其他矯正視力鏡片作為協助,仍不能讀出)。

 - Any other disease or disability which is likely to render him incapable of effectively driving and controlling a motor vehicle or suitably adapted motor vehicle to which such licence refers without endangering public safety, provided that deafness shall not of itself be deemed to be any such disability.
