Important Notice

Legal Requirements of the Transfer of Ownership of a Vehicle (Except Taxi)

In accordance with the law, the registered owner ('the existing owner') shall submit the duplicate of the "Notice of Transfer of Ownership of a Vehicle (Except Taxi)" (i.e. page 3 of the form TD25), completed and duly signed by the existing owner and the new owner, to the Vehicle Records Office of this Department within 72 hours after the transfer of the ownership of the vehicle. The new owner shall submit the original of the "Notice of Transfer of Ownership of a Vehicle (Except Taxi)" (i.e. page 1 of the form TD25), completed and duly signed by the existing owner and the new owner, to a Licensing Office of this Department, together with the required documents and fee within 72 hours after the transfer of the ownership of the vehicle, in order to complete the transfer of vehicle ownership procedures. The existing owner should ensure that the new owner submit the original "Notice of Transfer of Ownership of a Vehicle (Except Taxi)" to the Transport Department in order to complete the transfer of vehicle ownership procedures within 72 hours after the vehicle is transferred to the new owner, otherwise, the transfer of ownership is incomplete. Before the transfer of vehicle ownership procedures are completed, as the vehicle is still registered under the name of the existing owner, the existing owner needs to continue to take up all legal liabilities incurred by that vehicle.

Signature and Chop on Vehicle Registration Document (VRD)

The VRD <u>has to</u> contain signature of the registered vehicle owner, and the signature on the application form should match with that on the VRD when a relevant licensing application is submitted by the registered vehicle owner concerned. If the vehicle is owned by a company/organization, the VRD <u>has to contain</u> the signature of an authorized representative together with a company/organization chop and the chop on the application form <u>must be identical</u> with that on the VRD, otherwise this department will <u>not</u> process the licensing application.

Requirement of Address Proof

The original or a copy of the proof of address issued within the last three months <u>has to</u> be produced when submitting a licensing application. In accordance with the relevant legislation, the Transport Department may suspend processing the application in the absence of address proof. [Please refer to the list of acceptable proof of address]

Change of Address

According to the law, driving licence holders or registered vehicle owners have to notify the Transport Department within 72 hours of their change of address. Any person without reasonable excuse contravenes such requirement commits an offence and is liable on conviction to a fine at level 1. You may notify the Transport Department of change in address with your proof of new address (if applicable) through <u>GovHK</u>, by submitting <u>the specified form</u> ("Change of Personal Particulars or Vehicle Particulars") or in writing.

Mail Items with Insufficient Postage

For proper delivery of your mail items to this department, and to avoid unnecessary delivery delay or unsuccessful delivery, please ensure your mail items bear sufficient postage before posting [Please note the latest details about postage rates by Hongkong Post]. This department will not receive any underpaid mail items. Any underpaid mail items will be handled by the Hongkong Post, which actions including but not limited to levying a surcharge on the sender for mail item that bears a sender's address.

Submission of Identity Document

For application submitted by post/ via drop-in box, please do not submit the original identity document.

Applicants may choose to provide their completed application form and relevant documents to Licensing Office (LO) via email (vlapp@td.gov.hk) for preliminary vetting. Under normal circumstances, TD will provide a reply through email within 10 working days informing the applicant of the result of preliminary vetting, and advise the applicant to formally submit the original application form together with supporting documents and prescribed fee to an LO through the submission means mentioned in the application form. TD will only conduct preliminary vetting on applications submitted by email, and such applications will only be formally processed and approved after receiving the original application and supporting documents from applicant.

Purposes of Collection

- The personal data provided by means of this form will be used by Transport Department for the following purposes:
 - (a) activities relating to the processing of your application in this form;
 - maintenance of a register of vehicles for public access under regulation 4(2) of the Road Traffic (Registration and Licensing of Vehicles) Regulations; (applicable to vehicle-related applications only)
 - maintenance of a record of particulars of driving licences under regulation 39 of the Road Traffic (Driving Licences) Regulations; (applicable to driving licence-related applications only)
 - (d) activities relating to traffic and transport matters; and
 - (e) facilitating communication between Transport Department and yourself.
- 2. It is obligatory for you to supply the personal data as required by this form. If you fail to supply the required data, your application may be refused.

- The personal data you provided by means of this form may be disclosed to:
 - (a) other Government departments, bureaux and relevant organizations for the purposes mentioned in paragraph 1 above;
 - (b) any person for the purpose mentioned in paragraph 1(b) above; and
 - tunnel companies, Tsing Ma Control Area operator and Tsing Sha Control Area operator for execution of their statutory duties in traffic and transport matters.
