

# Important Notice

## Signature and Chop on Vehicle Registration Document (VRD)

The VRD **has to** contain signature of the registered vehicle owner, and the signature on the application form should match with that on the VRD when a relevant licensing application is submitted by the registered vehicle owner concerned. If the vehicle is owned by a company/organization, the VRD **has to contain** the signature of an authorized representative together with a company/organization chop and the chop on the application form **must be identical** with that on the VRD, otherwise this department will **not** process the licensing application.

## Requirement of Address Proof

The original or a copy of the proof of address issued within the last three months **has to** be produced when submitting a licensing application. In accordance with the relevant legislation, the Transport Department may suspend processing the application in the absence of address proof. [\[Please refer to the list of acceptable proof of address\]](#)

## Change of Address

According to the law, driving licence holders or registered vehicle owners have to notify the Transport Department within 72 hours of their change of address. Any person without reasonable excuse contravenes such requirement commits an offence and is liable to a fine of \$2,000. You may notify the Transport Department of change in address with your proof of new address in writing, through [GovHK](#) or by submitting [the specified form](#) (“Change of Personal Particulars or Vehicle Particulars”).

## Mail items with insufficient postage

Underpaid mail items are subject to surcharge by Hongkong Post. This department will not accept underpaid mail items, which will be returned to the sender (with return address) or disposed of (without return address) by the Hongkong Post. For proper delivery of your mail items to the department, and to avoid unnecessary delivery delay or unsuccessful delivery, please ensure your mail items bear sufficient postage with return address before posting. 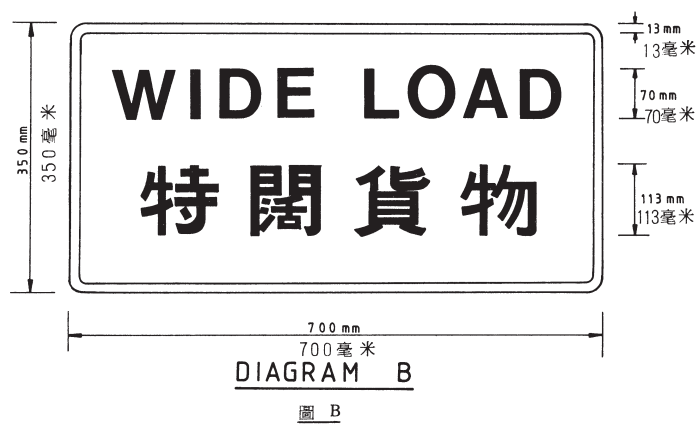
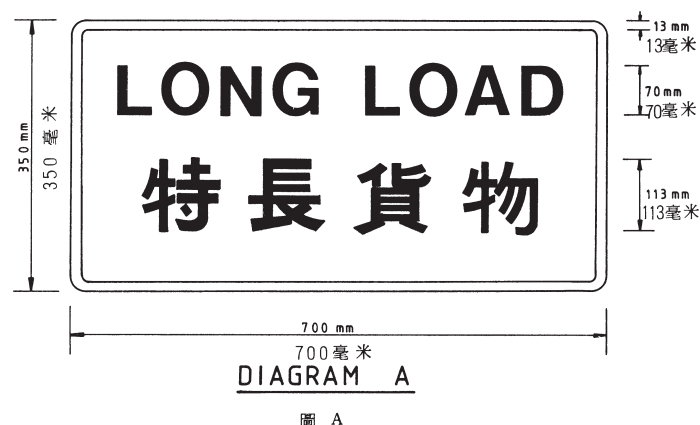

運載「特長貨物」和「特潤貨物」的許可證，是根據香港法例第 374 章道路交通（車輛登記及領牌）規例第 54 條的規定簽發，目的是方便車輛運載較車身長或潤的貨物。香港法例第 374 章道路交通（交通管理）規例第 55 條對運載較車身長或潤的貨物有以下規定：

規例第 55 條：

- (1) 除第 (2) 款另有規定外，任何司機不得在道路上駕駛載有以下負載物的車輛——
  - (a) 如屬非拖車的車輛，該負載物從該車輛的最前部分向前伸出 1.5 米以上；
  - (b) 該負載物從該車輛的最後部分向後伸出 1.4 米以上；
  - (c) 該負載物從兩側伸出，以致其總寬度超過 2.5 米；或
  - (d) 該負載物的高度超過 4.6 米，或雖低於該高度，但卻可能導致在該道路上空合法架設的任何物體或電綫損壞。
- (2) 如一部車輛的負載物不超出根據香港法例第 374 章道路交通（車輛登記及領牌）規例而發出的運載特長貨物許可證或運載特潤貨物許可證所訂明的範圍，則該車輛可運載該負載物。

“Long load” and “Wide load” permits are issued under the provisions of Regulation 54 of the Road Traffic (Registration and Licensing of Vehicles) Regulations, Cap. 374. These permits are issued to facilitate movement of overhang on vehicles which is governed by Regulation 55 of the Road Traffic (Traffic Control) Regulations, Cap. 374 which stipulates that:

- Reg. 55
- (1) “Subject to para. 2, no driver shall drive on a road a vehicle that is so loaded that the load—
    - (a) in the case of a vehicle other than a trailer, extends forwards more than 1.5 metres from the foremost part of the vehicle;
    - (b) extends backwards more than 1.4 metres behind the rearmost part of the vehicle;
    - (c) extends sideways so that the total width of the load is in excess of 2.5 metres; or
    - (d) rises to such a height in excess of 4.6 metres or to such lesser height as may cause damage to any object or wires lawfully erected above the road.
  - (2) A vehicle may be driven loaded within the limits prescribed in a long load permit or a wide load permit issued under the “Road Traffic (Registration and Licensing of Vehicles) Regulations.”

#### 簽發條件 CONDITIONS OF ISSUE

- (一) 申請人須是運載特長或特潤貨物許可證申請表所指車輛的登記車主。如果由代理人申請，則須有登記車主書面授權，申請才可獲接納。（如果申請由代理人遞交，代理人必須出示其本人的身分證明文件正本，以作記錄。）
- (二) 申請許可證的車輛須是中型或者重型貨車，有無掛接拖車均可，而車輛總長度不得少過 9.1 米。
- (三) 運載特長貨物的車輛貨物如伸出車前超過兩米及／或伸出車後超過 3 米，則車輛總長度不得少於 10 米。
- (四) 申請上述許可證的車輛必須具備在許可證有效期內有效的第三者風險保險。
- (1) The applicant shall be the registered owner of the vehicle for which the long load or wide load permit is being sought. An application by an agent will be accepted only where the agent is authorised in writing by the registered owner. (If the application is submitted by an agent, the agent is required to produce his/her own original identity document for record purpose.)
- (2) The vehicle under application shall be a medium goods vehicle or a heavy goods vehicle, whether or not articulated with a trailer, the total length of which shall not be less than 9.1 metres.
- (3) Loads should normally be positioned on the vehicle so that they do not overhang more than 2 m to the front, and/or more than 3 m to the rear, of the vehicle. However where this cannot be avoided, the vehicle on which the load is being carried shall not be less than 10 m in length.
- (4) The vehicle under application shall be covered by valid third party insurance for the entire period of the permit being sought.

#### 許可證條件 CONDITIONS OF PERMIT

- (一) 運載特長或特潤貨物許可證在運輸署署長指定的期間內有效。
- (二) 許可證須在車輛前擋風玻璃靠近車輛牌照處展示。
- (三) 所有貨物必須適當地繫牢在車輛上，而貨物的任何部份均不得接觸到路面。所有貨物不得只由車輛的尾閘支撐。
- (四) 在並非黑夜時間或在並非屬能見度低的情況下，該車輛的負載物的後端必須附有一塊面積不小於 1 平方米的紅旗。
- (五) 在黑夜時間或在能見度低的情況下，該車輛的負載物的前端每一邊均須展示有一盞朝前方照射的白燈，而負載物的後端須展示一盞朝後方照射的紅燈。
- (六) 在運載貨物車輛的前及後須有車輛護送。護送車輛須依照香港法例第 374 章道路交通（車輛構造及維修）規例第 111 條的規定裝上琥珀色光的閃動燈號，並在顯眼的位置，即在車輛的前面、後面或車頂上展示如圖 A 或 B 的適當標記（惟不得遮蔽琥珀色光的閃動燈號）。如屬前面護送車輛，該標記必須在車輛前面展示，使之面對迎面而來的車輛，如屬後面護送車輛，該標記必須在車輛後面展示，使之面對尾隨車輛。如裝在車頂，則可為雙面。
- (七) 此許可證亦須受警務處處長建議的其他條件限制。
- (八) 如違反許可證上任何條件，許可證會予取消；被取消的許可證，須交還運輸署署長。
- (九) 許可證持有人在運載特長和／或特潤貨物進入有管理機關或擁有人限制車輛進出的任何地方或私家路之前，必須取得該管理機關或擁有人預先批准。
- (1) A long load or wide load permit shall be valid for the period specified by the Commissioner for Transport.
- (2) The permit shall be displayed on the front windscreen of vehicle near to the vehicle licence.
- (3) Any load shall be properly secured to the vehicle, and no portion of it shall touch the road. No load shall be permitted to be carried only on the tailgate of the vehicle.
- (4) If the load is carried other than in the hours of darkness or in poor visibility conditions, a red flag of an area not less than one square metre shall be displayed at the rear extremity of the load.
- (5) During the hours of darkness and in poor visibility conditions, a white light showing ahead shall show ahead at each side of the front extremity of the load, and a red light shall show to the rear at the rear extremity of the load.
- (6) Escort vehicles to the front and rear of the load-carrying vehicle are required. An escort vehicle shall be equipped with an amber flashing light in accordance with Regulation 111 of the Road Traffic (Construction and Maintenance of Vehicles) Regulations, Cap. 374, and shall display in a prominent position, either at the front, rear or on the roof of the vehicle (but such that the flashing light is not obscured), a sign conforming with diagram “A” or “B” as appropriate. On the leading escort vehicle the sign shall be displayed to the front so as to face oncoming vehicles, and on the trailing escort vehicle the sign shall be displayed to the rear to face following vehicles. When mounted on the roof of an escort vehicle, signs may be double-sided.
- (7) The permit shall be subject to additional conditions recommended by the Commissioner of Police.
- (8) Contravention of any permit conditions may render the permit liable to cancellation in which case it shall be returned to the Commissioner for Transport.
- (9) The permit holder shall seek the approval from the relevant authority prior to carrying long and/or wide load in any area or private road of which the management authority or owner may restrict the access of the vehicle.

注意事項 NOTES FOR ATTENTION

- (一) 如任何駕駛執照持有人／登記車主曾向運輸署署長提供其姓名、地址或身分證明文件有所改變，他／她須在改變出現後 72 小時內以書面通知運輸署署長，並需提交有關改變的證明。任何人無合理辯解而違反此規定，即屬犯罪，可處罰款 \$2,000。如屬姓名的改變或身分證明文件的改變，駕駛執照持有人／登記車主亦須將現有的駕駛執照正本 (如持有)、駕駛教師執照正本 (如持有)、車輛登記文件正本 (如持有)、車輛牌照 (如持有) 及自訂登記號碼分配證明書 (如持有) 送交運輸署署長，以作修改。
- (二) 運輸署署長在處理牌照申請時，可要求申請人出示其現時地址的證明 (住址／公司地址 (如以公司為登記車主) 及通訊地址，例如水／電／煤氣／手提電話費單或銀行信件等，而該地址證明需距今不超過三個月)，以及可在申請人出示該等證明之前，**暫停處理該申請**。因此，請申請人帶同現時的地址證明，並在牌照事務處人員要求下，出示其地址證明。
- (三) 所有在本署以你的身分證明文件／公司註冊證號碼登記的車輛牌照或駕駛執照的記錄，會根據你在此申請表內填報的地址而同時更改。

- (1) If a change occurs in the **name, address or identity document of a driving licence holder/registered vehicle owner** previously provided by the driving licence holder/registered vehicle owner to the Commissioner for Transport, the driving licence holder/registered vehicle owner shall, within 72 hours of the change, notify the Commissioner for Transport in writing with the proof of change. Any person who without reasonable excuse contravenes such requirement commits an offence and is liable to a fine of \$2,000. For cases of change of name or change of identity document, the driving licence holder/registered vehicle owner shall also deliver to the Commissioner for Transport the existing original driving licence (if applicable), original driving instructor's licence (if applicable), original vehicle registration document (if applicable), vehicle licence (if applicable) and Certificate of Allocation of Personalized Registration Mark (if applicable) for amendment.
- (2) The Commissioner for Transport may, in processing licensing application, require the applicant to **produce proof of his/her present address** (residential/company (if using a company as registered vehicle owner) and correspondence address, e.g. water/electricity/gas/mobile phone bill or bank correspondence, which is issued not more than three months from now), and may **suspend the processing of the application** until the production of such proof. Therefore, applicants please bring along with your proof of present address for presentation as and when requested by officers of licensing offices.
- (3) For any change of address notified in this application form, all vehicle/driving licence records of the applicant under the same identity document/Certificate of Incorporation held by this Department will also be changed.
- (4) Copy of your submitted supporting document(s) will be destroyed after processing your application.
