A certificate showing the current vehicle particulars or that of a specified date and time within 5 years before the date of application can be issued by the computer on the day when the application is received. If the application is made for a certificate showing vehicle particulars of a specified date and time over 5 years before the date of application, the certificate will be posted to the applicant by registered post within 10 working days upon receipt of the application. If the applicant has not received the certificate within 5 weeks from the date of submitting the application, please contact the Transport Department at 2804 2600 for follow up action.

All information provided in this application may be disclosed to the concerned registered vehicle owner. Please also pay attention to paragraph 4 of the “Personal Data Collection Statement”. Applicants are advised to carefully consider the potential implications of the mentioned disclosure prior to submitting the applications.

If this Department or a law enforcement agency suspects that this application may not be genuine or that the information on the certificate may have been misused (e.g. after this Department issued the certificate, a complaint/report is received from the registered owner of the vehicle concerned), this Department/ law enforcement agency may request the applicant to provide supporting documents/information for verification of the information provided in this application (e.g. whether the information obtained from the certificate has only been used for the purpose(s) as stated in this application). Even without any complaints/reports, random check may also be conducted by this Department on this application within two years from the date the certificate is issued.

Having regard to the considerations of protecting the vehicle owners' privacy and other relevant rights and freedoms under the Basic Law, the Hong Kong Bill of Rights Ordinance (Cap. 383) and the Personal Data (Privacy) Ordinance (Cap. 486), the Transport Department will not approve applications that do not meet the conditions specified in items 2(1), (2) and (3)(a) to (g) in Part B.

In case the applicant considers that the application does not meet the conditions specified in items 2(1), (2) and 3(a) to (g) in Part B but there is a need to ascertain the registered particulars of a vehicle due to other circumstances involving the ownership or uses of the vehicle and involving significant public interest, and wishes the Commissioner for Transport to give special consideration for issuance of the certificate, the applicant must make an application under exceptional circumstances through a written submission to the Commissioner for Transport (this application form is not applicable in such circumstances). The application under exceptional circumstances will only be approved if the Commissioner for Transport is satisfied that the applicant's obtaining and the disclosure by the Commissioner for Transport of the vehicle particulars (or part of the particulars) to the applicant is lawful and legitimate; that the public interest in disclosing the vehicle particulars (or part thereof) outweighs the registered owner's right to privacy, and the lawful rights and interests of other persons and society as a whole in the overall circumstances of the case. The Commissioner for Transport must also be satisfied that the concerned particulars will be used by the applicants solely for the stated purpose(s) without any misuse or abuse. For details, please refer to the 'Guidance Notes on the Applications for a Certificate of Particulars of Vehicle' [[https://www.td.gov.hk/en/public\\_services/licences\\_and\\_permits/index.html](https://www.td.gov.hk/en/public_services/licences_and_permits/index.html)].

- (8) 就任何申請而言，如運輸署署長有合理理由相信批准有關申請會不利於國家安全，或相當可能威脅公共安全或損害維護公共秩序，將拒絕有關申請。

With respect to all applications, if the Commissioner for Transport reasonably believes that approving a particular application would be contrary to the interests of national security, or is likely to threaten public safety or prejudice the maintenance of public order, it would be rejected.

If the application is submitted by an agent, the agent is also required to produce his/her own original identity document for record purpose.

The registered vehicle owner can provide written consent in either paper or electronic format.
