4. 申請人通過私家／公共巴士（車輛類別 9/10）的駕駛考試後，只可獲發私家巴士（車輛類別 9）及私家小巴（車輛類別 4）的正式駕駛執照：申請人須分別完成公共巴士司機職前課程及公共小巴司機職前課程並獲取有關的課程證書，才可獲發公共巴士（車輛類別 10）及公共小巴（車輛類別 5）的正式駕駛執照。相關課程證書內所指明的完成課程日期須為申請該車輛類別的正式駕駛執照日期之前的一年內。

An applicant who passed a Private/Public Bus (Class 9/10) driving test will only be issued with the full driving licence to drive a Private Bus (Class 9) and a Private Light Bus (Class 4). The applicant has to complete the Pre-service Course for Public Bus Drivers and the Pre-service Course for Public Light Bus Drivers respectively and obtain the course certificates for the issue of the full driving licence to drive a Public Bus (Class 10) and a Public Light Bus (Class 5). The date of completion of the course specified in the course certificate shall fall within one year preceding the date of application for the full driving licence to drive the vehicle class.

A person shall not be eligible for a full driving licence to drive a taxi, a private light bus or public light bus, a private bus or public bus, a medium goods vehicle, a heavy goods vehicle, a special purpose vehicle or an articulated vehicle if he has been convicted of an offence under Section 36 (Causing death by dangerous driving), Section 36A (Causing grievous bodily harm by dangerous driving), Section 39 (Driving a motor vehicle under the influence of drink), Section 39A (Driving, attempting to drive or being in charge of a motor vehicle with alcohol concentration above prescribed limit), Section 39B (Screening breath tests), Section 39C (Provision of specimens for alcohol analysis), Section 39J (Driving motor vehicle without proper control under influence of specified illicit drug), Section 39K (Driving motor vehicle with any concentration of specified illicit drug), Section 39L (Driving motor vehicle without proper control under influence of drug other than specified illicit drug), Section 39O(1) (Failure to undergo preliminary drug test), Section 39S (Failure to provide specimen of blood or urine) of the Road Traffic Ordinance (Cap. 374) during the 5 years immediately preceding his application.

Any person who without reasonable excuse contravenes such requirement commits an offence and is liable to a fine of \$2,000. For cases of change of name or change of identity document, the driving licence holder/registered vehicle owner shall also deliver to the Commissioner for Transport the existing original driving licence (if applicable), original driving instructor's licence (if applicable), original vehicle registration document (if applicable), vehicle licence (if applicable) and Certificate of Allocation of Personalized Registration Mark (if applicable) for amendment.

### FIRST SCHEDULE TO THE ROAD TRAFFIC (DRIVING LICENCES) REGULATIONS—EXCEPTED DISEASES AND PHYSICAL DISABILITIES

- (一) 癲癇症。  
(二) 高血壓或其他原因，以致有可能突然暈眩或昏倒以致失去能力。  
(三) 精神紊亂，以致執照申請人或持有人(視屬何情況而定)有可能根據《精神健康條例》(第136章)被羈留或以住院病人身分在該條例所指的精神病院接受治療。  
(四) 任何導致肌肉不受控制的狀況。  
(五) 未受控制的糖尿病。  
(六) 不能在白天充足光線下讀出與他相距23米的登記號碼(有需要者在配戴眼鏡或其他矯正視力鏡片作為協助，仍不能讀出)。  
(七) 任何其他疾病或傷殘，而該疾病或傷殘很可能令申請人或持有人沒有能力在不危及公眾安全的情況下，有效地駕駛或控制該執照所指的汽車或經適當改裝的汽車；但失聰本身並不當作上述的傷殘。  
(1) Epilepsy.  
(2) Liability to sudden attacks of disabling giddiness or fainting due to hypertension or any other cause.  
(3) Mental disorder for which the applicant for the licence, or, as the case may be, the holder of the licence is liable to be detained under the Mental Health Ordinance (Cap. 136) or is receiving treatment as an in-patient in a mental hospital within the meaning of that Ordinance.  
(4) Any condition causing muscular incoordination.  
(5) Uncontrolled diabetes mellitus.  
(6) Inability to read at a distance of 23 metres in good daylight (with the aid of spectacles or other corrective lenses, if worn) a registration mark.  
(7) Any other disease or disability which is likely to render him incapable of effectively driving and controlling a motor vehicle or suitably adapted motor vehicle to which such licence refers without endangering public safety, provided that deafness shall not of itself be deemed to be any such disability.
