

# Important Notice

## Requirement of Address Proof

The original or a copy of the proof of address issued within the last three months **has to** be produced when submitting a licensing application. In accordance with the relevant legislation, the Transport Department may suspend processing the application in the absence of address proof. [\[Please refer to the list of acceptable proof of address\]](#)

## Change of Address

According to the law, driving licence holders or registered vehicle owners have to notify the Transport Department (TD) within 72 hours of their change of address. Any person without reasonable excuse contravenes such requirement commits an offence and is liable to a fine of \$2,000. You may notify TD of change in address with your proof of new address in writing, through [GovHK](#) or by submitting [the specified form](#) ("Change of Personal Particulars or Vehicle Particulars").

## Mail items with insufficient postage

Underpaid mail items are subject to surcharge by Hongkong Post. This department will not accept underpaid mail items, which will be returned to the sender (with return address) or disposed of (without return address) by the Hongkong Post. For proper delivery of your mail items to the department, and to avoid unnecessary delivery delay or unsuccessful delivery, please ensure your mail items bear sufficient postage with return address before posting. ## Apply for Full Driving Licence upon Completion of Probationary Driving Period

A probationary driving licence holder will only be allowed to apply for a full driving licence for the related class of vehicle within three years from the day after the completion date of the probationary driving period. If that day is a non-working day for the Licensing Offices of the Transport Department (e.g. Saturday, Sunday or a public holiday), the probationary driving licence holder concerned can only apply for a full driving licence at Licensing Offices on any subsequent working day.

## Submission of Identity Document

For application submitted by post/ via drop-in box, please **do not** submit the **original** identity document.

If you are a registered elector and your residential address has changed, please notify the Registration and Electoral Office (REO) as early as possible. For enquiries, please call the REO hotline 2891 1001.

## First Schedule of Road Traffic (Driving Licences) Regulations Excepted Diseases and Physical Disabilities

- (1) 癲癇症。
- (2) 高血壓或其他因由，以致有可能突然暈眩或昏倒以致失去能力。
- (3) 精神紊亂，以致執照申請人或持有人 (視屬何情況而定) 有可能根據《精神健康條例》(第 136 章) 被羈留或以住院病人身分在該條例所指的精神病院接受治療。
- (4) 任何導致肌肉不受控制的狀況。
- (5) 未受控制的糖尿病。
- (6) 不能在白天充足光線下讀出與他相距 23 米的登記號碼 (有需要者在配戴眼鏡或其他矯正視力鏡片作為協助，仍不能讀出)。
- (7) 任何其他疾病或傷殘，而該疾病或傷殘很可能令申請人或持有人沒有能力在不危及公眾安全的情況下，有效地駕駛或控制該執照所指的汽車或經適當改裝的汽車；但失聰本身並不當作為上述的傷殘。
- (1) Epilepsy.
- (2) Liability to sudden attacks of disabling giddiness or fainting due to hypertension or any other cause.
- (3) Mental disorder for which the applicant for the licence, or, as the case may be, the holder of the licence is liable to be detained under the Mental Health Ordinance (Cap. 136) or is receiving treatment as an in-patient in a mental hospital within the meaning of that Ordinance.
- (4) Any condition causing muscular incoordination.
- (5) Uncontrolled diabetes mellitus.
- (6) Inability to read at a distance of 23 metres in good daylight (with the aid of spectacles or other corrective lenses, if worn) a registration mark.
- (7) Any other disease or disability which is likely to render him incapable of effectively driving and controlling a motor vehicle or suitably adapted motor vehicle to which such licence refers without endangering public safety, provided that deafness shall not of itself be deemed to be any such disability.

- (9) 在完成辦理你的申請後，你所提交的證明文件副本將會被銷毀。

### 暫准駕駛執照須知

- (10) 根據《道路交通（駕駛執照）規例》（第 374B 章）的規定報考電單車、機動三輪車、私家車或輕型貨車駕駛考試而獲取及格後，只符合資格申請暫准駕駛執照，暫准駕駛執照持有人必須通過強制性暫准駕駛期，方可申請正式駕駛執照。
- (11) 暫准駕駛執照須在有關駕駛考試及格日期起計 3 年內申領。
- (12) 暫准駕駛執照有效期由簽發日起計，為期 12 個月。暫准駕駛執照每次可續期 6 個月，可於暫准駕駛執照屆滿前 15 日內或屆滿後 3 年內辦理續領手續。
- (13) 若被裁定觸犯一次『輕微』違例事項（『輕微』違例事項是根據《道路交通（駕駛執照）規例》（第 374 章，附屬法例 B）附表 12 所述的違例事項），暫准駕駛期須延長 6 個月。若被裁定犯下兩次『輕微』或一次『嚴重』違例事項（『嚴重』違例事項是根據《道路交通（違例駕駛記分）條例》（第 375 章）第 4 條，該人須就該違例事項被記 10 分或多於 10 分），暫准駕駛執照將被取消。
- (14) 如暫准駕駛期須要延長，你應在暫准駕駛執照屆滿前向本署申請續領手續，才能以有效的暫准駕駛執照來繼續完成餘下所需的暫准駕駛期。
- (15) 在完成某種類汽車的暫准駕駛期後，必須在 3 年之內申領該種類汽車的正式駕駛執照。否則，必須重新報考駕駛考試，獲取及格並取得該種類汽車的新暫准駕駛執照。你在完成新的暫准駕駛期後，才能再次申領該種類汽車的正式駕駛執照。
- (16) 倘你在暫准駕駛期內觸犯『輕微』或『嚴重』違例事項但並未被法庭定罪，你仍可申領正式駕駛執照。不過，如果你日後被法庭裁定該項違例罪名成立，則已獲發的正式駕駛執照將會被取消，而已繳付的牌照費將不會獲得退還。因此，在申請正式駕駛執照時，請留意你曾在暫准駕駛期間觸犯『輕微』或『嚴重』違例事項，及是否已符合領取正式駕駛執照的資格，以免日後因有關違例事項被定罪而引致你的正式駕駛執照被取消。
- (17) 如你的正式駕駛執照，因在暫准駕駛期內曾觸犯了一次『輕微』道路交通違例事項而被取消，你需要在正式駕駛執照被取消日起計 3 年內申請重新發出暫准駕駛執照。在圓滿完成所需要延長的暫准駕駛期後，你便可以再次申領正式駕駛執照。
- (18) 若你的暫准駕駛執照包含兩種類汽車，如私家車及輕型貨車，並在暫准駕駛期間駕駛私家車觸犯『輕微』或『嚴重』違例事項，私家車及輕型貨車兩個暫准駕駛汽車種類也會受影響；換言之，兩者的暫准駕駛期也須延長，或兩者的暫准／正式駕駛執照也會被取消。
- (19) 有關申請新領，續領或加領暫准駕駛執照及相關種類汽車的正式駕駛執照事宜，請參閱小冊子《暫准駕駛執照計劃》。

### 加領暫准駕駛執照

- (20) 如你在獲發暫准駕駛執照的日期起計 12 個月內，獲得另一種類汽車的考試及格，本署可以免費為你加簽新的汽車種類在現有的暫准駕駛執照上，而該暫准駕駛執照的有效日期將維持不變。在暫准駕駛執照屆滿前，你應續領暫准駕駛執照，以繼續完成新加簽汽車為期 12 個月的暫准駕駛期。

### 強制修習駕駛改進課程

- (21) 如你曾被要求修習和完成強制修習駕駛改進課程而你並未遵從該要求完成有關課程，運輸署署長不得向你發出或重新發出駕駛執照，或將駕駛執照續期。

### 更改個人資料

- (22) 如任何駕駛執照持有人／登記車主曾向運輸署署長提供其姓名、地址或身分證明文件有所改變，他／她須在改變出現後 72 小時內以書面通知運輸署署長，並須提交有關改變的證明。任何人無合理辯解而違反此規定，即屬犯罪，可處罰款 2,000 元。如屬姓名的改變或身分證明文件的改變，駕駛執照持有人／登記車主亦須將現有的駕駛執照正本（如持有）、駕駛教師執照正本（如持有）、車輛登記文件正本（如持有）、車輛牌照（如持有）及自訂登記號碼分配證明書（如持有）送交運輸署署長，以作修改。
- (23) 運輸署署長在處理牌照申請時，可要求申請人出示其現時地址的證明，以及可在申請人出示該等證明之前，暫停處理該申請。因此，請申請人士帶同現時地址的證明，並在牌照事務處人員要求下，出示該地址證明。
- (24) 所有在本署以你的身分證明文件號碼登記的車輛牌照或駕駛執照的記錄，會根據你在本申請表內填報的地址而同時更改。
- (25) 如欲運輸署署長刪除在駕駛執照和駕駛教師駕駛執照內「須戴眼鏡或矯正視力的鏡片」的駕駛限制，申請人須遞交由註冊醫生或專業視光師發出的證明書（正本及副本），並附上駕駛執照或駕駛教師駕駛執照正本（如持有）。

## General Information

- (1) You are advised to read the information booklet “How to Apply for a Driving Licence” before completion of this application form. You can obtain this booklet at all Licensing Offices or our website [www.td.gov.hk](http://www.td.gov.hk).
- (2) People with disabilities who wish to apply for a driving licence may contact Driving Services Section of Transport Department (Tel.: 2713 7262) for the arrangement of an appointment for driving ability assessment. Subject to the result of the assessment, you will be given an approval letter for applying for driving test and appropriate licence from the Commissioner for Transport.
- (3) **If you need to wear hearing aids when driving, please first approach Driving Services Section of Transport Department (Tel: 2713 7262) for arranging hearing ability assessment before submission of your application.**
- (4) If you subsequently suffer from any disease or physical disability which may cause the driving by you to be a source of danger to the public, you should report in writing to the Commissioner for Transport immediately.
- (5) If the application is submitted by an agent, the agent is also required to produce his/her own original identity document for record purpose.
- (6) The Commissioner for Transport is not empowered to issue any driving licence to you if there are any outstanding court orders directing the Commissioner for Transport to refuse to issue the licence to you.
- (7) If applicant has used cheque to settle payment of outstanding traffic fines, application for issue/renewal of driving licence would only be processed after 7 working days from the date of cheque payment.
- (8) Underpaid mail items are subject to surcharge by Hongkong Post. This department will not accept underpaid mail items, which will be returned to the sender (with return address) or disposed of (without return address) by the Hongkong Post. For proper delivery of your mail items to the department, and to avoid unnecessary delivery delay or unsuccessful delivery, please ensure your mail items bear sufficient postage with return address before posting. - (9) Copy of your submitted supporting document(s) will be destroyed after processing your application.

## Probationary Driving Licence

- (10) According to Road Traffic (Driving Licences) Regulations (Cap. 374B), any person who applies to take a driving test for motor cycle, motor tricycle, private car or light goods vehicle is only eligible to apply for a probationary driving licence upon passing the driving test. A probationary driving licence holder can apply for a full driving licence for the respective class after completion of a mandatory probationary driving period.
- (11) A probationary driving licence must be applied within 3 years from the date of passing the relevant driving test.
- (12) A probationary driving licence is valid for 12 months from the date of issue. A probationary driving licence can be renewed for 6 months each time. The application may be submitted at any time within 15 days before its expiry or not more than 3 years after its expiry.
- (13) The probationary driving period shall be extended by 6 months if you are convicted of one “minor” offence (a “minor” offence refers to one of offences stated in the Twelve Schedule of the Road Traffic (Driving Licences) Regulations (Cap. 374B). The probationary driving licence shall be **cancelled** if you are convicted of two “minor” offences or one “serious” offence (a “serious” offence refers to an offence in respect of which 10 or more points shall be incurred under section 4 of the Road Traffic (Driving-offence Points) Ordinance (Cap. 375)).
- (14) If the probationary driving period is extended by 6 months, you should renew your probationary driving licence before expiry in order to get a valid probationary driving licence to continue to undergo the remaining probationary driving period.
- (15) Application for full driving licence to drive a vehicle class must be submitted within 3 years from the date of completion of the probationary driving period for that vehicle class; otherwise, you must sit for and pass a driving test again to obtain a new probationary driving licence to drive that vehicle class. You will be eligible to apply for a full driving licence to drive that vehicle class after completing the requisite probationary driving period afresh.
- (16) If you have committed a “serious” or “minor” offence during the probationary driving period but have not been convicted during the probationary driving period, you will still be eligible for applying a full driving licence. However, the full driving licence that you have obtained shall be **cancelled** and the licence fee paid shall not be refunded if you are convicted of the offence at a later date. Therefore, in submitting your application for full driving licence, your attention is drawn to whether you have committed a “serious” or “minor” offence during your probationary driving period and whether you have fulfilled the requirements for obtaining a full driving licence, in order to avoid any subsequent cancellation of your full driving licence upon conviction of the offence.
- (17) If your full driving licence has been cancelled upon conviction of a “minor” offence committed during the probationary driving period, you must apply for reissue of probationary driving licence within 3 years from the cancellation date of your full driving licence. You will be eligible for applying for a full driving licence after satisfactorily completion of the extended probationary driving period.
- (18) If you hold two probationary classes, e.g. private car and light goods vehicle, and commit a “serious” or “minor” offence whilst driving a private car during the probationary driving period, upon conviction of the offence, the probationary classes of both private car and light goods vehicle will be affected, in terms of extension of probationary driving period or cancellation of probationary/full driving licence.
- (19) Regarding the application requirements in respect of applications for new issue or entitlement addition of probationary driving licence and full driving licence for relevant vehicle class(es), you are advised to read the leaflet “Probationary Driving Licence Scheme”.

## Addition of Probationary Driving Licence

- (20) If you are holding a probationary driving licence to drive a vehicle class, and within 12 months from the date of issue of this probationary driving licence you pass a driving test of another probationary class, Transport Department will add this new class on your existing probationary driving licence free of charge with the validity date unchanged. You should renew the probationary driving licence before expiry in order to continue to undergo the 12-month probationary driving period for the newly added class.

## Mandatory Attendance of Driving Improvement Course

- (21) If you have been required to attend and complete mandatory attendance of driving improvement course(s) and you have not complied with the requirement, the Commissioner for Transport shall not issue, reissue or renew a driving licence to you.

## Change of Personal Particulars

- (22) If a **change occurs in the name, address or identity document** of a driving licence holder/registered vehicle owner previously provided by the driving licence holder/registered vehicle owner to the Commissioner for Transport, the driving licence holder/registered vehicle owner shall, within 72 hours of the change, notify the Commissioner for Transport in writing with the proof of change. Any person who without reasonable excuse contravenes such requirement commits an offence and is liable to a fine of \$2,000. For cases of change of name or change of identity document, the driving licence holder/registered vehicle owner shall also deliver to the Commissioner for Transport the existing original driving licence (if applicable), original driving instructor's licence (if applicable), original vehicle registration document (if applicable), vehicle licence (if applicable) and Certificate of Allocation of Personalized Registration Mark (if applicable) for amendment.
- (23) The Commissioner for Transport may, in processing licensing application, require the applicant **to produce proof of his/her present address**, and may suspend the processing of the application until the production of such proof. Applicants please bring along your proof of present address for presentation as and when requested by officers of licensing offices.
- (24) For any change of address notified in this application form, all vehicle/driving licence records of the applicant under the same identity document held by this Department will also be changed.
- (25) If you wish to apply to the Commissioner for Transport for deletion of the driving restriction "To wear glasses or corrective lenses", please provide **original and copy** of medical certification or certificate, issued by Registered Medical Practitioner/Registered Optometrist and your **original** driving licence or your **original** driving instructor's licence (if applicable).
