The director of the company should be the authorised person to submit application if the director concerned is the registered owner of the vehicle in respect of which the application is made. The director who has been authorised by a company to submit an application and as the vehicle owner of that application is NOT allowed to submit another application under the other quota type in the name of an individual. In case the director is a body corporate (e.g. a registered company), that body corporate is NOT allowed to submit another application under the company quota type.

Note: According to Regulation 12 of Provisions on the Application for and Use of Driving Licenses (Order No. 139, Ministry of Public Security, the People's Republic of China), applicants for the People's Republic of China Motor Vehicle Driving Licence must be aged over 18 and under 70. This requirement is not applicable to designated drivers who have already obtained the People's Republic of China Motor Vehicle Driving Licence. (F) 截止申請日期 Closing date of application

12. 所有申請表必須在 2021 年 7 月 7 日下午 5 時 15 分前遞交。若以郵遞方式申請，將以郵戳日期為準。逾期遞交的申請一概不獲處理，本署會以書面通知有關人士。
All the applications must be submitted before 5:15 p.m. on 7 July 2021. For applications submitted by post, the postmark dates will be taken as the dates of application. Late applications will not be considered and the persons concerned will be notified in writing.
13. 本署會以電郵形式向以郵寄或投遞箱遞交申請的申請人確認收妥申請。以網上系統遞交申請者，會在完成申請時獲發申請編號。由於配額有限及審核申請需時，申請人獲發申請編號並不代表其申請成功。如果於 2021 年 7 月 14 日仍未收到有關申請編號，必須立即致電 2804 2600 與本署聯絡。
For application submitted by post or through drop-in box, an acknowledgement email will be issued to the applicant to confirm receipt of the application and inform of an application number. For applications submitted online, the applicant will be allocated with an application number once application submitted. Since the number of quotas is limited and it takes time to process applications, the allocation of an application number to an applicant does not imply that the application is successful. **If no application number is received by 14 July 2021, please call 2804 2600 to enquire.**

(G) 抽籤 Balloting

14. 若申請數目超出擬發出的 300 個香港私家車往來港澳配額數目時（個人及註冊公司名義申請的配額各 150 個），本署將會按申請類別，以抽籤決定處理每宗申請的先後次序。抽籤結果將上載於本署網頁(<http://www.td.gov.hk>)，申請人亦可透過 2804 2600 查詢。
If the number of applications exceeds the 300 regular quotas for Hong Kong-Macao cross-boundary private cars proposed to be issued (150 quotas for individual applicants and 150 for registered company applicants), this Department will, in accordance with their types of applications, carry out balloting to determine the order of applications to be processed. The ballot result will be available at this Department's website (<http://www.td.gov.hk>). Applicants may also call 2804 2600 to enquire.
15. 本署會依照抽籤的先後次序，向申請人發出處理封閉道路通行許可證的申請邀請，直至有關申請類別配額額滿為止。
This Department will invite applicants to proceed with their applications for closed road permit according to their balloted order, until all quotas have been filled.
16. 有關申請類別配額額滿後（以個人名義申請及註冊公司名義申請的各 150 個已分配完畢），其餘申請會被撥入備取名單。
When all quotas for the application type have been filled (i.e. when the 150 quotas for individual applicants and 150 quotas for registered company applicants have all been allocated), the remaining applicants will be put on a waiting list.
17. 本署會以申請人提交及填報的本申請表及封閉道路通行許可證申請表審核。申請人並須遞交上文須知事項（6）所規定的所需文件，如申請人填寫或提交資料不全、有誤或不符合申請條件，申請人會被取消資格。其配額會按次序分配予備取名單上的備取者。
This Department will vet this application form and the application form for closed road permit submitted and completed by applicant. Applicant must also submit the required documents as stipulated in Note (6) above. If the information provided or submitted by the applicant is incomplete, inaccurate or does not meet the application requirements, the applicant will be disqualified and the quota allocated will be re-allocated to applicants on the waiting list according to the balloted order.
18. 申請人獲發配額後，辦理相關封閉道路通行許可證時需繳付費用（現時收費為每張每年港幣 540 元）。
Having been allocated with a quota, a fee is payable by the applicant for the closed road permit application (the current annual fee is HK\$540).
19. 本署於 2020 年 12 月至 2021 年 1 月接受上一批香港私家車往來港澳的常規配額申請，該批申請仍在處理中。如同一申請人曾於上述期間提交申請，本署將會按每宗申請的抽籤先後次序處理。申請人一旦獲本署簽發配額，本署將停止繼續處理該申請人其他未獲簽發配額的申請（不論是本批或 2020 年 12 月至 2021 年 1 月的申請）。
The TD is still processing the applications for regular quota for Hong Kong private cars to Macao submitted between December 2020 and January 2021.
