豁免申請

運輸署只會考慮及處理已兩年或以上未領牌、且已發出「車輛兩年未有領牌通知書」的車輛相關豁免續牌申請。車輛未領牌不足兩年或早於通知書發出前提出的申請將不獲考慮及處理。

車輛相關法律責任

即使運輸署已向有關車輛批出豁免，有關車輛會一直登記在車主的名下，車主仍須繼續承擔該車輛引起的所有法律責任。

核實「電子聯絡方式」

In general, the exemption period commences **on the day when the Transport Department completes processing the application**. For vehicle owners who applied for and granted with a further exemption within 3 months before the current exemption period expires, the new exemption period will commence **after the current exemption period expires**.

- If the Transport Department has granted an exemption to the registered vehicle owner in respect of the vehicle, and it remains not reasonably practicable to have the vehicle licensed, the owner/ car dealer (for vehicles properly stored by established car dealers and are consigned for sale) may submit an exemption application to the Transport Department within 3 months immediately before the expiry of the exemption.
- Even if an exemption is granted, the vehicle concerned will continue to be registered under the name of the owner who has to bear all the legal liabilities associated with that vehicle.
- If the ownership of a vehicle granted with an exemption is transferred to a new owner during the exemption period, the approved exemption would be cancelled immediately. As no vehicle licence in respect of the vehicle has been in force for 2 years or more, another notice will be issued to the new owner under regulation 25A of the Regulations and the new owner must comply with the notice by applying for a vehicle licence within 3 months from the date of the notice issued pursuant to regulation 25A of the Regulations, unless the registration of the vehicle is cancelled under regulation 20 of the Regulations or a new exemption is obtained in respect of the vehicle under regulation 25B of the Regulations. Otherwise, the new owner may be prosecuted for not abiding the requirements prescribed in regulation 25A(3) of the Regulations.
- If the vehicle's year of manufacture is 30 years or above and is properly stored as a private collection, or it is properly stored by established car dealers and are consigned for sale, in case there is any change of the storage location of the above, the applicant must inform the Transport Department in writing of such changes as soon as practicable together with relevant supporting document(s), otherwise the exemption may be cancelled.
- Pursuant to regulation 25B(3), if proceedings for an offence under regulation 60(2A) of the Regulations in respect of the vehicle have been instituted, no exemption may be granted for the vehicle.
- The Transport Department may, by giving reasonable notice to the registered owner, alter or cancel the exemption granted.
- E-Contact Means — Applicants must provide either a Hong Kong mobile phone number through which they can be contacted by an SMS message or an email address through which they can be contacted by an electronic mail as the e-contact means when submitting driving or vehicle licensing applications. The e-contact means must be verified through the website of the Transport Department within three months before submitting an application, otherwise the processing of the application may be suspended.
