# (甲) 簽發條件

- (一) 客運營業證證明書乃簽發予以有效客運營業證經營的車輛。
- (二)客運營業證證明書的有效期為一年或與客運營業證屆滿期相同,惟以期間早者為依歸。
- (三) 每輛以客運營業證經營的車輛,必須:
  - (a) 在該車輛擋風玻璃的左面展示一張由運輸署署長指定格式的證明書;及
  - (b) 根據道路交通(公共服務車輛)規例第2附表中圖2所指定的形式於車輛後面展示載有客運營業證編號的字牌。
- (四)任何人士不得駕駛或使用已領有客運營業證的車輛或容許或任令他人駕駛或使用該車輛,如該車輛:
  - (a) 並無展示如以上第(三)段所指的證明書及字牌;
  - (b) 展示該證明書或字牌的方法與以上第(三)段所指定者不符;
  - (c) 展示任何聲稱為以上第(三)段所指的證明書或字牌,惟該證明書或字牌:
    - (i) 已遭毀壞、塗改或損毀;
    - (ii) 與該車輛現有的客運營業證無關;或
    - (iii) 與該車輛無關。

# (丁) 更改資料

申請人所填報的資料,如有任何更改,應即通知運輸署署長。

# (戊)警告

- (一) 根據香港法例第 201 章防止賄賂條例,任何人士,如向公務員提供利益,乃屬違法。遇有公務員或聲稱為公務員的代理人者,向申請人索取利益或 請求給予利益,申請人應即向廉政公署舉報(電話: 2526 6366)。

# **Purposes of Collection**

- 1. The personal data provided by means of this form will be used by Transport Department for the following purposes:
  - (a) activities relating to the processing of your application in this form;
  - (b) maintenance of a register of vehicles for public access under regulation 4(2) of the Road Traffic (Registration and Licensing of Vehicles) Regulations; (applicable to vehicle-related applications only)
  - (c) maintenance of a record of particulars of driving licences under regulation 39 of the Road Traffic (Driving Licences) Regulations; (applicable to driving licence-related applications only)
  - (d) activities relating to traffic and transport matters; and
  - (e) facilitating communication between Transport Department and yourself.
- 2. It is obligatory for you to supply the personal data as required by this form. If you fail to supply the required data, your application may be refused.

# Classes of Transferees

- 3. The personal data you provided by means of this form may be disclosed to:
  - (a) other Government bureau and departments for the purposes mentioned in paragraph 1 above;
  - (b) any person for the purpose mentioned in paragraph 1(b) above; and
  - (c) tunnel companies, Tsing Ma Control Area operator and Tsing Sha Control Area operator for execution of their statutory duties in traffic and transport matters.

# Access to Personal Data

4. You have a right of access and correction with respect to personal data as provided for in sections 18 and 22 and principle 6 of Schedule 1 of the Personal Data (Privacy) Ordinance. Your right of access includes the right to obtain a copy of your personal data provided by this form.

# NOTES FOR ATTENTION

#### A. CONDITIONS OF ISSUE

- (1) A passenger service licence certificate will be issued in respect of a vehicle operating under a valid passenger service licence.
- (2) A passenger service licence certificate is valid for one year or until the passenger service licence expires, whichever is the earlier.
- (3) Every vehicle operated under a passenger service licence shall display—
  - (a) on the left hand half of vehicle's windscreen in a manner as to be visible from the front of the vehicle a certificate in a form specified by the Commissioner for Transport; and
  - (b) at the rear of the vehicle, a plate showing the passenger service licence number in accordance with Figure No. 2 of the Second Schedule to the Road Traffic (Public Service Vehicles) Regulations.
- (4) No person shall drive or use a vehicle operated under a passenger service licence or suffer or permit such a vehicle to be driven or used, if such vehicle—
  - (a) does not display the certificate and the plate referred to in para. (3) above;
  - (b) displays such certificate or plate other than in the manner prescribed by para. (3) above;
  - (c) displays any such certificate or plate purporting to be a certificate or plate referred to in para. (3) that—
    - (i) is damaged, altered or defaced;
    - (ii) does not relate to a passenger service licence currently in force in respect of the vehicle; or
    - (iii) does not relate to the vehicle.
  - (d) displays a certificate referred to in para. (3) that is invalid.

# B. COMPLETION OF FORMS

(1) All relevant items of the form should be completed by an applicant in <u>BLOCK LETTERS</u>. The declaration in PART E must be signed. Incomplete or insufficient information may render the application unacceptable for consideration or may result in the applicant being required to attend interviews for clarification.

Part C

- (2) Applicants should list the particulars of only those public light buses with passenger service licence certificates due to expire within 4 months from the date of application.
- (3) For enquiry of passenger service licence fees, you may enquire at Hong Kong Licensing Office, obtain TD341 containing various licence fee or visit Transport Department's website (http://www.td.gov.hk).

# C. SUBMISSION OF APPLICATIONS

All completed applications should be submitted either in person or by registered post to Public Vehicles Unit of Transport Department at 3/F., United Centre, 95 Queensway, Hong Kong, within 4 months and at least 14 days before expire of the passenger service licence certificate(s). Applicant should forward the application form and all supporting documents as stipulated in PART F below, failure of which may result in delaying the issue of new Passenger Service Licence Certificate(s) at a later date.

# D. AMENDMENT

The Commissioner for Transport should be notified of any change in particulars immediately.

# E. WARNING

- (1) Applicants are reminded that it is an offence under the Prevention of Bribery Ordinance (Cap. 201) for any person to offer an advantage to a Government Servant. In the case of a Government Servant or any person representing to be his agent seeking or soliciting advantage from an applicant he should immediately report to the Independent Commission Against Corruption (Tel. 2526 6366).
- (2) Applicants are also reminded that if they knowingly make any statement which is false in a material particular for the purpose of obtaining a passenger service licence certificate, they will not only render their applications null and void but will also render themselves liable to prosecution under Section 111(3) of the Road Traffic Ordinance (Cap. 374) and on conviction to a fine of \$5,000 and to imprisonment for 6 months.

The following documents should be forwarded at the time of submission of the application form:—

- (1) Hong Kong Identity Card/Limited Company Certificate of Incorporation (copy only); (the copy of the identity card attached with the application submitted by registered post will be destroyed after processing the application)
- (2) Valid Business Registration Certificate (copy only);
- (3) Vehicle Registration Document(s) (copy only);
- (4) Passenger Service Licence (original); and
- (5) Other relevant documents/information in support of the application not mentioned above.
