(甲) 簽發條件

- (一) 公共小巴(專線)服務為以公共小巴作載客服務並收取個別及固定的收費，該等收費乃根據行走路線的路程長短而釐定，公共小巴(專線)服務客運營業證的簽發指定批准該等車輛用作公共小巴用途並得依照營業證上指定的地區或街道接載乘客，除非另作別論。
- (二) 客運營業證的有效期限通常為3年。
- (三) 每輛以客運營業證經營的車輛，必須：——
 - (a) 在該車輛擋風玻璃的左面展示一張由運輸署署長指定格式的證明書；及
 - (b) 根據道路交通(公共服務車輛)規例第2附表中圖2所指定的形式於車輛後面展示載有客運營業證編號的字牌。
- (四) 任何人士不得駕駛或使用已領有客運營業證的車輛或容許或任令他人駕駛或使用該車輛，如該車輛：——
 - (a) 並無展示如以上第(三)段所指的證明書及字牌；
 - (b) 展示該證明書或字牌的方式與以上第(三)段所指定者不符。
 - (c) 展示任何聲稱為以上第(三)段所指的證明書及字牌，惟該證明書或字牌：——
 - (i) 已遭毀壞，塗改或損毀；
 - (ii) 與該車輛現有客運營業證無關；或
 - (iii) 與該車輛無關。
 - (d) 展示如以上第(三)段所指的證明書及字牌，惟該證明書已失效。
- (五) 有關各類客運營業證的費用，你可於香港牌照事務處查詢或索取印有各類牌費用的單張(TD341)或瀏覽運輸署網頁(<http://www.td.gov.hk>)。
- (六) 如有理由相信(甲)該已領有客運營業證的車輛，曾經或正被用作並非其營業證所許可的用途；或(乙)該營業證的任何條件或任何有關法例未被遵從或已被抵觸者，經調查屬實，則運輸署署長可：——
 - (a) 吊銷客運營業證一個時期或將客運營業證取消；
 - (b) 就所指明的車輛吊銷客運營業證一個時期或將客運營業證取消；或
 - (c) 就下開事項更改客運營業證：——
 - (i) 路線；
 - (ii) 所批准的用途；
 - (iii) 營業證內的車輛數目。
- (七) 遇客運營業證被取消、吊銷、更改或修訂時，持證人應於其後的七十二小時內將營業證遞交運輸署署長，俾能視乎情況需要而將其營業證取消、吊銷、更改或修訂。
- (八) 該等經營必須按照由運輸署署長所批准及指定的服務細節。
- (九) 該等公共小巴(專線)服務客運營業證持證人必須通知運輸署署長任何因該專線服務而牽涉在內的法律訴訟程序。
- (十) 其他條件將於批准通知書內註明。

(乙) 填寫表格

- (一) 申請人須用正楷填寫此表格內各項有關資料。若資料不全或有漏報，其中請將不予考慮。此外，該申請人或須應邀前來會見運輸署人員，以便澄清任何疑點。

- (二) 申請人於取得經營權後，須向運輸署負責，確保各該路線的服務，能令運輸署感到滿意。

- (一) 根據防止賄賂條例(香港法例第201章)，任何人士，如向公務員提供利益，乃屬違法。遇有公務員或聲稱為公務員的代理人者，向申請人索取利益或請求給予利益，申請人應即向廉政公署舉報(電話：2526 6366)。
- (二) 申請人如故意提供失實資料以圖獲發該公共小巴(專線)服務營業證，則其申請即告無效。此外，根據道路交通條例(香港法例第374章)第111(3)條，其本身尚有被判罰款5,000元及監禁6個月之虞。

- It is obligatory for you to supply the personal data as required by this form. If you fail to supply the required data, your application may be refused.

**APPLICATION FOR PASSENGER SERVICE LICENCE
TO OPERATE PUBLIC LIGHT BUS (SCHEDULED) SERVICE**

NOTES FOR ATTENTION

A. CONDITIONS OF ISSUE

- (1) A public light bus (scheduled) service is a service for the carriage by public light bus of passengers at separate and fixed fares, the charge of which is based on the route kilometrage. Any passenger service licence for the operation of public light bus service (scheduled) service issued should be designated as authorising the use of the vehicle(s) for the carriage of passengers by public light bus in areas or on roads specified in the licence unless otherwise stated.
- (2) A passenger service licence will normally be issued for a period of 3 years.
- (3) Every vehicle operated under a passenger service licence shall display—
 - (a) on the left hand half of the vehicle's windscreen in a manner as to be visible from the front of the vehicle a certificate in a form specified by the Commissioner for Transport; and
 - (b) at the rear of the vehicle, a plate showing the passenger service licence number in accordance with Figure No. 2 of the Second Schedule to the Road Traffic (Public Service Vehicles) Regulations.
- (4) No person shall drive or use a vehicle operated under a passenger service licence or suffer or permit such a vehicle to be driven or used, if such vehicle—
 - (a) does not display the certificate and the plate referred to in para. (3) above;
 - (b) displays such certificate or plate other than in the manner prescribed by para. (3) above;
 - (c) displays any such certificate or plate purporting to be a certificate or plate referred to in para. (3) that—
 - (i) is damaged, altered or defaced;
 - (ii) does not relate to a passenger service licence concurrently in force in respect of the vehicle; or
 - (iii) does not relate to the vehicle.
 - (d) displays a certificate referred to in para. (3) that is invalid.
- (5) For enquiry of passenger service licence fees, you may enquire at Hong Kong Licensing Office, obtain TD341 containing various licence fee or visit Transport Department's website (<http://www.td.gov.hk>).
- (6) If the Commissioner has reason to believe that (a) the vehicle for which a passenger service licence has been issued or is being used otherwise than for the purpose of the service authorized by the licence; or (b) any condition of the licence or any provision of the relevant legislation has not been or is not being complied with, he may, after conducting an enquiry—
 - (a) suspend or cancel the passenger service licence;
 - (b) suspend or cancel the passenger service licence in respect of particular vehicles; or
 - (c) vary the passenger service licence in respect of—
 - (i) routes;
 - (ii) approved purposes;
 - (iii) the number of vehicle included in the licence.
- (7) Where a passenger service licence is cancelled, suspended, varied or amended, the licence shall, upon such cancellation, suspension, variation or amendment coming into effect, deliver the licence to the Commissioner within 72 hours who shall cancel, hold or amend the licence as the circumstances require.
- (8) The operator should be in accordance with the details specified in the Schedules of Service approved by the Commissioner for Transport.
- (9) The holder of the passenger service licence for public light bus (scheduled) service is required to advise the Commissioner of his involvement in any legal proceedings in connection with the scheduled service.
- (10) Other conditions will be specified at the letter offering the service/licence to the successful applicant.

B. COMPLETION OF FORMS

- (1) All relevant items of the form should be completed by an applicant in **BLOCK LETTERS**. Incomplete or insufficient information may render the application unacceptable for consideration or may result in the applicant being required to attend interviews for clarification.

Part A

- (2) The applicant will be responsible to the Transport Department for the satisfactory operation of the routes granted.
- (3) If the applicant is in partnership or intends or enter into partnership with one or more persons for the purpose of operating the services to which the application for specific public light bus (scheduled) service relates, then it is recommended that the partnership to be registered as a business in accordance with the provisions of the Business Registration Ordinance (Cap. 310).
- (4) In the case of a limited company, the name and address of the registered office of the company should be given.

Part C

- (5) This part of the form is on the particulars of the public light buses available for the operation of the routes applied for. The Transport Department will seek assurance that each registered owner nominated in Part C is willing to accept that the applicant *alone* will be responsible to the Transport Department for the satisfactory operation of any route granted. As an indication of his/her willingness, each registered owner must sign his/her name in the space provided.
- (6) Any passenger service licence held by the registered owners of the public light bus fleet should be stated.
- (7) Vehicles registered under the passenger service licence for public light bus (scheduled) service will be deleted from any other passenger service licence.

Part F

- (8) In the case of a limited company, the declaration should be signed by the managing director or company secretary.

C. SUBMISSION OF APPLICATIONS

All completed applications should be submitted either in person or by registered post to Public Vehicles Section of Transport Department at 3/F., United Centre, 95 Queensway, Hong Kong. The application form must be accompanied by all supporting documents as indicated in Part F below.

D. AMENDMENTS

The Commissioner for Transport should be notified of any change in particulars immediately.

E. WARNING

- (1) Applicants are reminded that it is an offence under the Prevention of Bribery Ordinance (Cap. 201) for any person to offer an advantage to a Government Servant. In the case of a Government Servant or any person representing to be his agent seeking or soliciting advantage from an applicant he should immediately report to the Independent Commission Against Corruption (Tel. 2526 6366).
- (2) Applicants are also reminded that if they knowingly make any statement which is false in material particular for the purpose of obtaining the grant of the public light bus (scheduled) service licence, they will not only render their applications null and void but will also render themselves liable to prosecution under Section 111(3) of the Road Traffic Ordinance (Cap. 374) on conviction to a fine of \$5,000 and to imprisonment for 6 months.

F. SUPPORTING DOCUMENTS

The following documents should be forwarded at the time of submission of the application form:—

- (1) Hong Kong Identity Card (certified true copy only);
(*the copy of the identity card attached with the application submitted by registered post will be destroyed after processing the application*)
- (2) Valid Business Registration Certificate (certified true copy only);
- (3) Certificate of Incorporation in the case of a limited company (certified true copy only);
- (4) Memorandum and Articles of Association where applicable;
- (5) Documentary evidence to show that maintenance and service facilities are provided by appointed garage/motor car company for the proposed public light bus(es); and
- (6) Other relevant documents/information in support of application not mentioned above.
