道路交通（駕駛執照）規例第一附表 - 疾病及傷殘情況

DISEASES AND PHYSICAL DISABILITIES—THE FIRST SCHEDULE TO THE ROAD TRAFFIC (DRIVING LICENCES) REGULATIONS

- (一) 癲癇症。
 - (二) 高血壓或任何其他因由，以致有可能突然暈眩或昏倒以致失去能力。
 - (三) 精神紊亂，以致執照申請人或持有人 [視屬何情況而定] 有可能根據《精神健康條例》 [第 136 章] 被羈留或以住院病人身分在該條例所指的精神病院接受治療。
 - (四) 任何導致肌肉不受控制的狀況。
 - (五) 未受控制的糖尿病。
 - (六) 不能在白天充足光線下讀出與他相距 23 米的登記號碼（有需要者在配戴眼鏡或其他矯正視力鏡片作為協助，仍不能讀出）。
 - (七) 任何其他疾病或傷殘，而該疾病或傷殘很可能令申請人或持有人沒有能力在不危及公眾安全的情況下，有效地駕駛或控制該執照所指的汽車或經適當改裝的汽車；但失聰本身並不當作上述的傷殘。
- (1) Epilepsy.
 - (2) Liability to sudden attacks of disabling giddiness or fainting due to hypertension or any other cause.
 - (3) Mental disorder for which the applicant for the licence, or, as the case may be, the holder of the licence is liable to be detained under the Mental Health Ordinance (Cap.136) or is receiving treatment as an in-patient in a mental hospital within the meaning of that Ordinance.
 - (4) Any condition causing muscular incoordination.
 - (5) Uncontrolled diabetes mellitus.
 - (6) Inability to read at a distance of 23 metres in good daylight (with the aid of spectacles or other corrective lenses, if worn) a registration mark.
 - (7) Any other disease or disability which is likely to render him incapable of effectively driving and controlling a motor vehicle or suitably adapted motor vehicle to which such licence refers with endangering public safety, provided that deafness shall not of itself be deemed to be any such disability.
