申請司機接載行動不便的殘疾人士泊車證明書

Application for Parking Certificate for Drivers Who Carry People with Mobility Disabilities

申請人在填寫申請表格 TD544 (Rev.02/21) 前,請細閱以下內容:

Applicant should read carefully the following content before filling in the Application Form TD544 (Rev.02/21).

申請資格 Eligibility:

- 1. 申請人所接載的乘客必須經由合資格人士確認為下肢肢體傷殘行動不便的殘疾人士(以下簡稱「行動不便的殘疾人士」); The passenger to be carried by the applicant must be a person with lower limb mobility disabilities (hereinafter referred to as "person with mobility disabilities") certified by qualified professional(s);
- 2. 申請人或其接載行動不便的殘疾人士,必須擁有以其本人姓名登記的車輛(車身高度須低於運輸署轄下停車場的高度限制);
 The applicant or the person with mobility disabilities must own a vehicle (the height of the vehicle must not exceed the headroom of government carparks which are managed by Transport Department);
- 3. 如多於一位申請人申請接載同一位行動不便的殘疾人士,在申請獲批准後,本署只會發出一張可機接載行動不便的殘疾人士泊車證明書(以下簡稱「泊車證明書」)。日後任何人士若就接載同一位行動不便的殘疾人士遞交新的申請書,其車輛登記號碼將視乎申請審批結果加註在同一張泊車證明書上,本署會於審批完成後通知申請人有關結果,申請人亦須於新泊車證明書批出前,將原先發出的泊車證明書,以郵寄方式交還至九龍油麻地海庭道 11 號西九龍波府合署南座 11 樓運輸署殘疾人士運輸組主建輸出的企業。

Each person with mobility disabilities may support more than one application from different applicants, however, only ONE Parking Certificate for Drivers Who Carry People with Mobility Disabilities (hereinafter referred to as "the Parking Certificate") will be issued if the applications are approved by this Department. Subject to the result of application, the vehicle registration mark(s) of subsequent application(s) in respect of the same person with mobility disabilities will be added onto the same Parking Certificate issued. This Department will notify the applicant(s) of the result(s) of application and the applicant(s) or the person with mobility disabilities will be required to first surrender the Parking Certificate previously issued by post to the Disabled Transport Section, Transport Department, 11/F, South Tower, West Kowloon Government Offices, 11 Hoi Ting Road, Yau Ma Tei, Kowloon for cancellation before a new parking certificate can be issued.

- 4. 泊車證明書的有效期會視乎註冊醫生或註冊物理治療師簽發的"證明書文件"而定,但每次申請所批出的有效期最長為三年。
 Validity of the Parking Certificate depends on the "Mobility Disability Certification" issued by registered doctor or registered physiotherapist, but the validity period will not exceed 3 years for each application.
- 5. 本署批出的泊車證明書將不會獲自動續期,申請人需在泊車證明書屆滿前兩個月將填妥的申請表格 TD544 (Rev.02/21)及有關的證明文件呈交本署辦理續期申請。

The Parking Certificate issued by this Department will not be renewed automatically. Completed Application Form TD544 (Rev.02/21) for renewal application should be submitted together with relevant supporting documents to this Department 2 months before expiry of the Parking Certificate.

申請方法 Application:

- 2. 申請人須提交詳列於申請表格 TD544 (Rev.02/21)第四部份內的所有證明文件。如未能提供所需的資料,有關申請將不獲受理。如申請獲批准,本署會將泊車證明書及申請人提交的所有證明文件以平郵方式寄回申請人。

All required supporting documents as specified in Part Four of the Application Form TD544 (Rev.02/21) must be submitted. Your application will not be considered if you fail to provide all the information as requested. If the application is approved, the Parking Certificate and all supporting documents submitted by the applicant will be returned to the applicant by surface mail.

使用泊車證明書的規限 Restrictions on the use of the Parking Certificate:

1. 泊車證明書不可轉讓。

The Parking Certificate is not transferable.

2. 泊車證明書持證人在接載下肢肢體傷殘行動不便的殘疾人士時,可使用路旁殘疾人專用泊位及運輸署轄下的政府多層停車場的特定泊車位。持證人駕駛有關申請車輛進入及/或離開泊位時,車上必須載有申請表格上所列明的行動不便的殘疾人士。

When the holder of the Parking Certificate is carrying a person with lower limb mobility disabilities, he/she may park his/her vehicle at the on-street parking spaces for the disabled and the designated parking spaces inside government multi-storey carpark managed by Transport Department. When the Parking Certificate holder drives the vehicle under application in and/or out of the parking spaces, the person with lower limb mobility disability to be carried as stated in the Application Form should be on board.

3. 泊車證明書持有人**並不**獲給予殘疾司機可享有的各項優惠。此泊車證明書**不適用**於在限制區上落,並只供持有人使用路旁殘疾人專用泊位及運輸署轄下政府多層停車場的特定泊車位泊車。

The Parking Certificate holder <u>is not</u> conferred with concessions which are given to drivers with disabilities. The Parking Certificate is <u>NOT</u> applicable to picking up and setting down passengers at restricted zones, it only permits the holder to park his/her vehicle at the on-street parking spaces for the disabled and the designated parking spaces inside government multi-storey carparks managed by Transport Department.

4. 如發現持證人濫用泊車證明書,運輸署保留取消該泊車證明書之權利。

Transport Department reserves the right to cancel the Parking Certificate from the driver if he/she abuses the use of the Parking Certificate.

Purposes of Collection

1. 運輸署會把透過本表格所獲得的個人資料作下列用途:
