- 1. I declare that to the best of my knowledge, the information given above and supporting document(s) provided are complete and true. I understand that if I knowingly make any statement which is false in a material particular, I shall render myself liable to prosecution under Section 111(3) of the Road Traffic Ordinance (Cap.374) and on conviction to a fine of HK\$5,000 and to imprisonment for six months.

- 4. I understand that since the HZMB Main Bridge is located within the Mainland waters,
 - (a) the Mainland Laws will apply according to the territoriality principle, and the Mainland government authorities will require basic information of the relevant vehicles and drivers for Filing Records and issue of electronic temporary vehicle and driving licences. I hereby consent to the transfer of vehicle and personal particulars kept in TD's records (as set out under item 16 of "Notes for Attention") by the TD to the Mainland government authorities for Filing Records; and
 - (b) as required by the Mainland government authorities, the vehicle permitted under this closed road permit is not allowed to carry any dangerous goods listed in the List of Dangerous Goods of national standards.

At the same time, upon the request of the Mainland government authorities, I hereby declare the following:

I have self-learned the Mainland laws and regulations on road traffic safety, including Law of the People's Republic of China on Road Traffic Safety, the Provisions on Administration of Motor Vehicles and Drivers of Temporary Entry (Order No. 90, Ministry of Public Security, the People's Republic of China), the Provisions on the Application for and Use of Driving Licenses (Order No. 139, Ministry of Public Security, the People's Republic of China);
 - 3. I shall provide the voucher of the "Mainland compulsory traffic accident liability insurance for motor vehicles" with a validity of no less than the temporary entry period.
- 2. I shall comply with the following requirements during the temporary entry period:
 - 1. I shall comply with the Mainland laws, regulations and rules on road traffic safety;
 - 2. I shall drive according to the areas and routes permitted as specified on the temporary vehicle licence;
 - 3. Upon interception by traffic police, I shall stop the vehicle and produce the entry/ exit permit and the temporary driving licence for inspection;
 - 4. In case I am in violation of laws and regulations on road traffic safety, I shall accept the disposition of the case by the Vehicle Control Offices of Mainland Public Security authorities according to law, and I am willing to receive messages on illegal acts via mobile phone short message service or email;
 - 5. When a traffic accident takes place, I shall speedily report to the traffic police on duty or to the Vehicle Control Offices of Mainland Public Security authorities, and I shall accept the disposition of the case by the Vehicle Control Offices of Mainland Public Security authorities according to law;
 - 6. The above presents my true situations and my genuine intention. I shall be held legally liable if I make an untrue declaration.

Notes for Attention

- 1. Since the Hong Kong-Zhuhai-Macao Bridge ("HZMB") Main Bridge is located within the Mainland waters, all cross-boundary vehicles using the HZMB will travel through the Mainland. It is the requirement of the Mainland government authorities that all cross-boundary vehicles travelling via the HZMB to Macao must provide the Mainland government authorities in advance the information of vehicles and drivers for Filing Records and issue of electronic temporary vehicle and driving licences.
- 2. To facilitate the Hong Kong cross-boundary private car applicants, the Transport Department ("TD") will co-ordinate the applications for Hong Kong and Macao licences and permits, and the Filing Records formalities of the Mainland government authorities. The TD will pass the information of applicants, vehicles and drivers to the Macao and the Mainland government authorities for completion of the requisite procedures as requested by the respective governments. For the information to be transferred, please refer to item 16. Without the approval from the Mainland government authorities, the applicants will not be permitted to drive to Macao via the HZMB even if they have completed the formalities as required by the governments of Macao and Hong Kong.
- 3. Before submitting the CRP application, applicants are required to visit the Mainland online filing platform (website: http://bridge.zhjj.org.cn:9080) to learn the Mainland laws and regulations on road traffic safety, including Law of the People's Republic of China on Road Traffic Safety, the Provisions on Administration of Motor Vehicles and Drivers of Temporary Entry (Order No. 90, Ministry of Public Security, the People's Republic of China), the Provisions on the Application for and Use of Driving Licenses (Order No. 139, Ministry of Public Security, the People's Republic of China).
- 4. According to Regulation 12 of Provisions on the Application for and Use of Driving Licenses (Order No. 139, Ministry of Public Security, the People's Republic of China), the applicants for the People's Republic of China Motor Vehicle Driving Licence must be aged over 18 and under 70. (As agreed by the three Governments, it is not applicable to the designated drivers who have already obtained the People's Republic of China Motor Vehicle Driving Licence.)
- 5. Incomplete applications will not be processed. For details, please refer to the "Application Guide for the Hong Kong-Zhuhai-Macao Bridge Macao Port Park-and-Ride Scheme" ("Application Guide").
- 6. For submission of applications, an applicant may make use of online services to submit the application, or log on to GovHK (website: www.gov.hk/macaopnr) to make an appointment free of charge and then submit the application in person or through an agent to the Cross Boundary Unit of the TD (address: Room 501, 5/F, Harbour Building, 38 Pier Road, Central, Hong Kong) during the appointed time slot.

 8. An annual fee of HK\$540 for a Closed Road Permit ("CRP") under application is payable at the time of application. If the validity period of the CRP under application is shorter than 1 year, the applicant should notify the TD in writing when submitting the application, and a monthly fee of HK\$45 will be payable. Any part of a month will be counted as one month. The application, together with a crossed cheque (payable to: "The Government of the Hong Kong Special Administrative Proceedings of the HCCAP") and the Hong Kong Special Administrative Procedure (Color HCCAP).
- Region" or the "The Government of the HKSAR") can be sent to the Cross Boundary Unit of the TD or delivered to the drop-in box at the Cross Boundary Unit (address: Room 1032, 10/F, Harbour Building, 38 Pier Road, Central, Hong Kong). For online applications, payments can be made by PPS or credit cards. <u>Unless the application is rejected, the fee is not refundable under any other circumstances</u>. The TD does not guarantee that the applicant who has been issued with a CRP can reserve a car parking space at the Macao Car Park. No refund will be given if the CRP issued is subsequently forgone or cannot be used due to failure of reserving a car parking space or completing the requisite procedure of the respective government authorities.
- 9. The three government authorities take about 12 working days for processing an application. For submission by post or through drop-in box, an extra two to three working days will be required. Moreover, it should be noted that the office hours and holidays of the Governments of the three places are different, and in particular as a result of suspension of office operation during long holidays, it may take longer time to complete the application procedures and relevant formalities. Applicants should allow ample time to submit the application so that the permit could be issued before the intended permit start date. Otherwise, applicant may run risk of permit to be issued after the intended permit start date.
- 10. Once the application for CRP is submitted, the applicant cannot withdraw or amend any vehicles and drivers related particulars (e.g. addition, cancellation or change of the designated driver(s); change of vehicle (even using the same vehicle registration mark); or change of the vehicle registration mark); otherwise the applicant is required to submit a new application, and the relevant fees paid would not be refunded. CRP issued for a specific vehicle is not transferable either.
- 11. As required by the Governments of the Mainland, Hong Kong and Macao, all applications will be assessed on the basis of the information on the applicants, drivers and vehicles provided at the time of application. The CRP issued will become invalid if there is any change in such information after an application has been approved and the relevant approved documents (including the CRP issued by the Transport Department and the approval confirmation email issued by the Macao Transport Bureau) have been issued. The relevant government authorities of the three places may refuse to let the vehicle travel to Macao via the HZMB.
- 12. For application for **duplicate** CRP, please tick the box on the top part of Page 1 and fill in Part II, Part III and Part IV. The fee payable is HK\$86. Besides, the loss report issued by the Police or the damaged CRP has to be attached. Applications for duplicate CRP can only be made at the Cross Boundary Unit of the TD.
- 13. Applications will be assessed in accordance with the terms and conditions as detailed in the Application Guide. The TD will also take into account the following vetting criteria when handling applications from applicants and drivers:
 - i. For applicants who have used the cross-boundary private cars to engage in illegal or unauthorised activities, such as goods smuggling, transporting illegal immigrants, illegal operation, and illegal carriage of prohibited, restricted or undeclared items which should be subject to quarantine inspection, the Governments of Hong Kong and Macao may

- refuse to accept any new applications from the applicants;
- ii. For applicants who have been involved in obtaining licences or permits for private cars entering Macao by improper means such as deception, the Governments of Hong Kong and Macao may refuse to accept any new applications from the applicants for 3 years from the day following the date of conviction;
- iii. For applicants who have been involved in traffic incidents or traffic offences in Macao or Hong Kong, the Governments of Hong Kong and Macao may cancel the licences and permits for the vehicles pending the conclusion of the cases or relevant legal proceedings;
- iv. For applicants whose private cars have been involved in overstay at or non-departure from Macao without justified reasons, the Government of Macao may cancel the licences or permits for the vehicles entering Macao for 3 years from the day following the date of departure from Macao. If the licences or permits for the vehicles entering Macao are cancelled, the TD of Hong Kong may refuse to accept the corresponding applications for CRPs;
- v. For applicants whose private cars have travelled beyond the boundary of the permitted access area, violated the access conditions or been driven by a person other than the designated driver(s), the Governments of Hong Kong and Macao may refuse to accept any new applications from the applicants for 1 year from the day following the date of departure from Macao.

Apart from refusal to accept new applications, if the validity period stated in the confirmation email from the Macao Transport Bureau has expired or the approval number issued by the Macao Transport Bureau in respect of the vehicle concerned becomes invalid, the approval notice and the CRP issued by the TD in respect of the same vehicle will be rendered invalid concurrently. Applications may also not be accepted under certain circumstances. These include, but are not limited to, the following situations:

- i. The applicant fails to provide relevant supporting documents.
- ii. The driving licence is invalid.
- iii. The driver is subject to a traffic-related outstanding arrest warrant or court order.
- iv. The vehicle does not have a valid vehicle licence.
- v. The vehicle has a valid Hong Kong hire car permit.
- vi. There is an outstanding inspection order on the vehicle concerned.

Notes from the Macao Special Administrative Region Government to Applicants

- 1. After the issue of a CRP and before departure of the vehicle to Macao, the applicant must ensure that mandatory civil liability insurance has been taken out in accordance with the laws of Macao.
- 2. Drivers and passengers visiting Macao via the HZMB under the Hong Kong-Zhuhai-Macao Bridge Macao Port Park-and-Ride Scheme ("the Scheme") must park their private cars at the East Car Park of the Frontier Post at the Macao Port and complete the clearance procedures before interchanging with public transport to travel to the city of Macao.
- 3. Designated drivers approved to drive the Hong Kong private cars to Macao via the HZMB under the Scheme must be the holders of valid Hong Kong full driving licences with private car entitlement.
- 4. According to the laws of Macao, the vehicle specifications should be consistent with that on the registration documents. If the Law Enforcement Agencies of Macao are doubtful about the specifications of Hong Kong private cars entering Macao, they may request the private car concerned to be inspected at vehicle inspection centres in Macao. If the concerned vehicle refuses to be inspected, the Macao Transport Bureau will cancel its qualification of reserving a parking space at the East Car Park of the HZMB Frontier Post at Macao Port immediately and handle the case in accordance with relevant law requirements.
- 6. According to the laws of Macao, only registered vehicles are allowed to be driven on the roads of Macao. If the validity period stated in the confirmation email has expired, the vehicle concerned in Macao will be regarded as unregistered and hence, not permitted to be driven on the roads of Macao. The vehicle concerned may need to be moved back to the HZMB by trailers, after which it will be passed to the relevant Hong Kong parties by the HZMB Authority or other parties consented by the registered owner of the concerned vehicle.

I shall comply with the following requirements during the temporary entry period: (a) I shall comply with the Mainland laws, regulations and rules on road traffic safety; (b) I shall drive according to the areas and routes permitted as specified on the temporary vehicle licence; (c) Upon interception by traffic police, I shall stop the vehicle and produce the entry/exit permit and the temporary driving licence for inspection; (d) In case I am in violation of laws and regulations on road traffic safety, I shall accept the disposition of the case by the Vehicle Control Offices of Mainland Public Security authorities according to law, and I am willing to receive messages on illegal acts via mobile phone short message service or email; (e) When a traffic accident takes place, I shall speedily report to the traffic police on duty or to the Vehicle Control Offices of Mainland Public Security authorities, and I shall accept the disposition of the case by the Vehicle Control Offices of Mainland Public Security authorities according to law; (f) The above presents my true situations and my genuine intention. I shall be held legally liable if I make an untrue declaration.
