It is the requirement of the Mainland authorities that all cross-boundary vehicles travelling via the HZMB to Macao must file with the Mainland authorities in advance the information of vehicles and drivers. I hereby confirm that the filing of records as required by the Mainland authorities has been completed when the cross-boundary vehicles use the HZMB.
