<p>2. 根據《簡易程序治罪條例》(第 228 章) 第 4A 條，任何人無合法權限或解釋而陳列或留下，或導致陳列或留下任何物品或東西，而這些物品或東西對在公眾地方的人或車輛造成阻礙、不便或危害者，或可能對在公眾地方的人或車輛造成阻礙、不便或危害者，可處罰款\$25,000 或監禁 3 個月。</p> <p>當局可檢控停放單車以致造成阻礙的人士。</p> <p>In accordance with Section 4A of the Summary Offences Ordinance, Cap. 228, any person who without lawful authority or excuse sets out or leaves, or causes to be set out or left, any matter or thing which obstructs, inconveniences or endangers, or may obstruct, inconvenience or endanger, any person or vehicle in a public place shall be liable to a fine of \$25,000 or to imprisonment for 3 months.</p> <p>The Authority may prosecute the person who parked the bicycle causing obstruction.</p>
