### **Traffic Advice**

# Temporary Traffic and Transport Arrangements in Ngau Pei Sha Street, Sha Tin

Motorists are advised that to facilitate the modification works of traffic signal system, the following temporary traffic and transport arrangements will be implemented from 8.00 am to 12.00 noon on 11 February 2018:

### a) Lane closure

- (i) Some traffic lanes of Ngau Pei Sha Street near its junction of Chui Yan Street will be closed:
- (ii) One traffic lane of Yuen Shun Circuit southbound near its junction of Ngau Pei Sha Street will be closed;
- (iii) One traffic lane of Chui Yan Street northbound near its junction of Ngau Pei Sha Street will be closed;

### b) Banning of Turning Movements for all Vehicles

- (i) All vehicles will be prohibited from turning right from Ngau Pei Sha Street westbound to Yuen Shun Circuit eastbound;
- (ii) All vehicles will be prohibited from turning right from Ngau Pei Sha Street eastbound to Chui Yan Street southbound;
- (iii) All vehicles will be prohibited from turning right from Yuen Shun Circuit southbound to Ngau Pei Sha Street westbound, or going straight from Yuen Shun Circuit southbound to Chui Yan Street southbound; and
- (iv) All vehicles will be prohibited from turning right from Chui Yan Street northbound to Ngau Pei Sha Street eastbound, or going straight from Chui Yan Street northbound to Yuen Shun Circuit northbound.

#### c) Traffic Diversions

- (i) Vehicles on Ngau Pei Sha Street westbound heading for Yuen Shun Circuit eastbound will be diverted via Chap Wai Kon Street northbound, Siu Lek Yuen Road eastbound, Sha Tin Wai Road southbound and Ngau Pei Sha Street westbound;
- (ii) Vehicles on Ngau Pei Sha Street eastbound heading for Chui Yan Street southbound will be diverted via Yuen Shun Circuit and Ngau Pei Sha Street westbound;
- (iii) Vehicles on Yuen Shun Circuit southbound heading for Ngau Pei Sha Street westbound or Chui Yan Street southbound will be diverted via Ngau Pei Sha Street eastbound, Yuen On Street and Yuen Shun Circuit.
- (iv) Vehicles on Chui Yan Street northbound heading for Ngau Pei Sha Street eastbound or Yuen Shun Circuit northbound will be diverted via Ngau Pei Sha Street westbound, Chap Wai Kon Street southbound, U-turn and Chap Wai Kon Street northbound.

# d) Temporary Transport Arrangements

During the above period, KMB route nos. 73A, 80K, Cross Harbour route no. 182, LWB route no. A41 and GMB route no. 811 on their journey to Yu Chui Court will be diverted via Yuen Shun Circuit and Ngau Pei Sha Street westbound before terminating at Yu Chui Court Public Transport Interchange.

Appropriate traffic signs will be erected on site to guide motorists. Public transport operators will display notices to advise passengers of the above temporary transport arrangements.
