

## Traffic Advice

### Service Adjustments of KMB Routes No. 80M, 85 and 88X

Members of the public are advised that the services of KMB Routes No. 80M (Sui Wo Court – Kowloon Tong Station), No. 85 (Fo Tan (Shan Mei Street) – Kowloon City Ferry) and No. 88X (Fo Tan Chun Yeung Estate – Ping Tin) will be adjusted with effect from 18 February 2024 (Sunday). Details are as follows:

#### **1. Route No. 80M (Sui Wo Court – Kowloon Tong Station)**

KMB Route No. 80M will be adjusted to peak only service on weekdays, with details as follows:

#### **2. Route No. 85 (Fo Tan Chun Yeung Estate – Kowloon City Ferry)**

The terminal point of KMB Route No. 85 will be extended from Shan Mei Street to Chun Yeung Estate, with details as follows:
