

## TRANSPORT DEPARTMENT NOTICE

### **Temporary Traffic and Transport Arrangements on Wu King Road, Tuen Mun**

Notice is hereby given that the following temporary traffic and transport arrangements will be implemented from 0.01 am to 5.00 am on 1, 5, 7 and 9 May 2026 to facilitate the erection of footbridge segment:

**(I) Road Closure**

Wu King Road will be temporarily closed to all vehicular traffic.

**(II) Traffic Diversion**

- (a) Vehicles on Wu Shan Road westbound heading for Wu King Road southbound will be diverted via Wu Shan Road westbound, Lung Mun Road southbound and Wu Chui Road eastbound;
- (b) Vehicles on Wu Shan Road eastbound heading for Wu King Road southbound will be diverted via Wu Shan Road eastbound, Wu Shan Road southbound and Wu Chui Road westbound;
- (c) Vehicles on Hoi Wong Road southbound heading for Wu King Road southbound will be diverted via Wu Shan Road westbound, Lung Mun Road southbound and Wu Chui Road eastbound, or diverted via Wu Shan Road eastbound, Wu Shan Road southbound and Wu Chui Road westbound;
- (d) Vehicles on Wu Chui Road westbound heading for Wu King Road northbound will be diverted via Wu Chui Road westbound, Lung Mun Road northbound and Wu Shan Road eastbound; and
- (e) Vehicles on Wu Chui Road eastbound heading for Wu King Road northbound will be diverted via Wu Chui Road eastbound, Wu Shan Road northbound and Wu Shan Road westbound.

**(III) Public Transport Arrangements**

The following temporary transport arrangements will be implemented during the affected period:
