^{Note2}If the public bus(es) is/are registered on or after 1 May 2009, the bus(es) should be in compliance with the safer seat requirement as stipulated under Regulation 73(1AA) of the Road Traffic (Construction and Maintenance of Vehicles) Regulations, Cap. 374A, and should pass the vehicle examination conducted by the Vehicle Examination Centre of Transport Department. Otherwise, the bus(es) would not be granted with the A03 endorsement.

Notes for Attention:

Transport Department will assess each application in accordance to the above criteria and inform the applicant in writing of the details of bus(es) approved to be granted with A03 endorsement. Applicant should bring the approval letter, together with all the documents listed in the letter, to PVU within the specified period to complete the formalities. If the bus(es) is/are first issued with Passenger Service Licence Certificate(s) (non-scheduled), a fee of \$160 (per year per vehicle) will be charged.
