Basic Function includes recording and storing the following data during at least the latest 30 days :

- (i) time and date; (ii) actual speed of the vehicle at intervals not exceeding 1 second; (iii) harsh acceleration / deceleration records;
- (iv) vehicle over-speeding record (with actual speed exceeding a pre-determined speed value);
- (v) the incident record showing the last 20 seconds before its actual stop with speed, headlamp/direction indicator and brake status;
- (vi) system record (including power status, data retrieval, setting changes, system fault).
