# Motorcycle/Motor tricycle Part B Test (Mandatory Competence Test) Notes on Driving Test Result

#### 1. For Candidate Who Passed Part B Test

Please apply for a learner's driving licence as well as appointment for Part C road test from this Department after 4 working days (but not exceeding 2 years) from the date of passing your Part B test. You may approach a designated driving school for enrolment and arrangement for the application for a learner's driving licence and road test appointment. If you would like to take the Part C road test at the Government Driving Test Centres, please approach one of the following Licensing Offices of this Department with the necessary documents listed below for application:

If you wish to submit your application in person/by agent over the counter at Licensing Office, you may make counter service in advance either online an appointment for via GovHK's website (https://www.gov.hk/en/residents/transport/drivinglicense/abs.htm) or by calling the 24-hour Interactive Voice Response System of the Appointment Booking Service at 3763 8080 to reduce waiting time. If no prior appointment has been made, applicants are required to obtain a same-day queue ticket on-site before using the counter services for applications in relation to driving licence and driving test. Candidates may also submit the application together with the necessary documents listed below by post to "Kowloon Licensing Office, Transport Department, 2/F, Cheung Sha Wan Government Offices, 303 Cheung Sha Wan Road, Kowloon" and mark "Application for Driving Test (TD82) and Learner's Driving Licence (TD555)" on the envelope.

Required documents for the application are as follows:

- 1. Hong Kong Identity Card or a valid identity document (original or photocopy); and
- Duly completed application form for learner's driving licence (TD555); and
   Duly completed Application for a Driving Test (Private Car, Light Goods Vehicle, Motor Cycle and Motor
- 3. Tricycle) (TD 82) (if applicable); and
- 4. Original or photocopy of present address proof (residential address and correspondence address) issued within the last 3 months (e.g. utility or telecommunication bills, correspondence from banks, insurance companies, government departments, local universities, local or international charitable organizations etc.); and
- 5. The required fee for the issuance of a learner's driving licence; and

6. Medical Examination Certificate (TD 256) duly completed by a registered medical practitioner (applicable to applicants aged 70 or above).

Applicants who would like to apply for a driving licence online must possess an "iAM Smart+" account with digital signing function or a valid personal digital certificate for the application. Please refer to GovHK's website at https://www.gov.hk/en/residents/transport/drivinglicense/onlineservices.htm.

For licence application or renewal, applicants are required to provide either a Hong Kong Mobile Phone Number or Email Address that is frequently used, which they can be contacted through SMS or Email, as the E-Contact Means (ECM). Applicants shall verify the said ECM by One-time Password (OTP) so that the application can be processed. This Department shall refuse to issue a learner's driving licence and arrange a Part C test in respect of a motorcycle or motor tricycle if the applicant has not made the applications within 2 years after passing the Part B test. In such cases, the applicants have to retake and pass the Part B test again.

#### 2. For Candidate Who Failed the Test

If you wish to re-take your driving test, please approach your relevant designated driving school for re-enrolment and arrangement of test appointment.

### 3. Result of Driving Test

The result of your driving test as shown on the copy of test form is subject to final verification by this Department. Should an amendment of the verdict be found necessary in the course of verification, the candidate will receive by post a notice to this effect and he/she will be invited to our office for the purpose of updating the test result.
