Private Car, Light Goods Vehicle, Motorcycle/Motor tricycle Road Test Notes on Driving Test Result

1. For Candidates Who Have Passed the Driving Test

Successful candidates are required to apply to the Transport Department for the issue of driving licence, or for addition of the relevant driving entitlement(s) as the case may be, after 4 working days (but not exceeding 3 years) from the date of passing the driving test. For application over the counter at licensing offices, via drop-in boxes or by post, the following documents are required:

- 1. Hong Kong Identity Card or a valid identity document (original or photocopy); and
- 2. Original or photocopy of present address proof (residential address and correspondence address) issued within the last 3 months (e.g. utility or telecommunication bills, correspondence from banks, government departments, local or international charitable organizations etc.); and
- 3. The duly completed Application for Full Driving Licence (TD 557) / Application for Probationary Driving Licence (TD 590)* as appropriate; and
- 4. The required fee for the issue of a driving licence/probationary driving licence (not applicable for driving entitlement endorsement); and
- 5. Medical examination report form (TD 256) duly completed by a registered medical practitioner (applicable to applicant aged 70 or above).

Applicants who would like to apply for a driving licence online must possess an "iAM Smart+" account with digital signing function or a valid personal digital certificate for the application. Please refer to GovHK's website at https://www.gov.hk/en/residents/transport/drivinglicense/onlineservices.htm.

For licence application or renewal, applicants are required to provide either a Hong Kong Mobile Phone Number or Email Address that is frequently used, which they can be contacted through SMS or Email, as the E-Contact Means (ECM). Applicants shall verify the said ECM by One-time Password (OTP) so that the application can be processed. According to the Road Traffic (Driving Licences) Regulations (Cap. 374B), any candidate who applies for the issue of a driving licence after 3 years from the date that he/she passed his/her test will not be entertained by this Department.

* Application for Probationary Driving Licence (TD 590) is made in accordance with the Road Traffic (Driving Licences) Regulation (Cap. 374B), any person who applies to take a driving test for motor cycle, motor tricycle, private car or light goods vehicle is only eligible to apply for a probationary driving licence upon passing the driving test. A probationary driving licence holder can apply for a full driving licence for the respective class after completion of a mandatory probationary driving period.

2. For Candidates Who Have Failed the Test

If you wish to re-take your driving test, you may make an application 4 working days after the date of your test through the following ways. The result of the test part you have passed will be retained and you will only need to take another test on the remaining part of your driving test. Please refer to the test form (TD 553):

- Online booking for Private Car/Light Goods Vehicle/Motorcycle Driving Test by visiting the GovHK website (http://www.gov.hk/en/residents/transport/drivinglicense/roadtest.htm). Candidates may apply for an end-of-list driving test appointment or a repeater early test appointment. (Note: Applicant of end-of-list driving test appointment must possess a valid personal digital certificate issued by recognised Certification Authorities or 'iAM SMART' account with digital signing for authentication; and a credit card (Visa, MasterCard, UnionPay or JCB) or a PPS account number and Internet password for online payment.) - Alternatively, you may submit your application together with the necessary documents by post to "Kowloon Licensing Office, Transport Department, 2/F, Cheung Sha Wan Government Offices, 303 Cheung Sha Wan Road, Kowloon" and mark "Application for a Driving Test (TD 82)" on the envelope. Please note that this department will not accept underpaid mail items, which will be returned to the sender (with return address) or disposed of (without return address) by the Hongkong Post. For proper delivery of their mail items to the department, and to avoid unnecessary delivery delay or unsuccessful delivery, applicants should ensure their mail items bear sufficient postage with return address before posting.
- Necessary documents for application for driving test:
 - 1. Original or copy of Hong Kong Permanent Identity Card / Hong Kong Identity Card / an alternative identity document previously registered in the Transport Department; and
 - 2. The duly completed Application for a Driving Test (Private Car, Light Goods Vehicle, Motor Cycle and Motor Tricycle) (TD 82); and
 - 3. Original or copy of the proof of present address (residential address and correspondence address) issued within the last 3 months (e.g. utility or telecommunication bills, correspondence from banks, government departments etc.); and
 - 4. The required fee for the purchase of the relevant driving test form (for application by post, please pay by crossed cheque or cashier order, payable to "The Government of the Hong Kong Special Administrative Region", do not send in cash); and
 - 5. Medical Examination Certificate (TD 256) duly completed by a registered medical practitioner (applicable to applicants aged 70 or above).

<u>Unsuccessful candidates</u> of motor tricycle Part C Test can contact the Driving Test Appointment Office 4 working days after the date of the test for enquiries on application to re-take the test.
