 - C1 車輛在進口香港供銷售前,曾在香港以外地方登記。根據相關證明文件,車輛在香港以外地方登 記的時間少於15天。

 - A prior to importation into Hong Kong for sale, the vehicle has either never been registered outside Hong Kong, or was registered outside Hong Kong but in a manner that the vehicle was not permitted to be used on roads, with documentary

- B prior to importation into Hong Kong for sale, the vehicle has never been registered outside Hong Kong as declared
- C1 the vehicle has been registered outside Hong Kong prior to importation to Hong Kong for sale. The length of the period of such registration is shorter than 15 days as proved by supporting documents
- C2 the vehicle has been registered outside Hong Kong prior to importation to Hong Kong for sale, other than vehicles
