# **Verification of E-contact Means**

In accordance with the law, applicants must provide either a Hong Kong mobile phone number through which they can be contacted by an SMS message or an email address through which they can be contacted by an electronic mail as the e-contact means when submitting driving / vehicle licensing or relevant vehicle permit applications. The e-contact means must be verified by one time password through the online licensing services or designated online platform of the Transport Department within three months before submitting an application. # Signature and Chop on Vehicle Registration Document (VRD)

The VRD <u>has to</u> contain signature of the registered vehicle owner, and the signature on the application form should match with that on the VRD when a relevant licensing application is submitted by the registered vehicle owner concerned. If the vehicle is owned by a company/organization, the VRD <u>has to contain</u> the signature of an authorized representative together with a company/organization chop and the chop on the application form <u>must be identical</u> with that on the VRD otherwise this department will **not** process the licensing application VRD, otherwise this department will **not** process the licensing application.

# Requirement of Address Proof

The original or a copy of the proof of address issued within the last three months <u>has to</u> be produced when submitting a licensing application. In accordance with the relevant legislation, the Transport Department may suspend processing the application in the absence of address proof. # Change of Address or E-contact Means

According to the law, driving licence holders or registered vehicle owners or relevant vehicle permit holders have to notify the Transport Department within 72 hours of their change of address or econtact means. Any person without reasonable excuse contravenes such requirement commits an offence and is liable on conviction to a fine at level 1.
