

# Important Notice

## Verification of E-contact Means

In accordance with the law, applicants must provide either a Hong Kong mobile phone number through which they can be contacted by an SMS message or an email address through which they can be contacted by an electronic mail as the e-contact means when submitting driving / vehicle licensing or relevant vehicle permit applications. The e-contact means must be verified by one time password through the online licensing services or designated online platform of the Transport Department within three months before submitting an application. For details, please refer to [the website of the Transport Department](#) or scan this QR code.

## Signature and Chop on Vehicle Registration Document (VRD)

The VRD **has to** contain signature of the registered vehicle owner, and the signature on the application form should match with that on the VRD when a relevant licensing application is submitted by the registered vehicle owner concerned. If the vehicle is owned by a company/organization, the VRD **has to contain** the signature of an authorized representative together with a company/organization chop and the chop on the application form **must be identical** with that on the VRD, otherwise this department will **not** process the licensing application.

## Requirement of Address Proof

The original or a copy of the proof of address issued within the last three months **has to** be produced when submitting a licensing application. In accordance with the relevant legislation, the Transport Department may suspend processing the application in the absence of address proof. [\[Please refer to the list of acceptable proof of address\]](#)

## Change of Address or E-contact Means

According to the law, driving licence holders or registered vehicle owners or relevant vehicle permit holders have to notify the Transport Department within 72 hours of their change of address or e-contact means. Any person without reasonable excuse contravenes such requirement commits an offence and is liable on conviction to a fine at level 1. You may notify the Transport Department of change in address with your proof of new address (if applicable) through [GovHK](#), by submitting [the specified form](#) ("Change of Personal Particulars or Vehicle Particulars") or in writing.

## Mail Items with Insufficient Postage

For proper delivery of your mail items to this department, and to avoid unnecessary delivery delay or unsuccessful delivery, please ensure your mail items bear sufficient postage before posting [\[Please note the latest details about postage rates by Hongkong Post\]](#). This department will not receive any underpaid mail items. Any underpaid mail items will be handled by the Hongkong Post, which actions including but not limited to levying a surcharge on the sender for mail item that bears a sender's address.

## Submission of Identity Document

For application submitted by post/ via drop-in box, please **do not** submit the **original** identity document.

*Applicant may choose to provide his completed application form and relevant documents to Licensing Office (LO) via email (hklo\_mpclassicar@td.gov.hk) for preliminary vetting. Under normal circumstances, TD will provide a reply through email within 10 working days informing the applicant of the result of preliminary vetting; and advise the applicant to formally submit the original application form together with supporting documents and prescribed fee to an LO through the submission means mentioned in the application form. TD will only conduct preliminary vetting on applications submitted by email, and such applications will only be formally processed and approved after receiving the original application and supporting documents from applicant.*

- (一) 申請人須為使用行駛許可證的車輛的車主。  
(二) 申請的車輛必須最少有二十年車齡，而且行駛的目的只是由一個場地往另一個場地，及只是參加由香港老爺車會或其他認可的組織籌辦／參與的活動。  
(三) 許可證不能轉讓，而許可證費用亦不能退還。  
(四) 行駛許可證授權有關的車輛在許可證的 12 個月有效期內最多在路上行駛 12 天；如須行駛更多次數，則必須領取一個新的許可證。  
(1) The applicant should be the owner of the vehicle to which a movement permit is sought.  
(2) The vehicle under application must be at least 20 years old. It should only be driven for the purposes of proceeding from one site to another and for joining the events organized/participated by the Classic Car Club or other approved organizations.  
(3) The permit is non-transferable and the permit fee is non-refundable.  
(4) The movement permit authorises the vehicle to be driven on the road for a maximum of 12 days during the 12-month validity period of the permit. A fresh permit must be obtained if more trips are required.

行駛條件 CONDITIONS OF OPERATION

- (一) 使用行駛許可證的車輛在路上行駛時，必須遵守香港法例第 374 章道路交通 (車輛登記及領牌) 規例第 53 條的法例規定及許可證的條件。  
(二) 行程的日期須由運輸署在許可證上批簽。申請人須事先向運輸署香港牌照事務處申請批簽。  
(三) 車輛在路上行駛時，除該車輛通常運載的設備、零件或燃料外，不得運載其他負載物。  
(四) 車輛的司機必須是該類別車輛的有效駕駛執照持有人。  
(五) 車輛必須裝載緊急警告標誌，在發生故障時一定要加以使用。而遇有故障情況必須立即通知警方。  
(六) 許可證必須展示在車頭擋風玻璃的左面，使別人能在車輛前面清楚看到。  
(七) 許可證如遭註銷，必須歸還運輸署署長。  
(八) 如違反許可證的條件，可能遭取消許可證並處第 1 級罰款。  
(九) 許可證持有人如駕駛該車輛進入有管理機關或擁有人限制車輛進出的任何地方或私家路之前必須取得該管理機關或擁有人的預先批准。  
(1) When the vehicle to which a movement permit relates is being moved on a road, it must comply with the statutory requirements of Regulation 53 of the Road Traffic (Registration and Licensing of Vehicles) Regulations, Cap. 374 and the conditions of permit.  
(2) Dates of the trips are to be endorsed by the Transport Department in the permit. Applicants should apply in advance to the Transport Department, Hong Kong Licensing Office for endorsement.  
(3) When the vehicle is being moved on a road, no load is allowed to be carried on the vehicle other than such equipment, spares or fuel normally carried on the vehicle.  
(4) The driver of the vehicle must be a holder of valid driving licence for that class of vehicle.  
(5) Emergency warning signs must be carried and used in the event of a breakdown and the Police should be immediately informed of the situation.  
(6) The permit shall be displayed on the left hand side of the front windscreen of the vehicle in such a manner that it is clearly visible from the front of the vehicle.  
(7) The permit must be returned to the Commissioner for Transport in the case of cancellation.  
(8) Contravention of any permit conditions may render the permit liable to cancellation and a fine at level 1.  
(9) The permit holder shall seek the approval from the relevant authority prior to driving the vehicle in any area or private road of which the management authority or owner may restrict the access of the vehicle.

(2) 如任何老爺車行駛許可證持有人曾向運輸署署長提供其姓名、地址、電子聯絡方式或身分證明文件有所改變，他／她須在改變出現後 72 小時內以書面通知運輸署署長，並須提交有關改變的證明。任何人無合理辯解而違反此規定，即屬犯罪，可處第 1 級罰款。如屬姓名或名稱的改變或地址的改變，他／她亦須將現時持有的老爺車行駛許可證的正本送交運輸署署長，以作修改；  
(3) 運輸署署長在處理牌照申請時，可要求申請人出示其地址證明 (例如水／電／煤氣費單和銀行信件等)，以及可在申請人出示該等證明之前，**暫停處理該申請**。因此，請申請人士帶同其距今不超過三個月的地址證明，並在牌照事務處人員要求下，出示其地址證明。如申請人先前曾提供其住址和通訊地址給運輸署，請同時提供住址和通訊地址的證明；  
(4) 運輸署署長可要求給予改變通知的駕駛執照持有人／登記車主，在要求當日起計 14 日內提供有關改變的證明。任何人無合理辯解而違反此規定，即屬犯罪，可處第 1 級罰款。如屬姓名的改變或身分證明文件的改變，駕駛執照持有人／登記車主亦須將現有的駕駛執照正本 (如持有)、車輛登記文件正本 (如持有) 及／或駕駛教師執照正本 (如持有) 送交運輸署署長；

(1) **E-Contact Means** — Applicants must provide either a Hong Kong mobile phone number through which they can be contacted by an SMS message or an email address through which they can be contacted by an electronic mail as the e-contact means when submitting driving / vehicle licensing or relevant vehicle permit applications. The e-contact means must be verified through the website of the Transport Department within three months before submitting an application, otherwise the processing of the application may be suspended. For details, please refer to the website of the Transport Department (www.td.gov.hk). If both Hong Kong mobile phone number and email address are provided, the Hong Kong mobile phone number would be given priority as the means for issuing electronic notification. Please refer to the "Notes About Your Personal Data" for the purposes of collecting e-contact means and the class of transferees. In particular, the Transport Department, Hong Kong Police Force, other Government departments, bureaux and Toll Service Provider may issue electronic notification to you through the e-contact means provided by you, either by SMS or email, as and when necessary. For instance, an Electronic Fixed Penalty Notice and Electronic Demand Notice may be issued by the Hong Kong Police Force to you through the e-contact means if you commit a traffic contravention under the Fixed Penalty (Traffic Contraventions) Ordinance (Cap. 237) or traffic offence under the Fixed Penalty (Criminal Proceedings) Ordinance (Cap. 240); a toll payment notification may be issued by the Toll Service Provider to you through the e-contact means when the toll cannot be successfully paid by automated payment means where your vehicle passes through a tunnel implemented with Free-Flow Tolling System. Please note that non-counter application takes about 10 working days for processing. The relevant systems would update your record according to the information provided in this form within one calendar day upon complete processing of the application;  
(2) If a change occurs in the **name, address, e-contact means or identity document** of a movement permit for classic car holder previously provided to the Commissioner for Transport, he or she shall, within 72 hours of the change, notify the Commissioner for Transport in writing with the proof of the change. Any person who without reasonable excuse contravenes such requirement commits an offence and is liable to a fine at level 1. For cases of change of name or change of address, he or she shall also deliver to the Commissioner for Transport the original copy of the movement permit for classic car for amendment, if applicable;  
(3) The Commissioner for Transport may, in processing licensing application, require the applicant to **produce proof of his/her address** (e.g. water/electricity/gas bill and bank correspondence), and may **suspend the processing of the application** until the production of such proof. Therefore, applicants please bring along with address proof issued not more than 3 months from now for presentation as and when requested by officers of licensing office. Please provide the **proof of both residential and correspondence addresses** if the applicant had provided the two addresses to Transport Department.



- (4) The Commissioner for Transport may require a driving licence holder/registered owner who has given to the Commissioner for Transport a notification of change of particulars to produce proof of the change within 14 days from the day on which the requirement is made. Any person who without reasonable excuse contravenes such requirement commits an offence and is liable to a fine at level 1. For cases of change of name or change of identity document, the driving licence holder/registered owner shall also deliver to the Commissioner for Transport the existing original driving licence (if applicable), original vehicle registration document (if applicable), and/or original driving instructor's licence (if applicable);
- (5) If the address and/ or e-contact means provided in this application form is/ are different from the vehicle/driving licence records of the applicant under the same identity document no./ Certificate of Incorporation no./ Company Registration no. held by this Department, we will update all relevant information in our records accordingly, including the e-contact means provided in accordance with the Road Traffic (Registration and Licensing of Vehicles) Regulations (Cap. 374E) and the Road Traffic (Driving Licences) Regulations (Cap. 374B) as well as the address contained in the "Record of driving licences and permits" stipulated under regulation 39 of Road Traffic (Driving Licences) Regulations (Cap. 374B) and "Register of vehicles" stipulated under regulation 4 of Road Traffic (Registration and Licensing of Vehicles) Regulations (Cap. 374E);

  - maintenance of a record of particulars of driving licences under regulation 39 of the Road Traffic (Driving Licences) Regulations; *(applicable to driving licence-related applications only)*
  - activities relating to traffic and transport matters;
  - handling enforcement matters including but not limited to issuance of Electronic Fixed Penalty Notice, Electronic Demand Notice and Notice Requiring Identification of Driver under sections 15 & 15AA of Fixed Penalty (Traffic Contraventions) Ordinance (Cap. 237), sections 3 & 3AA of Fixed Penalty (Criminal Proceedings) Ordinance (Cap. 240) and sections 63 & 63A of Road Traffic Ordinance (Cap. 374);
  - facilitating communication with you in relation to the matters in paragraphs (a) to (e) above; and
