- (1) 運輸署已於二零一九年一月二日起實施經修訂的「首次登記時的車輛狀況」,各分類的描述如下:
  - A 根據相關文件,車輛在進口香港供銷售前,未曾在香港以外地方登記,或曾在香港以外地方登記但有關登記不准許車輛在道路上使用。
  - B 基於車輛進口者的聲明,車輛在進口香港供銷售前,未曾在香港以外地方登記。
  - Cl 車輛在進口香港供銷售前,曾在香港以外地方登記。根據相關證明文件,車輛在香港以外地方登記的時間少於15天。
  - C2 車輛在進口香港供銷售前,曾在香港以外地方登記,並不歸類為C1狀況。

其他 - 車輛由登記車主進口香港自用,或在香港以進口底盤或進口駕駛室及底盤添加指明附加物裝配而成,或透過拍賣從香港特別行政區政府購得。

運輸署重申,經修訂的「車輛狀況」旨在如實地描述首次登記車輛在進口香港前的情况,而非描述或反映車輛使用情況或損耗程度。

 The Transport Department has implemented the Revised First Registration Vehicle Status with effect from 02.01.2019. Descriptions of respective "vehicle status" are as follows:-

A – prior to importation into Hong Kong for sale, the vehicle has either never been registered outside Hong Kong, or was registered outside Hong Kong but in a manner that the vehicle was not permitted to be used on roads, with documentary proof.

- B-prior to importation into Hong Kong for sale, the vehicle has never been registered outside Hong Kong as declared by the vehicle importer.
- C1 the vehicle has been registered outside Hong Kong prior to importation to Hong Kong for sale.

  The length of the period of such registration is shorter than 15 days as proved by supporting documents.
- $\mathrm{C2}$  the vehicle has been registered outside Hong Kong prior to importation to Hong Kong for sale, other than vehicles categorised as  $\mathrm{C1}$ .

Others – the vehicle was imported by the registered owner into Hong Kong for own use, or was assembled in Hong Kong with specified additions to the imported chassis / cab and chassis, or was acquired through auction from the Hong Kong SAR Government.

The Transport Department wishes to reiterate that the revised "vehicle status" serves with the purpose to provide factual description on the vehicles upon first registration prior to importation to Hong Kong but does not indicate nor imply the condition of use of the vehicle or its level of wear-and-tear.
