 - (2) Commodities and services included in the CPI are classified into nine sections, viz. transport, food, housing, electricity, gas and water, alcoholic drinks and tobacco, clothing and footwear, durable goods, miscellaneous goods and miscellaneous services.
 - (3) Under the impact of COVID-19, retail business of some industries was disrupted (e.g. suspension of outbound tours) in individual months from 2020 onwards. Figures of affected groups are thus not available as reliable price data could not be collected.
