- Note 1: If the applicant only applies for the renewal of the ICP, renewal application form for CRP for Cross-Boundary Vehicles (TD547) is not required.
- Note 2: The application for ICP can only be submitted at least three days after the expiry of the current ICP.
- Note 3: The Electronic Mainland Approval Notice shall reflect the application type applicants would like to apply. If applicants' Electronic Mainland Approval Notice does not reflect the respective application type in New Issue, Change in Vehicles and Change of Company Name, please approach Guangdong Provincial Public Security Department to apply past Mainland Approval Notice (i.e. 往期批文) before applying Closed Road Permit.

Applicants may take reference of the common application type as below:

- Note 4: With effect from October 1, 2025, applicants of ICP are required to provide the policy proof of the Hong Kong third party liability insurance which is valid when the ICP takes effect.
- Note 5: For information on the address proof accepted by this Department, please refer to [https://www.td.gov.hk/tc/public\\_services/licences\\_and\\_permits/proof\\_of\\_address/index.html](https://www.td.gov.hk/tc/public_services/licences_and_permits/proof_of_address/index.html) . If there is any change in the permit holder's address, please notify the Cross Boundary Unit of this Department (address: Room 1032, 10/F, Harbour Building, 38 Pier Road, Central, Hong Kong ) of change in address with your proof of new address in writing as soon as possible.
- Note 6: If the applicant uses the address of another Hong Kong resident or a Hong Kong-registered company, the applicant must submit the original authorization letter permitting the use of the relevant Hong Kong address (signed by the Hong Kong address holder/ signed and stamped with the company chop by the proprietor or director of the Hong Kong-registered company), together with a copy of the address holder's identity document or a copy of the valid Business Registration Certificate of the Hong Kong-registered company.
- Note 7: Mainland Enterprises Private Cars entering Hong Kong for the first time or Mainland Official/Enterprises Private Cars aged 6 years or above are required to conduct vehicle examination at a designated Car Testing Centre in Hong Kong. Upon submitting required documents of CRP and ICP, permits with shorter validity and a "Notice of Vehicle Inspection for Mainland Vehicles" (「內地車輛進行車輛檢驗通知書」) would be issued. Applicants are required to complete vehicle examination procedures within the validity period of permits. After completing the vehicle inspection procedures, the applicant must bring along the " Motor Vehicle Certificate of Roadworthiness", "TD547 and TD54A Application Forms" and a copy of Hong Kong motor vehicle third party risk

insurance certificate (if the original insurance certificate has expired) to apply for CRP and ICP with a longer validity period.

Note 8: If the applicant has lost or damaged the valid CRP or ICP (“the Permit”), they may apply for a duplicate permit. The applicant shall use “TD54A” or “TD547” application forms to apply for a duplicate ICP or CRP respectively. The applicant must apply in person at the Cross Boundary Unit of the Transport Department (Room 1032, 10th Floor, Harbour Government Building, 38 Pier Road, Central, Hong Kong) with either a police loss report or the damaged permit. The fee for a duplicate Closed Road Permit is HK\$86.
