Note 1: In case of the existing Closed Road Permits having expired over 6 months, the application should be regarded as a new application.

Note 2: The company chop, authorized directors' or authorized persons' signatures stated in the application form shall be same as the records stored in Cross Boundary Unit, Transport Department.

Note 3: The Electronic Mainland Approval Notice shall reflect the application type applicants would like to apply. If applicants' Electronic Mainland Approval Notice does not reflect the respective application type in New Issue, Change in Vehicles and Change of Company Name, please approach Guangdong Provincial Public Security Department to apply past Mainland Approval Notice (i.e. 往期批文) before applying Closed Road Permit.

Applicants may take reference of the common application types as below

Note 4: Hong Kong Business Registration Certificate shall bear a machine-printed line showing the date of payment and the amount paid.

Note 5: This is only applicable if the applicant is not the registered owner of the private car.

Note 6: The vehicle should possess with valid Hong Kong vehicle licence when apply for and upon issue of Closed Road Permit.

Note 7: Drivers shall be the registered drivers in Mainland Approval Notice and Hong Kong Residents/ Foreign Passport Holders.

Note 8: If the driver is an imported worker who enters the Hong Kong Special Administrative Region for employment under the Enhanced Supplementary Labour Scheme, he or she must provide an approval-in-principle letter issued by the Labour Department.

Note 9: If applicants would like to provide new specimen signature, they shall duly complete “Application for Closed Road Permit for Cross-boundary Vehicles – Specimen Signature of Applicant” (which is attached in the last page of TD547D application form) and signed by the applicant or owners/directors. If the applicant is unlimited company/limited company/overseas company, please provide certified Extract of Information on the Business Register within one year issued by the Inland Revenue Department OR certified copy of the latest Company Particular Search results within the last year provided by the Company Registry OR the latest Annual Return within one year (certified by the Company Registry or a Hong Kong Certified Public Accountant or solicitor) OR certified copy of Director List of overseas company (certified by a Hong Kong Certified Public Accountant or solicitor), to verify whether existing specimen signatures are still valid. If the authorized person in our record has resigned, please provide the above document as early as possible for updating the record.

Note 10: If the Closed Road Permit is lost or damaged, applicants shall apply a duplicate copy of Closed Road Permit by duly completing TD547 application form, with an original copy of Reporting Loss Memo from the Police or return of damaged Closed Road Permit. The fee is \$86 Hong Kong dollars.
