## 簡化申請文件

- 為提升向公眾提供的牌照服務，並為車主提供更多便利，運輸署自2024年12月30日起同步簡化車輛牌照申請文件。
- 車主申請車輛牌照時將
  - 無需出示車輛登記文件（俗稱「牌簿」）。
  - 驗車合格後，無需出示車輛宜於道路上使用證明書（俗稱「驗車紙」）。
  - 經網上提交申請，只要成功於網上核實第三者風險保險記錄，即無需上載保險單。

## 行車證不再載有屆滿日期及無須替換

- 優化車輛牌照不再載有牌照屆滿日期，其他於車輛牌照上載列的資訊將維持不變。
- 車主在獲發不再載有屆滿日期的車輛牌照後，仍需每年為牌照續期。
- 如牌照上顯示的車輛資料（如車牌號碼、顏色等）不變，車主在每次續牌後可沿用同一張而無需更換貼在車頭的車輛牌照。

## 網上查詢牌照屆滿日期

- 運輸署會向成功續領車輛牌照的車主發出「車輛發牌通知書」。
- 發出「車輛發牌通知書」代表車輛牌照已成功續領，上面載有該車輛的最新牌照期。
- 優化車輛牌照上方會新設一個二維碼。車主掃描該二維碼，無須登記便可於運輸署的車輛牌照網上查詢平台即時查閱牌照的屆滿日期。

## Simplify supporting documents

- To enhance the licensing services provided to the public, and to provide greater convenience to vehicle owners, the application documents for vehicle licence application is simplified from 30 December 2024 onwards.
- When applying for vehicle licence, vehicle owners are
  - No longer required to present the Vehicle Registration Document.
  - No longer required to present the Certificate of Roadworthiness after passing vehicle examination.
  - When submitting application online, once the third party risks insurance record is verified online, there is no need to upload the policy of insurance.

## Vehicle licence without expiry date printed and no replacement required

- The enhanced vehicle licence no longer bears a printed expiry date, while other information printed on the vehicle licence remains unchanged.
- After receiving the vehicle licence without the expiry date printed thereon, vehicle owners are still required to renew the licence annually.
- If the vehicle particulars printed on the licence (e.g. registration mark, body color, etc.) remain unchanged, vehicle owner can continue to use the same vehicle licence after each subsequent renewal, and there is no need to replace the vehicle licence displayed on the windscreen of the vehicle.

## Enquire licence expiry date online

- The Transport Department will issue a Vehicle Licensing Notice (“VLN”) to vehicle owners who have successfully renewed their vehicle licence.
- The issuance of VLN means the licence is successfully renewed and the licensed period of the vehicle will be shown on the VLN.
- A new QR code is printed at the top of the enhanced vehicle licence, for vehicle owner to scan and access the TD’s Vehicle Licence Online Enquiry Platform for instantly checking it’s latest expiry date without pre-registration.
