A driving licence cannot be renewed after 3 years of expiry Driver needs to take driving test again

The validity of the 10-year full driving licences issued since 1997 are expiring. According to the law, a driving licence shall not be renewed after 3 years of expiry. Should a driving licence holder fail to renew his full driving licence within 3 years after the expiry date, he will need to take driving test again and to complete the probationary driving period before obtaining a full driving licence for private car, light goods vehicle, motor cycle or motor tricycle. Furthermore, the licence holder will only be eligible for applying for commercial driving licence 2 years after obtaining his full driving licence of private car or light goods vehicle.

To remind driving licence holders to renew their licences in time, the Transport Department will send them a "Full Driving Licence Renewal Notice cum Application Form" (TD578) printed with a



renewal password before the expiry of the licences. Another reminder will be sent to licence holders whose licences are about to expire for three years shortly and yet to be renewed.

Driving licence can be renewed within 4 months before the expiry date or within 3 years after the licence has expired. Driving licence holders with expired driving licences are not allowed to drive.

By Post

Please send the completed application form and the required documents by post to P.O. Box 68115, Kowloon East Post Office.



By Drop Box

You may also put the completed application form and the required documents in the drop

boxes located at the Transport Department Licensing Offices or designated post offices (No postage is needed).

If renewal is made by post/drop box, the new driving licence will be issued to the applicant via registered post within 10 working days upon receipt of application by the Transport Department.

Online Renewal

Applicants with a unique password printed on the "Full Driving Licence Renewal Notice cum Application Form" or a valid digital certificate issued by recognized Certification Authorities may apply for renewal of driving THE CALL STREET licence by logging on http:// www.gov.hk/drivinglicence (Not applicable for applicants aged 70 or above). Upon receipt of application, the Transport Department will send a new driving licence to the applicant within 10 working days via registered post.

applicants are advised to make use of our advanced booking system as far as possible.



Renewal at Licensing Offices

Please log on http://www.gov.hk/tdabs or call the Transport Department Appointment Booking Service (Tel: 3763 8080) to make an appointment to renew driving licences at any licensing office. Applicants may renew their licences at the designated licensing offices in accordance with their bookings with the completed application forms and required documents. Applicants who have not made any advanced booking are required to queue for applications over the counter. Hence,



Change of Address

Licence holders are obliged to notify the Transport Department of any address change. Holders may notify the Transport Department the new address online (http:// www.gov.hk/changeaddress) or by completing Form TD559. The form can be obtained online (http://www. td.gov.hk), at post offices and the Transport Department Licensing Offices. Please return the completed form to the Transport Department by post, through drop box or in person/by agent at any licensing office. Applicants are required to produce address proof issued within the last 3 months (e.g. water/electricity/gas/mobile phone bill or bank correspondence) when applying for renewal of full driving licence and change of address. Transport Department may suspend the processing of the applications until the address proof is produced.
