Subject : Agreement for Management, Operation and Maintenance of Eastern Harbour Crossing

Description : The successful tenderer will be required to undertake the following duties:

- (a) management and operation of the tunnel, including:
 - (i) taking enforcement actions under the applicable ordinances and regulations;
 - (ii) collection of tolls, approved fees and charges;
 - (iii) regulation of traffic;
 - (iv) patrolling and security of the tunnel area;
 - (v) handling incidents occurred within the tunnel area;
 - (vi) recovery and removal of broken down vehicles; and
 - (vii) cleansing of the tunnel;
- (b) operation and maintenance of the electrical and mechanical equipment and electronic systems of the tunnel, including but not limited to:
 - (i) power supply system;
 - (ii) lighting system;
 - (iii) ventilation system;
 - (iv) toll collection system;
 - (v) traffic control and surveillance system; and
 - (vi) cathodic protection system;
- (c) providing non-structural maintenance and repairing works for the upkeep of the tunnel;
- (d) providing landscape services and tree management for the horticulture and vegetation within the tunnel area;
- (e) provision, installation, operation and maintenance of automatic toll collection system; and
- (f) selection and appointment of advertising agent(s) for displaying advertisements at approved locations within the tunnel area.

The duration of the agreement shall be six (6) years commencing on 7 August 2019.

Late tenders or tenders not deposited in the Government Secretariat Tender Box will not be accepted. Submission of Tenders/Applications : Tenders must be clearly marked with the tender reference and the subject of the tender on the outside of the envelope (but should not bear any indication which may relate the tender to the tenderer) addressed to the Chairman, Central Tender Board, and placed in the Government Secretariat Tender Box situated at the Lobby of the Public Entrance on the Ground Floor of East Wing of Central Government Offices, 2 Tim Mei Avenue, Tamar, Hong Kong before 12.00 noon on Friday, 12 April 2019
