Subject: Parking Survey (Off-Street Facilities) 2027 and 2028

Description: The service mainly includes:

- (i) To conduct various types of parking surveys on off-street parking facilities throughout the territory of the Hong Kong Special Administrative Region during year 2027 and 2028; and
- (ii) To conduct analyses on the data collected through the surveys, and compile survey reports.

The service is expected to commence in January/February 2027 and will take about 29 months to complete.

Submission of Tenders: For paper-based tendering, tenders must be sealed and clearly marked with the tender reference and the subject of the tender on the outside of the envelope (but should not bear any indication which may relate the tender to the tenderer) addressed to the Chairman, Tender Opening Committee of the Government Logistics Department, and

placed in the Government Logistics Department Tender Box situated on the Ground Floor, North Point Government Offices, 333 Java Road, North Point, Hong Kong. Tenders must be deposited in the tender box as specified in this tender notice (“Specified Tender Box”) before the tender closing time. Late tenders and tenders not deposited in the Specified Tender Box will not be accepted.

For electronic tendering, the tender should be submitted in accordance with the requirements specified in the tender documents, the terms and conditions of use and participation of the ETB (<https://pcms2.gld.gov.hk>). Transmission of a tender through the ETB shall be completed before the tender closing time.

In case Tropical Cyclone Warning Signal No. 8 or above is hoisted, or Black Rainstorm Warning Signal or “extreme conditions” announced by the Government is/are in force, for any duration between 9:00 a.m. and 12:00 noon (Hong Kong Time) on the tender closing date, the tender closing time will be postponed to 12:00 noon on the first working day after the Tropical Cyclone Warning Signal No.8 is lowered, or the Black Rainstorm Warning Signal or the “extreme conditions” announced by the Government has/have ceased to be in force.

In case of blockage of the public access to the location of the Specified Tender Box at any time between 9:00 a.m. and 12:00 noon (Hong Kong Time) on the tender closing date, the Government will announce extension of the tender closing time until further notice. Following removal of the blockage, the Government will announce the extended tender closing time as soon as practicable. The above announcements will be made via press releases on the website on Information Services Department (<http://www.info.gov.hk/gia/general/today.htm>).

Remarks: This tender is covered by the Agreement on Government Procurement of the World Trade Organization (“WTO GPA”) and will not involve electronic auction. This notice also serves as a summary notice required under WPO GPA.

Open tendering is adopted. All interested contractors/suppliers/service providers are invited to tender.

The Government of the Hong Kong Special Administrative Region does not bind itself to accept the lowest offer or tender with the highest combined score or any tender, and reserves the right to negotiate with any tenderer about the terms of the offer.
