Description :	<p>The contract comprises three parts:</p> <p>(1) design, supply, delivery, installation, testing and commissioning of about 660 traffic detectors, new journey time indicators at 19 locations, 1 set of enhanced speed map panel, and associated power supply system, data communication system, computer server, and civil, structural, electrical and electronic works;</p> <p>(2) integration of the existing journey time indication and speed map panel systems into the new systems; and</p> <p>(3) 6-year operation and maintenance services of the completed systems.</p> <p>The contract is scheduled to commence in March 2019 and will take about 104 months to complete.</p>

Tenders must be deposited in the tender box as specified in this tender notice ("Specified Tender Box") before the tender closing time. Late tenders and tenders not deposited in the Specified Tender Box will not be accepted.</p> <p>If a black rainstorm warning signal or tropical cyclone warning signal No. 8 or above is in effect at any time between 9:00 a.m. and 12:00 noon on 7 December 2018 (Friday), the tender closing time will be postponed to 12:00 noon on the first working day after the black rainstorm warning signal has ceased to be in effect or the tropical cyclone</p>

All interested contractors who meet the following requirement are invited to tender:-</p> <p><i>The tenderer, or the major shareholder or lead participant in case of a joint venture tenderer, has completed at least one construction contract involving design, supply and installation of either Traffic Detector System (TDS) or Traffic Control and Surveillance System (TCSS) at roads, tunnels or viaducts, with awarded values of the TDS or TCSS not less than HK\$25 million, in or outside Hong Kong, within the past 15 years (counting back from and including the original date set for the close of tender).</i></p> <p>The detailed requirements on the tenderer's qualification are stipulated in the tender documents.</p> <p>b. This tender is covered by the Agreement on Government Procurement of the World Trade Organization and will not involve electronic auction.</p> <p>c. A charge will be levied for delivery of tender documents where the delivery of tender documents is requested by a tenderer. A written request must be made.</p> <p>d. The Government of the Hong Kong Special Administrative Region does not bind itself to accept any tender irrespective of whether the tender is the lowest bid or where the assessment of tenders is based on a marking scheme or formula approach, the tender has the highest overall score.</p> <p>e. The Government of the Hong Kong Special Administrative Region reserves the right to negotiate with any tenderer about the terms of the offer.</p>
