Subject : Contract for Provision of Fee Collection Services for New Generation of Parking Meter System through the Faster Payment System (“FPS”) in Hong Kong

Description : The successful tenderer will be required to undertake the following major duties:

- (a) to collaborate with the Procurement cum Management, Operation and Maintenance (“PMOM”) contractor and provide all necessary information and assistance to facilitate the PMOM Contractor to collect parking fees via the Faster Payment System (“FPS”);
- (b) to provide FPS services for collection of parking fees round the clock; to deposit the amount of all parking fees collected directly to the PMOM contractor’s bank accounts; and
- (c) to generate FPS statement daily to the PMOM contractor for its reconciliation and follow-up actions on any problem identified.

The duration of the contract shall be five (5) years commencing on a date the Government of the Hong Kong Special Administrative Region shall specify by notice.

Remarks : The Government of the Hong Kong Special Administrative Region does not bind itself to accept the lowest tender or any tender, and reserves the right to negotiate with any tenderer about the terms of the offer.
