Subject : Procurement cum Management, Operation and Maintenance of Real-time Arrival Information System for Green Minibus

Description : The successful tenderer will be required to undertake procurement, management, operation and maintenance of real-time arrival information system for green minibus (GMB), including the following duties:

- (a) Install and maintain location detection device setup on each of the GMBs for detecting its real-time location and other relevant real-time data;
- (b) Provide and maintain wireless communication services for collecting real-time data from location detection device;
- (c) Develop and maintain central computer system for receiving the real-time data, computer processing and generating real-time arrival information of GMBs for dissemination via TD's mobile application 'HKeMobility' and 'data.gov.hk', and necessary data storage; and
- (d) Develop and maintain an 'online management portal' to facilitate the management of GMBs.

The duration of the contract shall be seven (7) years and six (6) months commencing on a date the Government of the Hong Kong Special Administrative Region shall specify by notice.

Late tenders or tenders not deposited in the Government Secretariat Tender Box ('Specified Tender Box') will not be accepted. If tropical cyclone warning signal No.8 or above is hoisted, or a black rainstorm warning signal or 'extreme conditions after super typhoons' announced by the Government is/are in force at any time between 9.00 a.m. and 12.00 noon (Hong Kong time) on 17 July 2020 (Friday), the tender closing time will be postponed to 12.00 noon (Hong Kong time) on the first working day after the tropical cyclone warning signal No.8 is lowered, or the black rainstorm warning signal or the 'extreme conditions after super typhoons' announced by the Government has/have ceased to be in force. In case of blockage of the public access to the location of the Specified Tender Box at any time between 9.00 a.m. and 12.00 noon (Hong Kong time) on 17 July 2020 (Friday), the Government will announce extension of the tender closing time until further notice. Following removal of the blockage, the Government will announce the extended tender closing time as soon as practicable. Submission of Tenders: Tenders must be clearly marked with the tender reference and the subject of the tender on the outside of the envelope (but should not bear any indication which may relate the tender to the tenderer) addressed to the Chairman, Central Tender Board, and placed in the Specified Tender Box situated at the Lobby of the Public Entrance on the Ground Floor of East Wing of Central Government Offices, 2 Tim Mei Avenue, Tamar, Hong Kong **before 12:00 noon on Friday, 17 July 2020** (Hong Kong time).
