I understand that, if at anytime after the Closed Road Permit is issued, I apply for reclassification of the said vehicle (e.g. from goods vehicle to private car), the Closed Road Permit shall be rendered invalid after reclassification. I undertake to surrender the Closed Road Permit to your office for cancellation immediately after any application for reclassification is approved by Transport Department.

由於港珠澳大橋的主橋（“大橋”）位於內地水域，所有使用大橋的跨境車輛，均須經過內地境內。因應內地當局要求，行經大橋往澳門的過境車輛須提供車輛及司機資料予內地當局作備案用途。本人確保過境車輛於行走大橋時已完成內地當局要求的備案手續。

As the Main Bridge of the HZMB is located within the Mainland waters, all cross-boundary vehicles using the HZMB will travel through the Mainland. It is the requirement of the Mainland authorities that all cross-boundary vehicles travelling via the HZMB to Macao must file with the Mainland authorities in advance the information of vehicles and drivers. I hereby confirm that the filing of records as required by the Mainland authorities has been completed when the cross-boundary vehicles use the HZMB.

Appointment should be made for the vehicle examination before applying for the Closed Road Permit for the first time.

The first issued Closed Road Permit and International Circulation Permit are temporary permits. The permits are valid only on the day on which the goods vehicle will undergo vehicle examination in Hong Kong.
- 貨車車主/申請人獲簽發臨時短期封閉道路通行許可證及國際通行許可證時，會獲編配以特定英文字母(ZP)為前綴的香港車輛登記號碼。車主/申請人須按獲編配的香港車輛登記號碼，自行訂做符合香港法例要求的車輛字牌。車主/申請人宜預留足夠時間辦理以上手續。  
A Hong Kong vehicle registration mark with "ZP" as the prefix will be assigned to the goods vehicle when applying for the temporary Closed Road Permit and International Circulation Permit. Vehicle owner / applicant should customise the vehicle registration mark display of the Hong Kong vehicle registration mark assigned according to the Hong Kong legal requirement. Vehicle owner / applicant shall reserve sufficient time for the above procedure.
- 貨車獲發可在大嶼山道路使用的車輛牌照後，申請人可遞交已填妥的 TD547 表格，向過境服務分組申請為期可長達 12 個月的封閉道路通行許可證。貨車須繼續沿用申領臨時短期封閉道路通行許可證及國際通行許可證時獲編配以特定英文字母(ZP)為前綴的香港車輛登記號碼。  
After obtaining the vehicle licence (applicable to the roads of Lantau), applicant may submit the completed TD547 to the Cross Boundary Unity to apply for the Closed Road Permit of which the validity period can be 12 months. The goods vehicle should use the Hong Kong vehicle registration mark with "ZP" as the prefix assigned when applying for the temporary Closed Road Permit and International Circulation Permit.
