#### 申请人须知

#### NOTICE TO APPLICANT

1. **注意：**任何人以欺骗手段取得财物，属犯罪行为。根据《盗窃罪条例》(第 210 章) 第 17 条，违法者一经定罪，最高可处监禁 10 年。

**Caution :** It is an offence to obtain property by deception. Any person committing the offence is liable on conviction to maximum imprisonment for 10 years under section 17 of the Theft Ordinance, Cap. 210.

2. 根据《简易程序治罪条例》(第 228 章) 第 4A 条，任何人无合法权限或解释而陈列或留下，或导致陈列或留下任何物品或东西，而这些物品或东西对在公众地方的人或车辆造成阻碍、不便或危害者，或可能对在公众地方的人或车辆造成阻碍、不便或危害者，**可处第 4 级罚款(现时为\$25,000)或监禁 3 个月。**

**当局可检控违例停放单车以致造成阻碍的人士。**

In accordance with section 4A of the Summary Offences Ordinance, Cap. 228, any person who without lawful authority or excuse sets out or leaves, or causes to be set out or left, any matter or thing which obstructs, inconveniences or endangers, or may obstruct, inconvenience or endanger, any person or vehicle in a public place **shall be liable to a fine at level 4 (\$25,000 at present) or to imprisonment for 3 months.**

**The Authority may prosecute the person who illegally parked the bicycle causing obstruction.**

3. 本申请表必须于 **2026 年 5 月 4 日或之前** 送达运输署下列地址。**逾期递交的申请将不予受理。**

This application form must be delivered to the below address of the Transport Department **on or before 4 May 2026.** **Late submission will NOT be handled.**

4. 申请人必须为有关单车的车主。在当局/法院决定是否发还有关单车前，申请人须在运输署通知的日期，**亲身**前往指定地点，一般**至少三次**，以：

- 1) 办理辨认单车手续；
- 2) 作索还单车车主口供；及
- 3) 前往法院出庭应讯（如当局决定对申请人进行检控）。

The applicant must be the owner of the concerned bicycle. Before the Authority/Court decides whether the concerned bicycle could be returned, the applicant must visit the designated spots **in person** on the dates notified by the Transport Department, usually **at least three times**, to :

- 1) complete the procedure for identifying the bicycle;
- 2) provide a cautioned statement as the owner reclaiming the bicycle; and
- 3) appear in court for hearing (if the Authority decides to prosecute the applicant).
