**(A) 經營公共巴士合約式出租服務須獲的批准**

- (一) 根據香港法例第374章《道路交通條例》的規定，所有經營非專營巴士服務的營辦商，必須領有有效的客運營業證，而提供服務的非專營巴士須領有有效的客運營業證證明書，並獲運輸署簽發合約式出租服務 (A08)的批註。
- (二) 合約式出租服務為不收取個別收費的運載乘客服務，即用合約方式提供並非香港法例第230章《公共巴士服務條例》第4條(3)所指明的任何服務。

- (三) 由相同起點地區往相同目的地地區，而在30天內不論是接續或間歇營運的日數超過兩天的合約式出租服務，除提供服務的巴士須取得合約式出租服務的批註(A08)外，營辦商須就個別路線取得運輸署的批准，包括以下批准類別：

申請人須將已填妥的申請表格，及以上有關申請證明文件，親自遞交或由代理人交回香港金鐘道 95 號統一中心三樓運輸署公共車輛分組，或以掛號郵遞交回。如申請營辦由相同起點地區往相同目的地地區，而在 30 天內不論是接續或間歇營運的日數超過兩天的合約式出租服務，申請人需於擬營辦日期前最少 14 個工作天前遞交申請。申請人如須更改填報的資料，必須立即通知運輸署署長。

## **(E) 申請注意事項**

- (一) 根據香港法例第 374 章《道路交通條例》第 28 條的規定，運輸署就客運營業證的申請作出決定時，除須顧及與該申請有關的事宜外，亦須顧及以下事宜：
- (i) 行政長官在有關提供公共運輸服務任何政策方面的指示；
  - (ii) 對於可予登記的車輛數目的任何有效限定；
  - (iii) 對申請人擬提供的服務需求；
  - (iv) 其他公共運輸經營者已有提供或已作計劃的服務的水平；
  - (v) 擬提供的服務的地區及道路的交通情況；及
  - (vi) 申請人擬提供的服務的標準。
- (二) 根據「非專營巴士營運的規管架構和發牌制度」的立法會交通事務委員會文件，政府會繼續實行自二零零三年十二月起停止自動簽發合約式出租服務 (A08) 批註予沒有該類批註的巴士的措施。唯新加入的營辦商或現有營辦商之間互相轉讓現有已登記車隊內的巴士時，如能符合下列條件，其合約式出租服務 (A08) 批註可予保留：
- (i) 該巴士在轉讓前已取得 A08 批註，因此不會令 A08 批註總數出現淨增長；
  - (ii) 巴士轉讓不會令非專營巴士車隊中的巴士總數出現淨增長；以及
  - (iii) 申請 A08 批註的新車車主能出示證明文件支持申請。
- (三) 如(i) 新的客運營業證申請及(ii) 現有營辦商申請增添巴士的申請，只通過合約式出租服務批註(A08)作為支持文件，則只有在非常特殊而申請人又能提供充分理據和證明文件的情況下，其申請才會獲得批准。
- (四) 如申請合約式出租服務的批註(即本申請表甲欄所指事項)，運輸署在收齊申請人需要提交的文件後，一般需時六至八個星期處理申請，實際處理時間視乎申請的複雜程度而定。
- (五) 如申請批註的巴士源自現有已登記的車隊，而有關申請不會令非專營巴士總數出現淨增長，則運輸署在批出和更改有關批註時，會採用較靈活的做法。在這方面，非專營巴士營辦商 (不論是現有營辦商還是新加入的營辦商) 之間轉讓的巴士，將通常不會獲發多於三項批註。如轉讓巴士是因營業證持有人公司化而起，而營辦商又能提出理據證明有需要營辦該項服務，則可豁免遵守這項規定。
- (六) 如合約式出租服務個別路線申請獲得批准，運輸署會制訂服務詳情表或在批准信內，規定所有關乎服務營運的細節，包括路線、服務時段、班次、巴士數目及載客量、獲准接載的乘客類別、或／及上落乘客站等等。營辦商須遵守服務詳情表或批准信內訂定的細則，以營辦該合約式出租服務個別路線。如不依照服務詳情表或批准信內訂定的細則提供服務，即構成違反發牌條件。

## NOTES FOR ATTENTION

---

### (A) Approval to be Obtained for the Operation of Public Bus Contract Hire Service

- (1) According to the Road Traffic Ordinance (Chapter 374), all non-franchised bus operators must be holders of valid Passenger Service Licences (PSL) whereas the bus(es) to be used for the provision of service should be issued with valid passenger service licence certificate(s) with contract hire service (A08) endorsement(s) by the Transport Department.
- (2) Contract hire service is for the carriage of passengers other than at separate fares. It provides under contract any type of service other than those specified in section 4(3) of the Public Bus Services Ordinance (Chapter 230).

**(3) For the operation of any contract hire service with the same origin and destination areas for more than 2 days either intermittently or consecutively in a period of 30 days, prior approval for respective route(s) should be obtained from the Transport Department in addition to the contract hire service (A08) endorsement in respect of the bus(es) to be used for the provision of service, including the following approved types:**

◆ Obtaining “one-off approval” in respect of specified types of contract hire service

The applicant may consider applying for “one-off approval” from the Transport Department for the provision of the following types of service during the validity period of the contract hire service endorsement and has no need to submit individual applications:

- service for weddings;
- service for funerals;
- service for extra-curricular activities of schools at secondary level or below; or
- pickup service to cope with urgent transport needs (e.g. suspension of railway services).

◆ Obtaining “one-off approval in respect of individual groups or homes” for the provision of contract hire service to specified groups or homes

The applicant may consider applying for “one-off approval in respect of individual groups or homes” for the provision of contract hire service to the following specified types of groups or homes during the contract period and has no need to submit individual applications.

- non-governmental organisation;
- church;
- community centre; or
- home/day care centre for the elderly.

◆ Others — “individual applications”

For the operation of other types of contract hire service with the same origin and destination areas for more than 2 days either intermittently or consecutively in a period of 30 days, individual applications should be made.

### (B) Application Forms

For the operation of contract hire service, the application forms stated in (1) and (2) below should be completed and submitted:

- (1) Application for Passenger Service Licence — Public Bus Service (T.D. 246A) and/or Application for Passenger Service Licence Certificate(s) — Public Bus Service (T.D. 247A); and
- (2) Application for Passenger Service Licence — Public Bus Service (Contract Hire Service) (T.D. 246A) (A08).

### (C) Supporting Documents

(1) Identification Documents of the Applicant

- (i) Hong Kong Identity Card of the applicant (only for new operators and those who are applying as individuals)  
(the copy (copies) of identity card attached to the application will be destroyed by the Transport Department after the processing of application);
- (ii) Certificate of Incorporation (only for applicants who are applying as limited companies);
- (iii) valid Business Registration Certificate;
- (iv) Company search document [Form I(a)/I(c) of the Inland Revenue Department] (only for new operators and those who are applying as individuals); and
- (v) Memorandum and Articles of Association (only for new operators and those who are applying as limited companies).

(2) Identification Document of the Hirer

- (i) valid Business Registration Certificate (to be submitted only when deemed necessary by the Transport Department).

(3) Documents in Support of the Need for the Contract Hire Service Proposed by the Applicant

(i) Application for contract hire service endorsement

- The bus hire service contract signed with the hirer with a validity period of at least 6 months, specifying the commencement date of hire, the number of bus(es) hired and the nature of service to be provided;
- If the proposed contract hire service is operated under a sub-contracting arrangement, the service contract signed between the hirer and the main contractor as well as the service contract signed between the main contractor and the applicant (with a validity period of at least 6 months), and a support letter from the hirer endorsing the sub-contracting arrangement; and
- If the proposed contract hire service has already been in operation at the time of application, written explanation with supporting documents on the arrangements for the provision of service and the reasons for not continuing the provision of contract hire service under such arrangements.

(ii) Application for the operation of contract hire service with the same origin and destination areas for more than 2 days either intermittently or consecutively in a period of 30 days

In the event of proposed operation of contract hire service with the same origin and destination areas for more than 2 days either intermittently or consecutively in a period of 30 days, the applicant should submit the following supporting documents in addition to obtaining the contract hire service (A08) endorsement in respect of the bus(es) to be used for the provision of service:

- Obtaining “one-off approval” in respect of specified types of contract hire service  
The bus hire service contract signed with the hirer or past business records (e.g. service receipts, bank pay-in slips or hire receipts). The contract should specify the validity period of the bus hire, the number of bus(es) hired and the nature of service to be provided;
- Obtaining “one-off approval in respect of individual groups or homes” for the provision of contract hire service to specified groups or homes  
The bus hire service contract signed with the hirer or booking receipts, etc. The contract should specify the validity period of the bus hire, the number of bus(es) hired and the nature of service to be provided;
- Others — “individual applications”  
The bus hire service contract signed with the hirer or booking receipts, etc. The contract should specify the validity period of the bus hire, the number of bus(es) hired and the nature of service to be provided.

(4) Supporting Documents in respect of the Bus(es) to be used for the provision of the proposed service(s) (only for applications for new PSL and additional bus(es))

◆ If second-hand bus(es), for which replacement bus(es) will be acquired by the existing owner(s), are to be deployed for the provision of contract hire service, the following documents are required:

- written explanation from the applicant with supporting documents on the reasons for purchasing the public bus(es);
- sale and purchase agreement signed between the applicant and the existing owner(s) in respect of the proposed bus(es); and
- application together with supporting documents from the existing owner(s) of the second-hand bus(es) for the purchase of replacement bus(es).

◆ If second-hand bus(es), for which no replacement bus will be acquired by the existing owner(s), are to be deployed for the provision of contract hire service, the following documents are required:

- sale and purchase agreement signed between the applicant and the existing owner(s) in respect of the proposed bus(es); and
- letter from the existing owner(s) of the proposed bus(es), agreeing not to purchase replacement bus(es).

(5) Documents in Support of the Need for Additional Bus(es) and/or Additional Service Endorsement(s) for Existing Public Bus(es) (only for applicants who are existing operators)

◆ Operation details of the services provided (except the proposed contract hire service) in the past 3 months in respect of all bus(es) registered under his/her PSL, including:

- valid service contracts signed with all hirers;
- hiring receipts endorsed by the hirers, or if such is not available, deployment records of the vehicle(s) with supporting documents; and
- public bus daily operation chart that clearly sets out the routes, timetable and name lists of students in the case that the applicant currently provides student service (sample forms are obtainable from the Public Vehicles Unit). The operation chart should be endorsed by the school principal concerned and affixed with the school chop. The deployment records in respect of the existing bus(es) is also required.

◆ If the applicant has been hiring bus(es) from other public bus operators for the provision of services in the past 3 months, the relevant bus hiring records and written explanation of reasons for not continue hiring bus(es) from other public bus operators.

**(D) Submission of Application Forms and Documents**

The completed application forms together with the relevant supporting documents should be submitted either in person, by agent or by registered post to the Public Vehicles Unit of the Transport Department at 3/F, United Centre, 95 Queensway, Hong Kong. For application for the operation of contract hire service with the same origin and destination areas for more than 2 days either intermittently or consecutively in a period of 30 days, the application should be submitted at least 14 working days prior to the service commencement. For any amendment to the information provided, the applicant(s) should notify the Commissioner for Transport immediately.

**(E) Points to Note in Submitting an Application**

- (1) According to section 28 of the Road Traffic Ordinance (Chapter 374), in determining an application for a PSL, the Transport Department shall take into account the following in addition to any other matter relevant to the application:
  - (i) any policy direction from the Chief Executive with respect to the provision of public transport services;
  - (ii) any limit in force on the number of vehicles that may be registered;
  - (iii) the need for the services to be provided by the applicant;
  - (iv) the level of service already provided or planned by other public transport operators;
  - (v) traffic conditions in the areas and on the roads where the services are to be provided; and
  - (vi) the standard of service to be provided by the applicant.
- (2) According to the paper entitled “Regulatory Framework And Licensing System For Non-Franchised Bus Operation” of the Legislative Council Panel on Transport, the measure implemented since December 2003 to cease automatic granting of contract hire service (A08) endorsement to vehicles currently without such endorsement will be continued, except that non-franchised vehicles within the existing registered fleet transferred among new or existing operators would be allowed to retain the contract hire service (A08) endorsement if:
  - (i) such vehicle has A08 endorsement before the transfer and thus will not result in a net increase in the total number of A08 endorsements;
  - (ii) the transfer will not result in a net increase in the non-franchised bus fleet; and
  - (iii) the new owner of the vehicles applies for the A08 endorsement with supporting documents to justify the application.
- (3) For (i) application for new PSL or (ii) application for additional bus(es) from existing operators, if the vehicle(s) concerned is solely supported by Contract Hire Service (A08), approval would only be given under exceptional circumstances and after stringent vetting. Applicant should also provide sufficient justifications and supporting documents to support the application.
- (4) For applications for contract hire service endorsement (i.e. the matter as indicated under Part A of this application form), it normally takes 6 to 8 weeks for the Transport Department to process the application upon receipt of all the requisite documents submitted by the applicant. Actual processing time will depend on the complexity of individual application.
- (5) If the vehicle for which an application for service endorsement is made is sourced from the existing registered non-franchised bus fleet and the application will not entail a net increase in the non-franchised bus fleet size, a more flexible approach will be adopted by the Transport Department in the granting and/or amendment of endorsements. In this respect, vehicle(s) transferred among non-franchised bus operators (regardless of whether they are existing or new operators) would normally not be granted with more than 3 endorsements. Transfer of vehicles arising from the corporatisation of PSL holder, however, will be exempted from this requirement if justifications can be provided by the operator to prove the need of service.
- (6) If the application for contract hire service in respect of specified route(s) is approved, a schedule of service would be set by the Transport Department or set out in the offer letter specifying the relevant operation details, including routing, operation hours, number of trips, number of bus(es) and seating capacity of bus(es), types of passengers permitted to carry, and/or boarding and alighting locations, etc. The bus operator should adhere to the details specified in the schedule of service or set out in the offer letter in providing contract hire service of the specified route(s). Non-adherence to the schedule of service or details set out in the offer letter will constitute a violation of the licensing conditions.
