為確定接受首次登記前檢驗的平行/個別進口電單車及私家車符合香港法例第 374 章《道路交通條例》及其附屬法例的規定，車主或其代理人在安排車輛進行首次登記前檢驗時，須提交下列其中一項文件包括認可英文譯本以作查核(如適用)。如車主或其代理人在車輛檢驗時未能提交有關文件，車輛檢驗將作不合格論。

- A: 符合證明書 (COC);
- B: 完成檢查終了証 (CIC);
- C: 讓渡證明書;
- D: 輸出抹消假登錄證明書 / 輸出予定届出證明書;
- E: 抹消登錄證明書 / 一時抹消登錄證明書;
- F: 登錄事項等證明書 – 現在記錄;
- G: 登錄事項等證明書 – 保存記錄; 或
- H: 車輛登記文件

以上文件的樣本已夾附在上載於本署網頁的通告以供參考。

由 2018 年 10 月 23 日起，本署驗車中心人員在查核有關文件後會在文件上蓋印以茲識別。車主或其代理人在向香港牌照事務處提交車輛首次登記申請時，除其他適用的所需文件外，亦須連同申請表提交**所有**由驗車中心人員查核及蓋印的文件。

在 2019 年 1 月 2 日或之後，曾接受首次登記前檢驗車輛的首次登記申請如沒有夾附由驗車中心人員查核及蓋印的文件，香港牌照事務處將不會處理有關申請。

Notice

Documents required for pre-registration inspection and vehicle first registration for parallel / individual imported motorcycles and private cars

To ascertain the parallel / individual imported motorcycles and private cars being examined are in compliance with the requirements under the Road Traffic Ordinance (Cap. 374) and its subsidiary legislations, one of the following documents with endorsed English translation (if applicable) should be submitted by the vehicle owner or his agent for vetting during the pre-registration inspection. If such document could not be submitted at the time of vehicle inspection, the vehicle concerned will not be able to pass the pre-registration inspection.

- A: Certificate of Conformity (CoC);
- B: Completion Inspection Certificate (CIC);
- C: Certificate of Transfer;
- D: Export Certificate;
- E: Certificate of De-registration / Certificate of Temporary De-registration;
- F: Certificate of Registration Matters – Present Record;
- G: Certificate of Registration Matters – Preserved Record; or
- H: Vehicle Registration Document

Samples of the above-mentioned documents are attached to the Notice uploaded to the website of this Department for easy reference.

From 23 October 2018 onwards, vehicle examiners will stamp on the vetted documents for identification. The vehicle owner or his agent shall submit to the Hong Kong Licensing Office the application form together with the stamped documents and other applicable supporting documents for vehicle first registration application.

From 2 January 2019, Hong Kong Licensing Office will not process first registration applications related to vehicles which have undergone pre-registration inspection if such applications are not accompanied with documents vetted and stamped by vehicle examiners.
