申請泊車服務說明書 (2026 年 6 月至 2026 年 9 月)

★★★★★★★★重要事項★★★★★★★★

- ✧ 請注意，本次雙鳳街停車場的泊車服務會作出一次性延長一個月，銷售月份會包括6月至9月，共4個月。隨後10月開始的泊車服務會恢復以3個月一季的模式銷售。措施旨在整合現時的銷售週期，以便於9月可與其他停車場一併進行電子抽籤。
- ✧ 上述4個月的泊車服務費會按比例收取多一個月的泊車費用，即私家車 / 客貨車之泊車費用為港幣\$9,800元；的士之泊車費用為港幣\$3,480元，以及電單車之泊車費用為港幣\$1,840元。

申請須知

1. 提交申請

泊車服務的申請表格於2026年4月、8月及11月中起開始於雙鳳街停車場繳費處派發，並接受申請。申請人亦可經指定網頁以電子方式提交泊車服務申請，詳情請瀏覽停車場營辦商（即「敏記停車場管理有限公司」）的網頁(<https://www.mackcarpark.com.hk>)及香港特別行政區運輸署（即「運輸署」）的網頁(<https://www.tdcarpark.com.hk>)。

2. 申請購買泊車服務的條件

申請人於提交泊車服務的申請時，須同時提交或上載由運輸署發出的有效私家車、客貨車、電單車或的士車輛牌照（即「行車證」）影印本及提供行車證屆滿日期。若申請人的行車證未載有屆滿日期，車主可掃描證上的二維碼至運輸署車輛牌照網上查詢平台，以查閱及提供有關屆滿日期資料。若申請人以電子方式提交申請，請確保輸入正確的「牌照屆滿日期」。

任何資料不全或資料錯誤的申請將不獲受理。提早提交或逾期提交申請的要求亦將不獲受理。申請人如未能於2026年4月20日至5月2日期間經指定網頁成功提交電子申請，可於2026年4月20日至5月4日期間，親身前往雙鳳街停車場繳費處提交申請。

不論親身於雙鳳街停車場繳費處還是透過電子形式提交申請，申請人只可以為每部車輛提交一份申請，重複提交的申請將不獲受理並予以取消。

申請人於雙鳳街停車場繳費處提交申請時，將會獲發一張申請確認回條。申請人透過電子形式提交申請，將會收到由系統發出的確認電郵。截止申請後，泊車服務申請名單將於抽籤日期之前展示於雙鳳街停車場繳費處供所有申請人參考。申請人須妥為保存該回條 / 電郵，以作核實及中籤後辦理購買泊車服務手續之用。

如車輛登記車主或申請人為肢體殘疾人士，他 / 她可以購買泊車服務而無須進行抽籤。在提交申請時，申請人須提交或上載由運輸署發出的「傷殘人士泊車許可證」或「批准信」的影印本，以作核實之用。

申請人提供的所有資料必須正確無誤。如申請人於提交申請時提供任何虛假文件及資料，有關申請將被作廢，個案將轉交執法部門跟進。

3. 泊車服務的分配

如申請購買泊車服務的數目比車輛類別的泊車服務配額為少，將無須抽籤，申請人將會自動獲得購買該車輛類別泊車服務的權利，申請人須於2026年5月14至18日期間，前往雙鳳街停車場繳費處以現金、支票或使用電子繳費或透過指定的網頁和使用指定的電子繳付方式購買泊車服務。如申請人沒有在指定期間購買泊車服務，將被視作自動放棄購買泊車服務。

如申請購買泊車服務的數目比車輛類別的泊車服務配額為多，該車輛類別的泊車服務將會以抽籤方式分配予申請人，並會以抽籤方式抽出候補申請人和決定其獲補購泊車服務的先後次序。

4. 抽籤安排及發售泊車服務

抽籤會於本說明書「**重要事項**」所列的日期進行，列有抽籤時間和地點的通告會預先張貼在雙鳳街停車場繳費處。如抽籤日期有所改動，有關的通告亦會預先張貼在雙鳳街停車場繳費處。抽籤結束後，成功申請人須於本說明書「**重要事項**」所列的日期內，前往雙鳳街停車場繳費處以現金、支票或使用電子繳費或透過指定的網頁和使用指定的電子繳付方式購買泊車服務。如申請時所遞交之行車證會於泊車服務生效期前失效，該成功申請人必須到雙鳳街停車場繳費處補交有效之行車證及購買泊車服務（不設網上繳付方式購買泊車服務）。

如成功申請人沒有在指定期間購買泊車服務，將被視作自動放棄購買泊車服務，剩餘的泊車服務配額將按抽籤次序分配予第一輪候補申請人。剩餘泊車服務的配額數量以及第一輪候補申請人的名單會於雙鳳街停車場繳費處、停車場營辦商的網頁及運輸署的網頁公布。成功的第一輪候補申請人須於本說明書「**重要事項**」所列的日期內，前往雙鳳街停車場繳費處以現金、支票或使用電子繳費或透過指定的網頁和使用指定的電子繳付方式購買泊車服務。如第一輪候補申請人沒有在指定期間購買泊車服務，將被視作自動放棄購買泊車服務。

經過分配剩餘的泊車服務配額予第一輪候補申請人後，如仍有剩餘泊車服務配額，將按抽籤次序分配予第二輪候補申請人。剩餘泊車服務的配額數量以及第二輪候補申請人的名單會於雙鳳街停車場繳費處、停車場營辦商的網頁及運輸署的網頁公布。成功的第二輪候補申請人須於本說明書「**重要事項**」所列的日期內，前往雙鳳街停車場繳費處以現金、支票或使用電子繳費或透過指定的網頁和使用指定的電子繳付方式購買泊車服務。如第二輪候補申請人沒有在指定期間購買泊車服務，將被視作自動放棄購買泊車服務。

如泊車服務的剩餘配額於分配予第二輪候補申請人後，如仍有剩餘配額，而候補名單上仍有申請人，雙鳳街停車場職員將按抽籤次序通知候補名單上的申請人購買剩餘的泊車服務配額。該合資格的申請人須前往雙鳳街停車場繳費處以現金、支票或使用電子繳費購買泊車服務（此輪不設網上繳付方式購買泊車服務）。如候補名單內已沒有其他候補申請人，剩餘配額會在雙鳳街停車場繳費處以先到先得形式公開發售。

所有成功申請人 / 候補申請人，如經停車場繳費處提交申請，須在購買泊車服務時出示申請確認回條。如經指定網頁提交申請，則須出示由系統發出的確認電郵。如申請人未能親身購買泊車服務，可授權他人代為購買，該被授權人士在購泊車服務時，須出示發給申請人的申請確認回條正本或確認電郵列印本，以便核對其可購買泊車服務時的身份。

停車場營辦商不會承擔因下述情況而導致延遲或未能確認、批核或授權網上或電子付款所引起的任何法律責任或責任。該等情況是指涉及處理或完成網上或電子付款交易的有關係統、網絡、設備或裝置的硬件或軟件出現任何故障、失靈、機能失常或任何其他失誤的各種情況。

5. 泊車服務的使用

使用泊車服務的私家車 / 客貨車或的士客戶，其車輛的車頭須展示已在雙鳳街停車場登記的車牌號碼的字牌作為有效之憑證，以用於啟動免觸式泊車系統進出雙鳳街停車場。至於使用泊車服務的電單車客戶，將會獲發一張智能咭作為有效之憑證，客戶須使用該智能咭進/出雙鳳街停車場。而使用指定的網頁和使用指定的電子繳付方式購買泊車服務的電單車客戶可在進/出雙鳳街停車場之前到雙鳳街停車場繳費處，出示由系統自動發送到由申請人提供的電郵地址的付款收據領取一張智能咭作為有效之憑證和使用該智能咭進/出雙鳳街停車場。

泊車服務只供在申請表上填報的車輛使用，不得私下轉讓。客戶如需要永久轉換登記使用泊車服務之車輛，或因維修車輛而需要使用暫替車輛，需向雙鳳街停車場提出申請，詳情請參閱本說明書「**重要事項**」有關永久轉換車牌號碼及使用暫替車輛之安排。

如客戶以其他未有登記之車輛使用雙鳳街停車場的泊車服務，或客戶以不誠實的方法令多於一架車輛使用雙鳳街停車場的泊車服務，該泊車服務會被註銷，而客戶不會獲退款或補償。雙鳳街停車場並會保留權利向相關客戶及/或涉事者採取進一步行動，包括但不限於向執法機關舉報。

客戶使用泊車服務時，必須同時遵守張貼於雙鳳街停車場內的《季租客戶須知》與《停車場泊車及使用條款》，以及其他由運輸署不時公布的通告和條款。

6. 防止賄賂

任何人士向任何政府人員或停車場營辦商職員提供利益（按照香港法例第201章《防止賄賂條例》中對利益的定義），以試圖影響本申請的結果，即屬觸犯《防止賄賂條例》，會導致申請無效。案件會轉介廉政公署跟進，已售出的泊車服務會被註銷，該人士亦需承擔因有關違法行為而致令政府蒙受的所有損失及費用。如遇任何人因本申請向你索取利益，應向廉政公署舉報（電話：2526-6366）。

★★★★★★★★★ **Important Notes** ★★★★★★★★★★

- ✧ Please note that **the** parking service of Sheung Fung Street Car Park will be **extended for one month on a one-off basis, covering June to September 2026** for 4 months in total. Starting from October 2026, the subscription for parking service will then revert to the **three-month sales cycle**. This arrangement aims to align the sales cycle of parking services, enabling the electronic balloting to be conducted in September 2026 together with other car parks.
- ✧ The parking service fees of the abovementioned **four-month period** will be charged proportionally for one additional monthly fee, i.e. **parking fee for private car/van would be HK\$9,800, parking fee for taxi would be HK\$3,480 and parking fee for motorcycle would be HK\$1,840.**

If the original purchaser of the parking service only requests for refund of monthly fee from 1 to 30 September 2026, the administrative fee of HK\$100 would be waived. The refund will be deposited to the bank account designated by the patron within sixty (60) days upon receipt of the completed refund application form from the patron.

Application Guidelines

1. Submission of Application

Application forms are available at the shroff of SFSCP starting from mid-April, mid-August and mid-November 2026 for inviting application. Applicants may also submit online application via designated website. For details, please visit the website of the car park contractor ("Mack & Company Carpark Management Limited") (<https://www.mackcarpark.com.hk>) and the website of the Transport Department of Hong Kong SAR Government ("TD") (<https://www.tdcarpark.com.hk>).

2. Requirements for Parking Service Application

Applicants must attach or upload a copy of valid vehicle licence for Private Car, Light Goods Vehicle, Motor Cycle or Taxi issued by the TD and provide the expiry date of vehicle licence for submission of parking service application. If the vehicle licence of applicants does not have the expiry date printed on it, vehicle owners could scan the QR code printed on the vehicle licence to access the Vehicle Licence Online Enquiry Platform to enquire and provide the concerned expiry date information. If applicants apply via designated website, applicants must ensure to enter the correct expiry date of vehicle licence.

Any application which contains incomplete data or wrong data will not be processed. Any request for advance submission or late submission will not be entertained. If an applicant cannot submit online application successfully via designated website between 20 April 2026 and 2 May 2026, he / she may submit application in person at the shroff of SFSCP between 20 April 2026 and 4 May 2026.

An applicant is allowed to submit one application for each vehicle only, be it made in person at the shroff of SFSCP or through online. Repeated applications for the same vehicle will not be accepted and will be disqualified.

At the time of submitting application to the shroff of SFSCP, an acknowledgement slip in respect of the application will be issued to the applicant. For online application, a system-generated acknowledgement email will be sent to the applicant. After closure of submission, a parking service application list will be posted outside the shroff of SFSCP before the date of ballot for reference of all applicants. Applicants shall properly keep the slip / email properly for verification and purchase of the parking service in accordance with the ballot result.

If the registered owner of the vehicle or the applicant is a person with physical disability, he / she may purchase the parking service without going through the ballot. Upon submission of application, the applicant has to attach or upload a copy of the Disabled Person's Parking Permit or the letter of approval issued by the TD for verification.

All information provided by the applicant must be correct. If the applicant submits any false document or information, his / her application will be disqualified and the case will be referred to Law enforcement authorities.

3. Allocation of Parking Service

In case the number of applications is less than the quotas set for the parking service of a particular vehicle type, ballot will not be required. The respective applicants will be entitled to purchase the parking service automatically. These applicants shall purchase the parking service in cash, by cheque or by electronic payment means in person at the shroff of SFSCP or through designated website and designated electronic payment methods between 14 May 2026 and 18 May 2026. Any applicant who fails to purchase the parking service during the specified period will be regarded as giving up his / her right.

In case the number of applications is more than the quotas set for the parking service of a particular vehicle type, allocation of the parking service to the applicants will be determined by ballot. The waiting list applicants and their priority of parking service purchase will also be determined by ballot.

4. Ballot and Sale of Parking Service

The ballot will be held on the date specified in the “**Important Notes**” of this Guidance Notes. A notice which shows the schedule and venue of the ballot will be posted at the shroff of SFSCP in advance. In case there is a change in the date of ballot, a notice will also be posted at the shroff of SFSCP in advance. After the ballot, all successful applicants shall purchase the parking service in cash, by cheque or by electronic payment means in person at the shroff of SFSCP or through designated website and designated electronic payment methods within the period specified in the “**Important Notes**” of this Guidance Notes. If the valid vehicle licence submitted during the application will expire before the effective date of the parking service, successful applicants must go to the shroff of SFSCP to resubmit a valid vehicle licence and purchase parking service (online payment method for purchasing parking service is not applicable).

Any successful applicant who fails to purchase the parking service during the specified period will be regarded as giving up his / her right. The remaining quotas of parking service will be allocated to other applicants on the first-round waiting list according to the priority determined by the ballot. The number of remaining quotas of parking service and the applicants on the first-round waiting list will be displayed at the shroff of SFSCP. Such information will also be uploaded to the website of the car park contractor and the website of TD. The successful applicants on the first-round waiting list shall purchase the parking service in cash, by cheque or by electronic payment means in person at the shroff of SFSCP or through designated website and designated electronic payment methods within the period specified in the “**Important Notes**” of this Guidance Notes. Any successful applicant on the first-round waiting list who fails to purchase the parking service during the specified period will be regarded as giving up his / her right.

After allocation of the remaining quotas of parking service to eligible applicants on the first-round waiting list, the remaining quotas, if any, will be allocated to other applicants on the second-round waiting list according to the priority determined by the ballot. The number of remaining quotas of parking service and the applicants on the second-round waiting list will be displayed at the shroff of SFSCP. Such information will also be uploaded to the website of the car park contractor and the website of TD. The successful applicants on the second-round waiting list shall purchase the parking service in cash, by cheque or by electronic payment means in person at the shroff of SFSCP or through designated website and designated electronic payment methods within the period specified in the “**Important Notes**” of this Guidance Notes. Any successful applicant on the second-round waiting list who fails to purchase the parking service during the specified period will be regarded as giving up his / her right.

After allocation of the remaining quotas of parking service to eligible applicants on the second-round waiting list, if there are still remaining quotas and eligible applicants on the waiting list, the staff of SFSCP will notify the applicants according to the priority determined by the ballot for them to purchase the remaining quotas of parking service. The eligible applicant must purchase the parking service in cash, by cheque or by electronic payment means at the shroff of SFSCP (online payment method for purchasing parking service is not applicable for this round). If the waiting list is fully consumed, the remaining quotas will be open for sale at the shroff of SFSCP on a first-come-first-served basis.

At the time of parking service purchase, all successful applicants / waiting list applicants are required to present the acknowledgement slip (for those who submit the application in person at the shroff) or the system-generated acknowledgement email (for those who submit the application via designated website). Any applicant who is not able to purchase the parking service in person may authorise a representative to purchase the service for him / her. The authorised person must present the original of the acknowledgement slip or the printout of the acknowledgement email upon purchase of the parking service for identification purpose.

The car park operator shall not accept any liability or responsibility for any delay or failure in confirmation, approval or authorisation of online or electronic payment due to any break down, non-function, mal-function or any other fault of the hardware or software of the system, network, equipment or device involved in connection with the processing or effecting of the online or electronic payment.

5. Use of Parking Service

For the patron who uses the parking service for private car / van or taxi, the front of his / her vehicle is required to display the number plate, which the vehicle registration mark has been registered at SFSCP, as a valid identity of activating the contactless parking system to enter / exit SFSCP. As for the patron who uses the parking service for motorcycle, a smart card will be issued to him / her as a valid identity to enter / exit SFSCP. If motorcycle patrons who use the designated website and use the designated electronic payment method to purchase parking service, they can go to the shroff of SFSCP before entering/exiting the SFSCP to collect a smart card by presenting a system generated receipt being sent to the email address provided by the applicant and use the smart card as valid identity for permission to use the parking service of this car park and enter/exit this car park.

The parking service is non-transferable and solely for use by the vehicle specified in the application form. In case the patron requests for permanent change to the vehicle registration mark of the vehicle using the parking service, or requests for temporary deployment of an alternative vehicle when the registered vehicle is under repair, patron has to make an application at SFSCP. For details, please refer to the **"Important Notes"** of this Guidance Notes regarding the permanent change of vehicle registration mark and temporary deployment of alternative vehicle.

The parking service will be suspended without any refund or compensation if such patron is found using the parking service of SFSCP by other unregistered vehicle; or such patron is found using the parking service of SFSCP by more than one vehicle in a dishonest way. SFSCP also reserves the right to take further action against the patron and / or the persons involved, including but not limited to reporting the case to the law-enforcement agencies.

Patron of the parking service is subject to the terms and conditions listed out in "Notice to Patrons of Quarterly Parking" and the "Conditions of Parking and Use" displayed in SFSCP, as well as other notices and conditions announced by the TD from time to time.

6. Prevention of Bribery

Any attempt to offer advantage (as defined in the Prevention of Bribery Ordinance ("POBO") (Chapter 201 of the Laws of Hong Kong)) to any Government officer or staff of the car park contractor with a view to influencing the outcome of this application constitutes an offence under the POBO and renders the application invalid. The case will be reported to the Independent Commission Against Corruption ("ICAC"). The parking service being sold will be suspended and the person will be liable for all losses and expenses incurred by the Government as a result of the offence.
