收集目的

Purposes of Collection

- (1) The personal data you provided by means of this form will be used by the Transport Department for the following purposes:

- (2) It is obligatory for you to supply the personal data as required by this form. If you fail to supply the required data, your report may be refused.

Classes of Transferees

(3) The personal data you provided by means of this form may be disclosed to other Government departments, bureaux and relevant organizations for the purposes mentioned in paragraph (1) above.

Access to Personal Data

(4) You have a right of access and correction with respect to personal data as provided for in sections 18 and 22 and principle 6 of Schedule 1 of the Personal Data (Privacy) Ordinance. Your right of access includes the right to obtain a copy of your personal data provided by this form.
